ASSEMBLY CONCURRENT RESOLUTION—Designating
May 9, 2005, as “Vintage Car Day” at the Nevada
Legislature.

1 WHEREAS, Automobiles and the automobile industry have
2 played a vital role in the growth of the State of Nevada and this
3 great country; and

4 WHEREAS, Automobile sales in the United States have grown
5 over the years from \$4,100 in 1900 to \$3.7 million in 1925, \$6.7
6 million in 1950, \$9.3 million in 1965 to over \$140 billion worth of
7 motor vehicles and parts produced in the United States by
8 companies employing over 6.6 million workers nationwide; and

1 WHEREAS, The automobile industry has become one of the
2 largest purchasers of many key American industrial products, such
3 as steel; and

4 WHEREAS, Since 1987, the automobile industry has grown by
5 more than 47 percent, helping to drive the economy of the United
6 States to new heights; and

7 WHEREAS, Automobiles have shaped our everyday lives over
8 the past 100 years more than any other invention by allowing
9 consumers to commute long distances for family visits, tourism,
10 entertainment, shopping and work; and

11 WHEREAS, Automobiles have encouraged the development of a
12 far-reaching system of highways and roads which made possible the
13 growth of suburbs and shopping centers around major cities; and

14 WHEREAS, Many people all over the nation, including a large
15 number in Nevada, maintain their classic automobiles as a pastime
16 and do so with a great passion; and

17 WHEREAS, The members of the Nevada Legislature recognize
18 the effect the automobile has had on this State and our country, and
19 support wholeheartedly all activities involved in the restoration and
20 exhibition of these fine automobiles; and

21 WHEREAS, Thousands of local clubs have been instrumental in
22 preserving a historic part of this country's heritage by encouraging
23 the restoration and exhibition of these vintage works of art which
24 easily evoke smiles and fond memories; now, therefore, be it
