A.B. No. 111—Requires Department of Administration to conduct study concerning feasibility and desirability of relocating certain state agencies to rural communities under certain circumstances.



“feasibility and desirability of expanding or relocating certain state agencies to rural communities under certain circumstances; requiring the Department to recommend, if feasible, the expansion or relocation of at least one such agency;”.

Amend the summary of the bill to read as follows:

“SUMMARY—Requires Department of Administration to conduct study concerning feasibility and desirability of expanding or relocating certain state agencies to rural communities under certain circumstances. (BDR S-989)”.

**If this amendment is adopted, the Legislative
Counsel's Digest will be changed to read as follows:**

Legislative Counsel's Digest:

This bill requires the Department of Administration to conduct a study to determine the feasibility and desirability of expanding or relocating certain state agencies to rural areas. The study must include a survey of state employees regarding their willingness to relocate to a rural area. The study will be conducted only if money to pay the costs of the study is received from grants, gifts, donations, bequests or other sources.

This bill requires the Department of Administration to recommend the expansion or relocation, if feasible, of at least one state agency, or portion thereof, to a rural area as a result of the study. The Budget Division must consider the results of the study when preparing the proposed state budget for Fiscal Year 2008-2009, including any recommendation to expand or relocate a state agency as a result of the study.
