Legislative Counsel's Digest:

Existing law establishes the position of State Controller as an elected state officer and prescribes the duties of the State Controller. (Nev. Const., Art. 5, § 19, Art. 9, § 3) Existing law establishes the position of State Treasurer as an elected state officer and prescribes the duties of the State Treasurer. (Nev. Const., Art. 5, § 19)

This resolution proposes to amend the Nevada Constitution to eliminate the positions of State Controller and State Treasurer and to transfer their respective duties to the Secretary of Finance. This resolution further proposes to amend the Nevada Constitution to require the Secretary of Finance to appoint as deputies a Controller and a Treasurer who are not constitutional officers but who assist the Secretary of Finance, and whose qualifications must be defined by the Legislature.
