***“Except as otherwise provided in this section, the”.***

S.B. No. 30—Authorizes certain cities to establish wireless enhanced 911 service and impose surcharge for certain telephone services to pay for such service.

Amend sec. 9, page 3, by deleting lines 1 through 9 and inserting:

***“☞for the enhancement of the telephone system for reporting an emergency in the city.***

***2. A city council may not impose a surcharge pursuant to this section unless the city council first adopts a 5-year master plan for the enhancement of the telephone system for reporting emergencies in the city. The master plan must include an estimate of the cost of the enhancement of the telephone system and all proposed sources of money for funding the enhancement.”.***

Amend sec. 9, page 3, line 13, by deleting “75” and inserting “25”.

Amend sec. 9, page 3, line 28, by deleting “13” and inserting “11”.

Amend sec. 10, page 3, line 44, by deleting “9” and inserting “7”.

Amend sec. 10, page 4, by deleting lines 3 and 4 and inserting:

***“pursuant to section 7 of this act, to enhance the telephone system for reporting an emergency in the city and to”.***

Amend sec. 10, page 4, line 20, by deleting “9” and inserting “7”.

Amend sec. 10, page 4, by deleting lines 21 through 23 and inserting:

***“the fund must be used only to enhance the telephone system for reporting an emergency so that the number and address from which a call received by the system is made may be determined, including only:”.***

Amend sec. 10, page 4, lines 26, 29 and 31, by deleting “service;” and inserting:

***“enhanced telephone system;”.***

Amend sec. 10, page 4, line 34, by deleting “service.” and inserting:

***“enhanced telephone system.”.***

Amend the title of the bill by deleting the third through sixth lines and inserting:

“services for the enhancement of the telephone system for reporting emergencies in certain incorporated cities; requiring a city council which imposes such a surcharge to create an advisory committee to develop a plan for the enhancement of the city’s telephone service for reporting emergencies; and”.

Amend the summary of the bill to read as follows:

“SUMMARY—Authorizes certain cities to impose surcharge on telephone services for enhancement of telephone system for reporting emergencies. (BDR 21-740)”.

**If this amendment is adopted, the Legislative  
Counsel's Digest will be changed to read as follows:**

**Legislative Counsel's Digest:**

Existing law authorizes certain counties to collect a surcharge on local telephone service and mobile telephone service to enhance 911 service in the county. (NRS 244A.7641-244A.7647)

This bill authorizes the city council of certain cities incorporated by general law to impose and provide for the collection of such a surcharge in order to enhance 911 service in the city.

This bill requires that if a city council which imposes such a surcharge also imposes a business license fee on a provider of personal wireless service, the city treasurer must deposit the money generated from the fees into the special revenue fund created for the enhancement of the 911 service in the city. This bill also provides a mechanism for resolving disputes between a customer and telephone service provider over the amount collected for the surcharge.
