Amend section 1, page 2, line 41, after "2." by inserting:

"On or before January 15 of each odd-numbered year, the Committee shall submit to the Director of the Legislative Counsel Bureau for transmittal to the Legislature a report concerning any action that the Committee had taken pursuant to subsection 1 during that biennium.

*3.*".

Amend the bill as a whole by renumbering sec. 2 as sec. 3 and adding a new section designated sec. 2, following section 1, to read as follows:

"Sec. 2. NRS 218.536, 218.5361, 218.5363, 218.5365, 218.5367, 218.5368, 218.5369 and 218.5371 are hereby repealed.".

Amend sec. 2, page 3, by deleting line 1 and inserting:

"Sec. 3. 1. This section and section 1 of this act become effective upon passage and approval.

## **Legislative Counsel's Digest:**

Existing law establishes the powers and duties of the Legislative Committee on Public Lands. (NRS 218.5367)

This bill authorizes the Committee to review and comment on any matter relating to the preservation, conservation, use, management or disposal of public lands, which the Chairman of the Committee or a majority of the members of the Committee considers appropriate. This bill also requires the Committee to submit a report to the Director of the Legislative Counsel Bureau on its actions during each biennium. This bill additionally repeals the provisions creating the Committee effective July 1, 2009.
