

SENATE BILL NO. 14—COMMITTEE ON TRANSPORTATION
AND HOMELAND SECURITY

(ON BEHALF OF THE OFFICE OF VETERANS' SERVICES)

SUMMARY—Revises provisions relating to certain special license plates. (BDR 43-322)

AN ACT relating to license plates; revising the allocation of money collected from the issuance and renewal of special license plates for the support of veterans' homes; increasing the number of sets of the Pearl Harbor Veteran plates, Pearl Harbor Survivor plates, Disabled Veteran plates, ex-Prisoner of War plates, or Purple Heart plates that must be issued to qualified applicants; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law requires that as of July 1, 2005, the first \$100,000 of all money
2 collected from the issuance and renewal of special license plates in support of
3 veterans' homes be deposited in the Gift Account for Veterans' Homes in the State
4 General Fund. (NRS 482.3764, 417.145) The money in the Gift Account does not
5 revert to the State General Fund at the end of a fiscal year and may only be
6 expended for use at veterans' homes. (NRS 417.145) The remaining money
7 collected each year from the issuance and renewal of those special license plates is
8 deposited directly into the State General Fund and, therefore, is not earmarked for
9 uses relating to veterans' homes. (NRS 482.3764)

10 This bill deletes the requirement that a portion of the money collected from the
11 issuance and renewal of special license plates in support of veterans' homes be
12 deposited into the State General Fund. Therefore, all money collected from the
13 issuance and renewal of those special license plates will be deposited in the Gift
14 Account for Veterans' Homes and may only be expended for use at veterans'
15 homes.

16 Existing law requires the Department of Motor Vehicles to issue one set of
17 special license plates to qualified Pearl Harbor survivors (NRS 482.3765), disabled
18 veterans and ex-prisoners of war (NRS 482.377) and Purple Heart recipients (NRS
19 482.3775) who apply for such plates.

20 This bill requires the Department of Motor Vehicles to increase the number of
21 sets of those special license plates that it issues to those qualified applicants to two
22 sets. The special license plates may be used on private passenger vehicles,
23 noncommercial trucks and motor homes.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 482.3764 is hereby amended to read as follows:

2 482.3764 1. Before the Department issues to any person,
3 pursuant to NRS 482.3763:

4 (a) An initial set of special license plates, it shall:

5 (1) Collect a special fee for a veterans' home in the amount
6 of \$25; and

7 (2) Affix a decal to each plate if requested by an applicant
8 who meets the requirements set forth in NRS 482.37635.

9 (b) An annual renewal sticker, it shall:

10 (1) Collect a special fee for a veterans' home in the amount
11 of \$20; and

12 (2) Affix a decal to each plate if requested by an applicant
13 who meets the requirements set forth in NRS 482.37635.

14 2. The Department shall deposit ~~[the first \$100,000 any~~
15 **money** collected pursuant to this section ~~[each year]~~ with the State
16 Treasurer for credit to the Gift Account for Veterans' Homes,
17 established by subsection 7 of NRS 417.145. ~~[Thereafter, any~~
18 ~~additional amount collected pursuant to this section during the year~~
19 ~~must be deposited in the State General Fund.]~~

20 **Sec. 2.** NRS 482.3765 is hereby amended to read as follows:

21 482.3765 1. ~~[A person who qualifies pursuant to this section~~
22 ~~may register one passenger car or light commercial vehicle having a~~
23 ~~manufacturer's rated carrying capacity of 1 ton or less, for his own~~
24 ~~personal use.]~~ A veteran of the Armed Forces of the United States
25 who survived the attack on Pearl Harbor on December 7, 1941, is
26 entitled to ~~[a]~~ specially designed license ~~[plate]~~ plates inscribed with
27 the words "PEARL HARBOR VETERAN" or "PEARL HARBOR
28 SURVIVOR," at the option of the person who qualifies pursuant to
29 this section, and three or four consecutive numbers.

30 2. **Each person who qualifies for special license plates**
31 **pursuant to this section may apply for two sets of plates. The**
32 **second set of plates for an additional vehicle must have a different**
33 **number than the first set of plates issued to the same applicant.**
34 **Special license plates issued pursuant to this section may be used**

1 **only on a private passenger vehicle, a noncommercial truck or a**
2 **motor home.**

3 3. The Department shall issue [a] specially designed license
4 [plate] **plates** for persons qualified pursuant to this section who
5 submit an application on a form prescribed by the Department and
6 evidence of their status as a survivor required by the Department.

7 [3.] 4. If , during a registration year, the holder of [a special
8 plate] **special license plates** issued pursuant to this section disposes
9 of [the] a vehicle to which the plates are affixed, **[he shall retain the**
10 **plates and:**

11 —(a) **Affix]** **the holder shall:**

12 (a) **Retain the plates and affix** them to another vehicle which
13 meets the requirements of this section and report the change to the
14 Department in accordance with the procedure set forth for other
15 transfers; or

16 (b) Within 30 days after removing the plates from the vehicle,
17 return them to the Department.

18 [4.] 5. The fee for [the special license plate] **each set of special**
19 **license plates issued pursuant to this section** is \$25, in addition to
20 all other applicable registration and license fees and governmental
21 services taxes. The annual fee for a renewal sticker **for each set of**
22 **special license plates issued pursuant to this section** is \$5.

23 **Sec. 3.** NRS 482.377 is hereby amended to read as follows:

24 482.377 1. **[A person who qualifies pursuant to this section**
25 **may register one passenger car or light commercial vehicle having a**
26 **manufacturer's rated carrying capacity of one ton or less, for his**
27 **own personal use.]** A veteran of the Armed Forces of the United
28 States who, as a result of his service:

29 (a) Has suffered a 100-percent service-connected disability and
30 who receives compensation from the United States for his disability,
31 is entitled to [a] specially designed license [plate] **plates** inscribed
32 with the words DISABLED VETERAN and three or four
33 consecutive numbers.

34 (b) Has been captured and held prisoner by a military force of a
35 foreign nation, is entitled to [a] specially designed license [plate]
36 **plates** inscribed with the words ex-PRISONER OF WAR and three
37 or four consecutive numbers.

38 2. **Each person who qualifies for special license plates**
39 **pursuant to this section may apply for two sets of plates. The**
40 **second set of plates for an additional vehicle must have a different**
41 **number than the first set of plates issued to the same applicant.**
42 **Special license plates issued pursuant to this section may be used**
43 **only on a private passenger vehicle, a noncommercial truck or a**
44 **motor home.**

1 3. The Department shall issue [a] specially designed license
2 [plate] **plates** for persons qualified pursuant to this section who
3 submit an application on a form prescribed by the Department and
4 evidence of disability or former imprisonment required by the
5 Department.

6 [3.] 4. A vehicle on which license plates issued by the
7 Department pursuant to this section are displayed is exempt from
8 the payment of any parking fees, including those collected through
9 parking meters, charged by the State or any political subdivision or
10 other public body within the State, other than the United States.

11 [4.] 5. If , during a registration year, the holder of [a special
12 plate] **special license plates** issued pursuant to this section disposes
13 of [the] a vehicle to which the plates are affixed, [he shall retain the
14 plates and:]

15 (a) Affix] the holder shall:

16 (a) **Retain the plates and affix** them to another vehicle which
17 meets the requirements of this section and report the change to the
18 Department in accordance with the procedure set forth for other
19 transfers; or

20 (b) Within 30 days after removing the plates from the vehicle,
21 return them to the Department.

22 **Sec. 4.** NRS 482.3775 is hereby amended to read as follows:

23 482.3775 1. [A person who qualifies pursuant to this section
24 may register one passenger car or light commercial vehicle having a
25 manufacturer's rated carrying capacity of 1 ton or less, for his own
26 personal use.] A veteran of the Armed Forces of the United States
27 who was awarded the Purple Heart is entitled to [a] specially
28 designed license [plate which indicates] **plates which indicate** that
29 he is a recipient of the Purple Heart.

30 2. **Each person who qualifies for special license plates**
31 **pursuant to this section may apply for two sets of plates. The**
32 **second set of plates for an additional vehicle must have a different**
33 **number than the first set of plates issued to the same applicant.**
34 **Special license plates issued pursuant to this section may be used**
35 **only on a private passenger vehicle, a noncommercial truck or a**
36 **motor home.**

37 3. The Department shall issue [a] specially designed license
38 [plate] **plates** for any person qualified pursuant to this section who
39 submits an application on a form prescribed by the Department and
40 evidence of his status as a recipient of the Purple Heart as required
41 by the Department. The Department may designate any appropriate
42 colors for the special plates.

43 [3.] 4. If, during a registration year, the holder of [a special
44 plate] **special license plates** issued pursuant to the provisions of this

15 stolen or mutilated, the owner of the vehicle may secure a set of
16 replacement license plates from the Department for a fee of \$5.

17 **Sec. 5.** This act becomes effective on July 1, 2005.
