
SENATE BILL NO. 221—SENATOR CEGAVSKE

SUMMARY—Provides for participation of homeschooled children in certain interscholastic activities and events. (BDR 34-1158)

AN ACT relating to education; providing for the participation of homeschooled children in certain interscholastic activities and events; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law allows homeschooled children to participate in interscholastic
2 athletics governed by an interscholastic association in the same manner as pupils of
3 a public school. (NRS 386.420-386.470) The current association formed pursuant
4 to existing law governs only interscholastic athletics for pupils who are of high
5 school age. Existing law also provides for the participation of homeschooled
6 children in certain classes and extracurricular activities, excluding sports, within the
7 school district of the child's residence. (NRS 392.070)

8 This bill allows homeschooled children to participate in interscholastic
9 activities and events in addition to those that are governed by the association that is
10 currently formed for high school athletics. The homeschooled children must be
11 allowed to participate through a public school and the same rules governing
12 eligibility and participation for public school pupils apply to homeschooled
13 children.

14 This bill also allows a private school that participates in interscholastic
15 activities and events governed by the existing association for high school athletics
16 to adopt a policy that prohibits the participation of homeschooled children in the
17 activities and events through the private school or that allows the participation of
18 homeschooled children through the private school.



THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** NRS 386.462 is hereby amended to read as follows:
2 386.462 1. A homeschooled child must be allowed to
3 participate in interscholastic activities and events in accordance with
4 the regulations adopted by the association pursuant to NRS 386.430.
5 2. *If a private school is a member of the association, the*
6 *school may adopt a policy:*
7 (a) *Prohibiting a homeschooled child from participating in*
8 *interscholastic activities and events of the association through the*
9 *school.*
10 (b) *Allowing a homeschooled child to participate in*
11 *interscholastic activities and events of the association through the*
12 *school if space is available.*
13 (c) *Requiring a homeschooled child who participates in*
14 *interscholastic activities and events of the association through the*
15 *school to pay a fee for participation that is equal to or greater than*
16 *the fee required of a pupil who is enrolled in the school.*
17 3. The provisions of NRS 386.420 to 386.470, inclusive, and
18 the regulations adopted pursuant thereto that apply to pupils enrolled
19 in public schools who participate in interscholastic activities and
20 events apply in the same manner to homeschooled children who
21 participate in interscholastic activities and events, including, without
22 limitation, provisions governing:
23 (a) Eligibility and qualifications for participation;
24 (b) ~~{}Fees}~~ *Except as otherwise provided in subsection 2, fees*
25 *for participation;*
26 (c) Insurance;
27 (d) Transportation;
28 (e) Requirements of physical examination;
29 (f) Responsibilities of participants;
30 (g) Schedules of events;
31 (h) Safety and welfare of participants;
32 (i) Eligibility for awards, trophies and medals;
33 (j) Conduct of behavior and performance of participants; and
34 (k) Disciplinary procedures.
35 **Sec. 2.** NRS 392.070 is hereby amended to read as follows:
36 392.070 1. Attendance required by the provisions of NRS
37 392.040 must be excused when satisfactory written evidence is
38 presented to the board of trustees of the school district in which the
39 child resides that the child is receiving at home or in some other
40 school equivalent instruction of the kind and amount approved by
41 the State Board.



1 2. The board of trustees of each school district shall provide
2 programs of special education and related services for
3 homeschooled children. The programs of special education and
4 related services required by this section must be made available:

5 (a) Only if a child would otherwise be eligible for participation
6 in programs of special education and related services pursuant to
7 NRS 388.440 to 388.520, inclusive;

8 (b) In the same manner that the board of trustees provides, as
9 required by 20 U.S.C. § 1412, for the participation of pupils with
10 disabilities who are enrolled in private schools within the school
11 district voluntarily by their parents or legal guardians; and

12 (c) In accordance with the same requirements set forth in 20
13 U.S.C. § 1412 which relate to the participation of pupils with
14 disabilities who are enrolled in private schools within the school
15 district voluntarily by their parents or legal guardians.

16 3. Except as otherwise provided in subsection 2 for programs
17 of special education and related services, upon the request of a
18 parent or legal guardian of a child who is enrolled in a private
19 school or a parent or legal guardian of a homeschooled child, the
20 board of trustees of the school district in which the child resides
21 shall authorize the child to participate in a class that is not available
22 to the child at the private school or home school or *to* participate in
23 an extracurricular activity, excluding sports, at a public school
24 within the school district if:

25 (a) Space for the child in the class or extracurricular activity is
26 available; and

27 (b) The parent or legal guardian demonstrates to the satisfaction
28 of the board of trustees that the child is qualified to participate in the
29 class or extracurricular activity.

30 ➤ If the board of trustees of a school district authorizes a child to
31 participate in a class or extracurricular activity, excluding sports,
32 pursuant to this subsection, the board of trustees is not required to
33 provide transportation for the child to attend the class or activity. A
34 homeschooled child must be allowed to participate in interscholastic
35 activities and events *governed by an association* pursuant to NRS
36 386.420 to 386.470, inclusive [], *and interscholastic activities and*
37 *events, including sports, pursuant to subsection 5.*

38 4. The board of trustees of a school district may revoke its
39 approval for a pupil to participate in a class or extracurricular
40 activity at a public school pursuant to subsection 3 if the board of
41 trustees or the public school determines that the pupil has failed to
42 comply with applicable statutes, or applicable rules and regulations
43 of the board of trustees. If the board of trustees revokes its approval,
44 neither the board of trustees nor the public school are liable for any
45 damages relating to the denial of services to the pupil.



1 5. *In addition to those interscholastic activities and events*
2 *governed by an association pursuant to NRS 386.420 to 386.470,*
3 *inclusive, homeschooled children must be allowed to participate in*
4 *interscholastic activities and events, including sports, through a*
5 *public school. Any rules or regulations that apply to pupils*
6 *enrolled in public schools who participate in interscholastic*
7 *activities and events, including sports, apply in the same manner*
8 *to homeschooled children who participate in interscholastic*
9 *activities and events, including, without limitation, provisions*
10 *governing:*

- 11 (a) *Eligibility and qualifications for participation;*
- 12 (b) *Fees for participation;*
- 13 (c) *Insurance;*
- 14 (d) *Transportation;*
- 15 (e) *Requirements of physical examination;*
- 16 (f) *Responsibilities of participants;*
- 17 (g) *Schedules of events;*
- 18 (h) *Safety and welfare of participants;*
- 19 (i) *Eligibility for awards, trophies and medals;*
- 20 (j) *Conduct of behavior and performance of participants; and*
- 21 (k) *Disciplinary procedures.*

22 6. *If a homeschooled child participates in interscholastic*
23 *activities and events pursuant to subsection 5:*

24 (a) *No challenge may be brought by an association, a school*
25 *district, a public school or a private school, a parent or guardian*
26 *of a pupil enrolled in a public school or a private school, a pupil*
27 *enrolled in a public school or a private school, or any other entity*
28 *or person claiming that an interscholastic activity or event is*
29 *invalid because the homeschooled child is allowed to participate.*

30 (b) *Neither the school district or a public school may prescribe*
31 *any regulations, rules, policies, procedures or requirements*
32 *governing the eligibility or participation of the homeschooled child*
33 *that are more restrictive than the provisions governing the*
34 *eligibility and participation of pupils enrolled in public schools.*

35 7. The programs of special education and related services
36 required by subsection 2 may be offered at a public school or
37 another location that is appropriate.

38 ~~[6-]~~ 8. The Department may adopt such regulations as are
39 necessary for the boards of trustees of school districts to provide the
40 programs of special education and related services required by
41 subsection 2.

42 ~~[7-]~~ 9. As used in this section, "related services" has the
43 meaning ascribed to it in 20 U.S.C. § 1401(22).
