AN ACT relating to noxious weeds; creating the position of Weed Control Coordinator within the State Department of Agriculture; requiring the Director of the Department to retain a portion of certain annual registration fees for use by the Director and the Weed Control Coordinator; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** Chapter 555 of NRS is hereby amended by adding
2 thereto a new section to read as follows:
3 ***1. The position of Weed Control Coordinator is hereby***
4 ***created within the Department.***
5 ***2. The Director shall appoint the Weed Control Coordinator.***
6 ***The person so appointed:***
7 ***(a) Is in the classified service of the State;***
8 ***(b) Must possess a bachelor's degree in one of the agricultural***
9 ***or biological sciences from an accredited college or university;***
10 ***(c) Must have at least 1 year of work experience in a field of***
11 ***study specified in paragraph (b); and***
12 ***(d) Must be selected on the basis of his training, experience,***
13 ***capability and interest in:***
14 ***(1) Eradicating and controlling noxious weeds; and***



1 (2) *Managing and supervising groups of persons in the*
2 *eradication and control of noxious weeds.*

3 3. *The Weed Control Coordinator shall:*

4 (a) *If requested by an association or other private entity that is*
5 *organized within a county to control or assist in the control of*
6 *noxious weeds within the county:*

7 (1) *Coordinate the activities of that association or private*
8 *entity with the activities of any other similar association or private*
9 *entity concerning the control of noxious weeds; and*

10 (2) *Provide assistance to the association or private entity*
11 *relating to the activities of the association or private entity; and*

12 (b) *Carry out any other duty relating to the control of noxious*
13 *weeds assigned to him by the Director.*

14 **Sec. 2.** NRS 586.270 is hereby amended to read as follows:

15 586.270 1. A registrant shall pay an annual registration fee in
16 an amount established by regulation of the Director , *which must*
17 *not be less than \$20*, for each brand of pesticide registered.

18 2. The Director shall, for each annual registration fee he
19 collects ~~[-]~~:

20 (a) *Except as otherwise provided in paragraph (b)*, deposit in a
21 separate account the amount established for that purpose by
22 ~~[-regulation of]~~ the Director ~~[-]~~ *pursuant to subsection 1; and*

23 (b) *Deposit in a separate account an amount that is equal to*
24 *\$20 of the annual registration fee for use pursuant to paragraph*
25 *(b) of subsection 3.*

26 3. The money deposited in ~~[-the]~~ :

27 (a) *The* account *maintained pursuant to paragraph (a) of*
28 *subsection 2* must be used for the disposal of pesticides and to
29 monitor pesticides and protect ground water and surface water from
30 contamination by pesticides ~~[-]~~.

31 ~~[-3-]~~ ; and

32 (b) *The account maintained pursuant to paragraph (b) of*
33 *subsection 2 must be used by the Director and the Weed Control*
34 *Coordinator in carrying out the provisions of section 1 of this act.*

35 4. A registrant who offers a pesticide for sale before registering
36 the brand of pesticide shall pay an amount equal to twice the
37 registration fee for registering the brand of pesticide.

38 **Sec. 3.** This act becomes effective on July 1, 2005.
