SUMMARY—Revises provisions governing persons appointed to National Conference of Commissioners on Uniform State Laws to represent State of Nevada. (BDR 17-1104)

AN ACT relating to the National Conference of Commissioners on Uniform State Laws; revising the provisions governing the appointment of Commissioners on Uniform State Laws to represent the State of Nevada; revising provisions governing reimbursement of expenses for engaging in certain activities as a Commissioner on Uniform State Laws; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 219 of NRS is hereby amended by adding
2 thereto a new section to read as follows:
3 ***1. A Commissioner who continues to serve or resumes service***
4 ***as a Commissioner pursuant to the provisions of NRS 219.025 and***
5 ***who attends an annual meeting of the National Conference of***
6 ***Commissioners on Uniform State Laws is entitled to receive***
7 ***reimbursement from the Legislative Fund for expenses incurred to***
8 ***attend the annual meeting if the Commissioner, at least 10 days***
9 ***before the annual meeting, provides to the Director of the***
10 ***Legislative Counsel Bureau written notice stating that he will***
11 ***actively participate and carry out the duties set forth in NRS***
12 ***219.030 and 219.040.***



1 2. *Each Commissioner appointed by the Legislative*
2 *Commission pursuant to paragraph (b) of subsection 2 of*
3 *NRS 219.020 is entitled to receive reimbursement from the*
4 *William S. Boyd School of Law for any expenses incurred in*
5 *carrying out his duties as a Commissioner, including travel and*
6 *per diem expenses.*

7 **Sec. 2.** NRS 219.020 is hereby amended to read as follows:

8 219.020 1. Except as otherwise provided in this section and
9 NRS 219.025, the Commissioners are ~~the~~ :

10 (a) *The* Legislative Counsel ;

11 (b) *Two members of the faculty of the William S. Boyd School*
12 *of Law of the University of Nevada, Las Vegas; and* ~~not~~

13 (c) *Not* more than four attorneys licensed to practice law in the
14 State of Nevada appointed by the Legislative Commission.

15 2. The Legislative Commission shall appoint ~~attorneys~~ :

16 (a) *Attorneys* who are members of the Legislature to fill the
17 appointive positions created pursuant to ~~this~~ *paragraph (c) of*
18 *subsection 1* if attorneys are available in the Legislature to fill ~~such~~
19 ~~positions.~~

20 ~~2.~~ *those positions.*

21 (b) *Two members of the faculty of the William S. Boyd School*
22 *of Law of the University of Nevada, Las Vegas, from a list*
23 *submitted to the Legislative Commission by the Dean of the Law*
24 *School. Each member so appointed serves for a term of 4 years.*

25 3. The Legislative Counsel may appoint not more than two
26 additional Commissioners from the attorneys employed by the
27 Legislative Counsel Bureau, upon approval of the Legislative
28 Commission.

29 ~~3.~~ 4. The National Conference of Commissioners on
30 Uniform State Laws is hereby declared to be a joint governmental
31 agency of this State.

33 5. *It is* a function of the Commissioners ~~on Uniform State~~
34 ~~Laws~~ to carry forward the participation of the State of Nevada in
35 the National Conference of Commissioners on Uniform State Laws.
36 Annual dues ~~shall~~ *must* be paid to that organization out of the
37 Legislative Fund.

38 ~~5.~~ 6. The Legislative Counsel shall notify the National
39 Conference of Commissioners on Uniform State Laws whenever a
40 Commissioner is appointed pursuant to this section.

41 **Sec. 3.** NRS 219.025 is hereby amended to read as follows:

42 219.025 1. A Commissioner who served pursuant to
43 subsection 1 of NRS 219.020 , *except for a Commissioner who*
44 *served pursuant to paragraph (b) of that subsection,* may continue
45 to serve or resume his service as a Commissioner if he:



- 1 ~~[1.]~~ (a) Is licensed to practice law in the State of Nevada;
2 ~~[2.]~~ (b) Is a resident of Nevada; and
3 ~~[3.]~~ (c) Notifies the Legislative Counsel of his intention to serve
4 as a Commissioner.
5 2. The Legislative Counsel shall notify the National
6 Conference of Commissioners on Uniform State Laws whenever a
7 Commissioner is added pursuant to this section.
8 **Sec. 4.** This act becomes effective on July 1, 2005.
