EXPLANATION – Matter in ***bolded italics*** is new; matter between brackets **[omitted material]** is material to be omitted.

AN ACT relating to aging persons; authorizing the President of the Nevada Silver Haired Legislative Forum to excuse absences from meetings; eliminating the restrictions on the locations in which the Forum may hold hearings; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

- 1 Under existing law, a member must be removed from the Nevada Silver Haired
2 Legislative Forum if he is absent from three consecutive meetings.
3 (NRS 427A.360)
4 This bill authorizes the President of the Forum, in his discretion, to excuse
5 absences from meetings.
6 Existing law authorizes the Nevada Silver Haired Legislative Forum to hold
7 public hearings but places restrictions on the number and location of the hearings.
8 This bill authorizes the Forum to hold three or more public hearings in the State
9 when the Legislature is not in a regular session and removes the requirement that
10 the meetings, if held, be held in different areas of the State.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** NRS 427A.360 is hereby amended to read as
2 follows:
3 427A.360 1. A position in the Nevada Silver Haired
4 Legislative Forum becomes vacant upon:
5 (a) The death or resignation of a member.

1 (b) The illness of a member that prevents him from attending
2 three consecutive meetings of the Nevada Silver Haired Legislative
3 Forum **[.]**, ***unless excused by the President.***

4 (c) The absence of a member for any reason from three
5 consecutive meetings of the Nevada Silver Haired Legislative
6 Forum **[.]**, ***unless excused by the President.***

7 2. If a vacancy occurs, the Legislative Commission shall
8 appoint a person to serve the remainder of the unexpired term. The
9 Legislative Commission may appoint a person whose membership
10 in the National Silver Haired Congress has ended to fill a vacancy in
11 the Nevada Silver Haired Legislative Forum.

12 ***3. As used in this section, "President" means the person
13 elected to serve as President of the Nevada Silver Haired
14 Legislative Forum pursuant to NRS 427A.370.***

15 **Sec. 2.** NRS 427A.380 is hereby amended to read as follows:

16 427A.380 1. The Nevada Silver Haired Legislative Forum
17 may, within the limits of legislative appropriations and any gifts,
18 grants or donations received by the Forum:

19 (a) During the period in which the Legislature is not in a regular
20 session, hold three ***or more*** public hearings in ***[three different areas
21 of this State and may hold additional public hearings in any area of]***
22 this State.

23 (b) During the period in which the Legislature is in a regular
24 session, meet as often as necessary to conduct the business of the
25 Forum.

26 (c) Form committees, which may meet as often as necessary to
27 conduct the business of the Forum.

28 2. The Nevada Silver Haired Legislative Forum and its
29 committees shall comply with the provisions of chapter 241 of NRS.

30 **Sec. 3.** This act becomes effective on July 1, 2005.
