SUMMARY—Revises provisions relating to Nevada Silver Haired Legislative Forum. (BDR 38-447)

EXPLANATION – Matter in ***bolded italics*** is new; matter between brackets **[omitted material]** is material to be omitted.

AN ACT relating to aging persons; authorizing the President of the Nevada Silver Haired Legislative Forum to excuse absences from meetings; providing that officers of the Forum shall serve terms beginning on July 1 of each year; eliminating the restrictions on the locations in which the Forum may hold hearings; revising the date on which the recommendations for legislation of the Forum must be submitted to the Legislative Commission and the Governor; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

- 1 Under existing law, a member must be removed from the Nevada Silver Haired
- 2 Legislative Forum if he is absent from three consecutive meetings.
- 3 (NRS 427A.360)
- 4 This bill authorizes the President of the Forum, in his discretion, to excuse
- 5 absences from meetings.
- 6 Existing law provides that officers of the Nevada Silver Haired Legislative
- 7 Forum serve a term of 1 year beginning at the first meeting every year of the
- 8 Forum. (NRS 427A.370)
- 9 The bill provides that officers of the Forum serve a term of 1 year beginning on
- 10 July 1 of each year.
- 11 Existing law authorizes the Nevada Silver Haired Legislative Forum to hold
- 12 public hearings but places restrictions on the number and location of the hearings.
- 13 (NRS 427A.380)
- 14 This bill authorizes the Forum to hold three or more public hearings in the State
- 15 when the Legislature is not in a regular session and removes the requirement that
- 16 the meetings, if held, be held in different areas of the State.

17 Existing law authorizes the Nevada Silver Haired Legislative Forum to submit
18 recommendations for legislation to the Legislative Commission and the Governor
19 before July 1 of each even-numbered year. (NRS 427A.390)

20 The bill provides that the Forum may submit recommendations for legislation
21 to the Legislative Commission and the Governor before September 1 of each even-
22 numbered year.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 427A.360 is hereby amended to read as
2 follows:

3 427A.360 1. A position in the Nevada Silver Haired
4 Legislative Forum becomes vacant upon:

5 (a) The death or resignation of a member.

6 (b) The illness of a member that prevents him from attending
7 three consecutive meetings of the Nevada Silver Haired Legislative
8 Forum ~~H~~, *unless excused by the President*.

9 (c) The absence of a member for any reason from three
10 consecutive meetings of the Nevada Silver Haired Legislative
11 Forum ~~H~~, *unless excused by the President*.

12 2. If a vacancy occurs, the Legislative Commission shall
13 appoint a person to serve the remainder of the unexpired term. The
14 Legislative Commission may appoint a person whose membership
15 in the National Silver Haired Congress has ended to fill a vacancy in
16 the Nevada Silver Haired Legislative Forum.

17 *3. As used in this section, "President" means the person
18 elected to serve as President of the Nevada Silver Haired
19 Legislative Forum pursuant to NRS 427A.370.*

20 **Sec. 2.** NRS 427A.370 is hereby amended to read as follows:

21 427A.370 1. The Nevada Silver Haired Legislative Forum
22 shall elect from among its members, to serve a term of 1 *year*
23 *beginning on July 1 of each* year:

24 (a) A President, who shall conduct meetings and oversee the
25 formation of committees as necessary to accomplish the purposes of
26 the Nevada Silver Haired Legislative Forum.

27 (b) A Vice President, who shall assist the President and conduct
28 meetings of the Nevada Silver Haired Legislative Forum if the
29 President is absent or otherwise unable to perform his duties.

30 (c) A Secretary, who shall:

31 (1) Prepare and keep a record of meetings, including, without
32 limitation, the date, time, place and purpose of every meeting; and

33 (2) At the first meeting ~~every year~~ of the Nevada Silver
34 Haired Legislative Forum ~~H~~ *on or after July 1 of each year*,

1 prepare a list of the dates of the meetings that are scheduled for the
2 year.

3 (d) A Treasurer, who shall, with the assistance of the Director of
4 the Legislative Counsel Bureau, administer any account established
5 pursuant to NRS 427A.395.

6 2. The Director of the Legislative Counsel Bureau shall
7 provide such persons as are necessary to assist the Nevada Silver
8 Haired Legislative Forum in carrying out its duties.

9 **Sec. 3.** NRS 427A.380 is hereby amended to read as follows:

10 427A.380 1. The Nevada Silver Haired Legislative Forum
11 may, within the limits of legislative appropriations and any gifts,
12 grants or donations received by the Forum:

13 (a) During the period in which the Legislature is not in a regular
14 session, hold three **or more** public hearings in ~~three different areas~~
15 ~~of this State and may hold additional public hearings in any area of~~
16 this State.

17 (b) During the period in which the Legislature is in a regular
18 session, meet as often as necessary to conduct the business of the
19 Forum.

20 (c) Form committees, which may meet as often as necessary to
21 conduct the business of the Forum.

22 2. The Nevada Silver Haired Legislative Forum and its
23 committees shall comply with the provisions of chapter 241 of NRS.

24 **Sec. 4.** NRS 427A.390 is hereby amended to read as follows:

25 427A.390 The Nevada Silver Haired Legislative Forum may:

26 1. Submit a report containing recommendations for legislative
27 action to the Legislative Commission and the Governor before
28 ~~July~~ September 1 of each even-numbered year.

29 2. Accept gifts, grants and donations that must be deposited in
30 an account established pursuant to NRS 427A.395.

31 3. Adopt procedures to conduct meetings of the Nevada Silver
32 Haired Legislative Forum and committees thereof. Those
33 procedures may be changed upon approval of a majority vote of all
34 members of the Nevada Silver Haired Legislative Forum who are
35 present and voting.

36 **Sec. 5.** This act becomes effective on July 1, 2005.
