**SUMMARY**—Makes various changes relating to qualifications for free tuition and loans for certain students at institutions of University and Community College System of Nevada. (BDR 34-158)

---

AN ACT relating to the University and Community College System of Nevada; providing for the applicability of certain policies established by the Board of Regents in determining residency for purposes of eligibility for free tuition and certain student loans; lengthening certain minimum periods of residency required for students at institutions of the System to qualify for free tuition; expanding the categories of persons who are entitled to receive free tuition; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

1 Existing law provides free tuition to all students enrolled at a university, state  
2 college or community college of the University and Community College System of  
3 Nevada whose families are bona fide residents of Nevada, regardless of the length  
4 of that residency. (NRS 396.540) Existing law also provides free tuition to all  
5 students whose families reside outside Nevada but who themselves have been bona  
6 fide residents of Nevada for at least 6 months prior to their matriculation at an  
7 institution in the System. (NRS 396.540)

8 This bill requires the family of a student to reside in Nevada for at least 12  
9 months prior to the matriculation of the student at an institution in the System for  
10 the student to qualify for free tuition. In addition, this bill increases the minimum

11 period of residency to qualify for free tuition to 12 months prior to matriculation for  
12 students whose families are not residents of Nevada. This bill also requires the  
13 Board of Regents to prescribe by regulation a definition of "matriculation" for  
14 purposes of determining such residency requirements.

15 This bill expands the granting of free tuition to employees of the University and  
16 Community College System of Nevada who take classes other than during regular  
17 working hours and to members of the Armed Forces of the United States.

18 Existing law requires that, for eligibility for student loans, students in nursing  
19 programs of the University and Community College System of Nevada must be  
20 bona fide residents of the State for at least 6 months prior to the student's  
21 matriculation in the System. (NRS 396.890)

22 This bill clarifies that, for the purpose of measuring this required 6-month  
23 period of bona fide residency for such students in nursing programs to be eligible  
24 for student loans, the definition of "matriculation" prescribed by the Board of  
25 Regents by regulation will be used.

26 Existing law provides that for the purposes of eligibility for free tuition or for  
27 nursing student loans from the University and Community College System of  
28 Nevada, the term "bona fide resident" must be construed to require physical  
29 presence in the State during all of the period for which residency is claimed. (NRS  
30 10.155, 396.540, 396.890)

31 This bill requires that the term "bona fide resident" also be construed in  
32 accordance with policies established by the Board of Regents, to the extent that  
33 those policies do not conflict with any statute.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1       **Section 1.** NRS 396.540 is hereby amended to read as follows:  
2        396.540   1. For the purposes of this section:

3           (a) "Bona fide resident" shall be construed in accordance with  
4       the provisions of NRS 10.155 ~~[;]~~ ***and policies established by the  
5       Board of Regents, to the extent that those policies do not conflict  
6       with any statute.*** The qualification "bona fide" is intended to assure  
7       that the residence is genuine and established for purposes other than  
8       the avoidance of tuition.

9           (b) ***"Matriculation" has the meaning ascribed to it in  
10      regulations adopted by the Board of Regents.***

11          (c) "Tuition charge" means a charge assessed against students  
12       who are not residents of Nevada and which is in addition to  
13       registration fees or other fees assessed against students who are  
14       residents of Nevada.

15       2. The Board of Regents may fix a tuition charge for students  
16       at all campuses of the ~~University of Nevada~~ System, but tuition  
17       ~~[shall]~~ ***must*** be free to:

18           (a) All students whose families ~~[are]~~ ***have been*** bona fide  
19       residents of the State of Nevada ~~[;]~~ ***for at least 12 months prior to  
20      the matriculation of the student at a university, state college or  
21      community college within the System;***

1       (b) All students whose families reside outside of the State of  
2 Nevada, providing such students have themselves been bona fide  
3 residents of the State of Nevada for at least ~~16~~ **12** months prior to  
4 their matriculation at *a university, state college or community*  
5 *college within the [university;] System;*

6       (c) All public school teachers who are employed full time by  
7 school districts in the State of Nevada; ~~and~~

8       (d) All full-time teachers in private elementary, secondary and  
9 postsecondary educational institutions in the State of Nevada whose  
10 curricula meet the requirements of chapter 394 of NRS ~~H~~;

11      (e) *Employees of the System who take classes other than*  
12 *during their regular working hours; and*

13      (f) *Members of the Armed Forces of the United States.*

14       3. In its discretion, the Board of Regents may grant tuitions  
15 free each ~~[university]~~ semester to *other* worthwhile and deserving  
16 students from other states and foreign countries, in *a* number not to  
17 exceed a number equal to 3 percent of the total matriculated  
18 enrollment of students for the last preceding fall semester.

19      **Sec. 2.** NRS 396.890 is hereby amended to read as follows:

20       396.890 1. The Board of Regents may administer, directly or  
21 through a designated officer or employee of the System, a program  
22 to provide loans for fees, books and living expenses to students in  
23 the nursing programs of the System.

24       2. Each student to whom a loan is made must:

25       (a) Have been a "bona fide resident" of Nevada, as that term is  
26 defined in NRS 396.540 , ~~H~~ for at least 6 months ~~before his~~  
27 ~~matriculation~~ *prior to the "matriculation" of the student* in the  
28 System ~~H~~, *as that term is defined pursuant to NRS 396.540;*

29       (b) Be enrolled at the time the loan is made in a nursing program  
30 of the System for the purpose of becoming a licensed practical nurse  
31 or registered nurse;

32       (c) Fulfill all requirements for classification as a full-time  
33 student showing progression towards completion of the program;  
34 and

35       (d) Maintain at least a 2.00 grade-point average in each class  
36 and at least a 2.75 overall grade-point average, on a 4.0 grading  
37 scale.

38       3. Each loan must be made upon the following terms:

39       (a) All loans must bear interest at 8 percent per annum from the  
40 date when the student receives the loan.

41       (b) Each student receiving a loan must repay the loan with  
42 interest following the termination of his education for which the  
43 loan is made. The loan must be repaid in monthly installments over  
44 the period allowed with the first installment due 1 year after the date  
45 of the termination of his education for which the loan is made. The

1 amounts of the installments must not be less than \$50 and may be  
2 calculated to allow a smaller payment at the beginning of the period  
3 of repayment, with each succeeding payment gradually increasing  
4 so that the total amount due will have been paid within the period  
5 for repayment. The period for repayment of the loans must be:

- 6       (1) Five years for loans which total less than \$10,000.  
7       (2) Eight years for loans which total \$10,000 or more, but  
8 less than \$20,000.

9       (3) Ten years for loans which total \$20,000 or more.

10      4. A delinquency charge may be assessed on any installment  
11 delinquent 10 days or more in the amount of 8 percent of the  
12 installment or \$4, whichever is greater, but not more than \$15.

13      5. The reasonable costs of collection and an attorney's fee may  
14 be recovered in the event of delinquency.

15     **Sec. 3.** The provisions of section 1 of this act apply  
16 prospectively and do not affect, impair or eliminate any existing  
17 obligation of the Board of Regents to pay refunds to students who  
18 were charged tuition but who were bona fide residents of the State  
19 of Nevada for at least 6 months before matriculation between 1995  
20 and spring of 2004 that was established by the Board of Regents at  
21 its meeting which was held on March 18-19, 2004.

22     **Sec. 4.** Notwithstanding any provision of section 1 of this act  
23 to the contrary, each student who is a resident of the State of Nevada  
24 for at least 6 months but less than 12 months before the first day of  
25 instruction for the fall semester of 2005 at the applicable institution  
26 within the Nevada System of Higher Education shall be deemed a  
27 "bona fide resident" for purposes of that section.

28     **Sec. 5.** This act becomes effective on July 1, 2005.
