AN ACT relating to the system of criminal justice; making various changes concerning the composition of and the administration of the Advisory Commission on Sentencing; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 176.0123 is hereby amended to read as
2 follows:

3 176.0123 1. The Advisory Commission on Sentencing is
4 hereby created. The Commission consists of:

5 (a) One member who is a district judge, appointed by the
6 governing body of the Nevada District Judges Association;

7 (b) One member who is a district attorney, appointed by the
8 governing body of the Nevada District Attorneys Association;

9 (c) One member who is an attorney in private practice,
10 experienced in defending criminal actions, appointed by the
11 governing body of the State Bar of Nevada;

12 (d) One member who is a representative of a law enforcement
13 agency, appointed by the Governor;

1 (e) One member who is a representative of the Division of
2 Parole and Probation of the Department of Public Safety, appointed
3 by the Governor;

4 (f) One member who has been a victim of a crime or is a
5 representative of an organization supporting the rights of victims of
6 crime, appointed by the Governor;

7 (g) One member who is a county commissioner, appointed by
8 the governing body of the Nevada Association of Counties;

9 (h) *The Director of the Department of Corrections;*

10 (i) Two members who are Senators, one of whom is appointed
11 by the Majority Leader of the Senate and one of whom is appointed
12 by the Minority Leader of the Senate; and

13 (j) Two members who are Assemblymen, one of whom is
14 appointed by the Speaker of the Assembly and one of whom is
15 appointed by the Minority Leader of the Assembly.

16 → If any association listed in this subsection ceases to exist, the
17 appointment required by this subsection must be made by the
18 association's successor in interest or, if there is no successor in
19 interest, by the Governor.

20 2. The ~~[Governor shall designate one member of the~~
21 ~~Commission to~~ *Attorney General is an ex officio voting member*
22 *of the Commission and shall serve as the Chairman [] of the*
23 *Commission.*

24 3. Each *appointed* member serves a term of 2 years. Members
25 may be reappointed for additional terms of 2 years in the same
26 manner as the original appointments. Any vacancy occurring in the
27 membership of the Commission must be filled in the same manner
28 as the original appointment.

29 4. The Legislators who are members of the Commission are
30 entitled to receive the salary provided for a majority of the members
31 of the Legislature during the first 60 days of the preceding session
32 for each day's attendance at a meeting of the Commission.

33 5. While engaged in the business of the Commission, *to the*
34 *extent of legislative appropriation*, each member ~~[and employee]~~ of
35 the Commission is entitled to receive the per diem allowance and
36 travel expenses provided for state officers and employees generally.

37 6. *To the extent of legislative appropriation, the Attorney*
38 *General shall provide the Commission with such staff as is*
39 *necessary to carry out the duties of the Commission.*
