AN ACT relating to real estate; revising provisions relating to the regulation of real estate brokers, broker-salesmen and salesmen; requiring the preparation and distribution of booklets on disclosures; requiring the Administrator of the Real Estate Division of the Department of Business and Industry to charge and collect certain fees and costs relating to audits conducted of real estate brokers; prohibiting an owner-developer from employing salesmen unless the owner-developer also employs a qualified broker-salesman to act as a sales manager over the salesmen; prohibiting the issuance of a permit or registration under certain circumstances to a person whose previous permit or registration was revoked; revising provisions relating to the scope of a license as a residential appraiser; revising provisions relating to fingerprints required for background checks; requiring the Commission of Appraisers of Real Estate to adopt certain regulations relating to licensure of, and continuing education for, appraisers; increasing the period during which certain disciplinary proceedings must be commenced; revising the definition of “sales agent” involved in the sale of time shares; revising provisions



relating to the registration of representatives involved in the sale of time shares; revising fees; providing a penalty; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

**Section 1.** Chapter 645 of NRS is hereby amended by adding thereto the provisions set forth as sections 2 to 5, inclusive, of this act.

**Sec. 2. 1.** *An applicant for a license as a real estate salesman is not required to pass the uniform portion of a national real estate examination otherwise required by NRS 645.330 and 645.460 if:*

*(a) He holds a license in good standing as a real estate broker, broker-salesman or salesman issued by another state or territory of the United States, or the District of Columbia;*

*(b) The requirements for licensure as a real estate salesman issued in that state or territory of the United States, or the District of Columbia, are substantially equivalent to the requirements in this State for licensure as a real estate salesman; and*

*(c) The applicant has passed the examination in that state or territory of the United States, or the District of Columbia.*

**2.** *The Division shall issue a license as a real estate broker or broker-salesman to a person who holds a license as a real estate broker or broker-salesman, or an equivalent license, issued by a state or territory of the United States, or the District of Columbia, if that state or territory, or the District of Columbia, has entered into a reciprocal agreement with the Commission for the issuance of licenses pursuant to this chapter and the person submits proof to the Division that:*

*(a) He has been issued a license as a real estate broker or broker-salesman, or an equivalent license, by that state or territory of the United States, or the District of Columbia; and*

*(b) At the time he files his application with the Division, the license is in good standing.*

**3.** *The Commission shall not enter into a reciprocal agreement pursuant to subsection 2 unless the provisions relating to the practice of real estate, including the requirements for the licensing of real estate brokers and real estate broker-salesmen in the other state or territory of the United States, or the District of Columbia, are substantially similar to the provisions relating to the practice of real estate in this State.*

**Sec. 3. 1.** *The Division shall prepare a booklet that provides relevant information concerning the disclosures that are*



1 *required by federal, state and local laws and regulations by a*  
2 *buyer and a seller in a transaction involving the sale of residential*  
3 *property.*

4 *2. The Division shall make copies of the booklet prepared*  
5 *pursuant to subsection 1 available to licensees which the licensee*  
6 *must distribute to prospective buyers and sellers in the sale of*  
7 *residential property in accordance with the regulations adopted by*  
8 *the Commission.*

9 *3. The Commission shall approve the format and content of*  
10 *the information that must be included in the booklet.*

11 *4. As used in this section, "residential property" has the*  
12 *meaning ascribed to it in NRS 113.100.*

13 **Sec. 4.** *1. The Administrator shall charge and collect from*  
14 *each real estate broker an amount equal to the amount of the*  
15 *actual costs and fees incurred by the Division to conduct an audit*  
16 *of the financial accounts of the real estate broker pursuant to this*  
17 *chapter or any regulations adopted pursuant thereto.*

18 *2. The Administrator shall bill each real estate broker upon*  
19 *the completion of the audit for the costs and fees imposed*  
20 *pursuant to subsection 1. The costs and fees must be paid within*  
21 *30 days after the date the real estate broker receives the bill.*  
22 *Except as otherwise provided in this subsection, any payment*  
23 *received after the due date must include a penalty in the amount of*  
24 *10 percent of the amount specified in the bill plus an additional*  
25 *penalty in the amount of 1 percent of the amount for each month,*  
26 *or portion of a month, that the bill is not paid. The Administrator*  
27 *may waive the penalty for good cause.*

28 *3. The failure of a real estate broker to pay the costs and fees*  
29 *required pursuant to subsection 1 as provided in this section*  
30 *constitutes grounds for disciplinary action against the real estate*  
31 *broker.*

32 *4. Money received by the Division pursuant to this section*  
33 *must be:*

34 *(a) Deposited with the State Treasurer for credit to the*  
35 *appropriate account of the Division.*

36 *(b) Used by the Division only to offset the fees and costs*  
37 *incurred by the Division in carrying out the provisions of*  
38 *NRS 645.313.*

39 **Sec. 5.** *1. To qualify as a sales manager for the purposes of*  
40 *NRS 645.283, a licensed real estate broker-salesman must have at*  
41 *least 2 years of experience during the immediately preceding 4*  
42 *years as a real estate broker-salesman or salesman licensed in this*  
43 *State or any other state or territory of the United States, or the*  
44 *District of Columbia.*

45 *2. A real estate broker-salesman shall:*



1     (a) *Before becoming associated with an owner-developer as a*  
2     *sales manager, notify the Division on a form prescribed by the*  
3     *Division that he will be acting in that capacity; and*

4     (b) *Upon the termination of his association with an owner-*  
5     *developer as a sales manager, notify the Division of that fact.*

6     **Sec. 6.** NRS 645.035 is hereby amended to read as follows:

7     645.035 1. Within the meaning of this chapter, a “real estate  
8     broker-salesman” is any person who holds a real estate broker’s  
9     license, or who has passed the real estate broker’s examination, but  
10    who, as an employee or as an independent contractor, for  
11    compensation or otherwise, is associated with ~~it~~:

12    (a) *A licensed real estate broker in the capacity of a salesman, to*  
13    *do or to deal in any act, acts or transactions included within the*  
14    *definition of a real estate broker in NRS 645.030* ~~it~~ *; or*

15    (b) *A registered owner-developer in the capacity of a sales*  
16    *manager in accordance with NRS 645.283 and section 5 of this*  
17    *act.*

18    2. In this chapter , the term “real estate salesman” includes  
19    “real estate broker-salesman” when applicable.

20    **Sec. 7.** NRS 645.280 is hereby amended to read as follows:

21    645.280 1. It is unlawful for any licensed real estate broker,  
22    or broker-salesman or salesman to offer, promise, allow, give or  
23    pay, directly or indirectly, any part or share of his commission,  
24    compensation or finder’s fee arising or accruing from any real estate  
25    transaction to any person who is not a licensed real estate broker,  
26    broker-salesman or salesman, in consideration of services performed  
27    or to be performed by the unlicensed person. A licensed real estate  
28    broker may pay a commission to a licensed broker of another state.

29    2. A real estate broker-salesman or salesman shall not be  
30    associated with or accept compensation from any person other than  
31    the broker or owner-developer under whom he is *licensed* at the  
32    time ~~licensed~~ *of the real estate transaction.*

33    3. It is unlawful for any licensed real estate broker-salesman or  
34    salesman to pay a commission to any person except through the  
35    broker or owner-developer under whom he is *licensed* at the time

**Sec. 11.** NRS 645.343 is hereby amended to read as follows:

645.343 1. In addition to the other requirements contained in this chapter, an applicant for an original real estate salesman's license must furnish proof satisfactory to the Real Estate Division that he has successfully completed a course of instruction in the principles, practices, procedures, law and ethics of real estate, which course may be an extension or correspondence course offered by the University and Community College System of Nevada, by any other accredited college or university or by any other college or school approved by the Commission. The course of instruction must include the subject of disclosure of required information in real estate transactions, including instruction on methods a seller may use to obtain the required information.

2. An applicant for an original real estate broker's or broker-salesman's license must furnish proof satisfactory to the Real Estate Division that he has successfully completed 45 semester units or the equivalent in quarter units of college level courses which include:

(a) Three semester units or an equivalent number of quarter units in real estate law, including at least 18 classroom hours of the real estate law of Nevada and another course of equal length in the principles of real estate;

(b) Nine semester units or the equivalent in quarter units of college level courses in real estate appraisal and business or economics;

(c) Nine semester units or the equivalent in quarter units of college level courses in real estate, business or economics; and

(d) Three semester units or an equivalent number of quarter units in broker management.

3. On and after January 1, 1986, in addition to other requirements contained in this chapter, an applicant for an original real estate broker's or broker-salesman's license must furnish proof satisfactory to the Real Estate Division that he has completed 64 semester units or the equivalent in quarter units of college level courses. This educational requirement includes and is not in addition to the requirements listed in subsection 2.

4. For the purposes of this section, each person ~~[holding a valid]~~ *who holds a license as a* real estate ~~[salesman's license under the provisions of this chapter]~~ *broker, broker-salesman or salesman, or an equivalent license, issued by a state or territory of the United States, or the District of Columbia,* is entitled to receive credit for the equivalent of 16 semester units of college level courses for each 2 years of active experience *that, during the immediately preceding 10 years,* he has ~~[as a licensed real estate salesman.]~~ *obtained while he has held such a license, not to exceed 8 years of active experience.* This credit may not be applied against the
