AN ACT relating to personal identifying information; prohibiting the establishment or possession of a financial forgery laboratory; enhancing the penalties for crimes involving personal identifying information that are committed against older persons and vulnerable persons; requiring the issuer of a credit card to provide a notice including certain information concerning its policies regarding identity theft and the rights of cardholders when issuing a credit card to a cardholder; requiring data collectors to provide notification concerning any breach of security involving system data; making various other changes concerning personal identifying information; providing penalties; and providing other matters properly relating thereto.



THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

**Section 1.** Chapter 205 of NRS is hereby amended by adding thereto the provisions set forth as sections 2 to 6, inclusive, of this act.

**Sec. 2.** *“Artificial person” means any corporation, limited-liability company, limited-liability partnership, limited partnership, limited-liability limited partnership, business trust or municipal corporation or any comparable entity which is created and existing under the laws of this State, any other state, territory or foreign government, or the Government of the United States and which is doing business in this State.*

**Sec. 3.** *“Older person” means a person who is 60 years of age or older.*

**Sec. 4.** *“Vulnerable person” means a person who:*

*1. Suffers from a condition of physical or mental incapacitation because of a developmental disability, organic brain damage or mental illness; or*

*2. Has one or more physical or mental limitations that restrict the ability of the person to perform the normal activities of daily living.*

**Sec. 5.** *In any case in which a person is convicted of violating any provision of NRS 205.461 to 205.4657, inclusive, and sections 2 to 5, inclusive, of this act, the court records must clearly reflect that the violation was committed by the person convicted of the violation and not by the person whose personal identifying information forms a part of the violation.*

**Sec. 6. 1.** *A person shall not establish or possess a financial forgery laboratory with the intent to commit any unlawful act.*

*2. Unless a greater penalty is provided pursuant to specific statute, a person who violates this section is guilty of a category B felony and shall be punished by imprisonment in the state prison for a minimum term of not less than 1 year and a maximum term of not more than 20 years, and may be further punished by a fine of not more than \$100,000.*

*3. For the purposes of prosecuting a violation of this section, the prosecuting attorney may present expert testimony to provide a prima facie case that any computer, system, program or electronic or mechanical device, or any combination thereof, is specifically configured for any purpose set forth in subparagraph (1) or (2) of paragraph (b) of subsection 4.*

*4. As used in this section:*

*(a) “Computer” has the meaning ascribed to it in NRS 205.4735.*



(b) “Financial forgery laboratory” means any computer, system, program or other electronic or mechanical device, or any combination thereof, that is specifically configured for the purpose of unlawfully:

(1) Obtaining personal identifying information of another person to commit an unlawful act; or

(2) Manufacturing any forged or fraudulent financial instrument, document or item, including, without limitation, any negotiable instrument, check, draft, bond, credit card, debit card, stock certificate, annuity, bank bill or note, draft, bill of exchange, contract, promissory note, traveler’s check or money order.

(c) “Personal identifying information” has the meaning ascribed to it in NRS 205.4617.

(d) “Program” has the meaning ascribed to it in NRS 205.475.

(e) “System” has the meaning ascribed to it in NRS 205.476.

**Sec. 7.** NRS 205.461 is hereby amended to read as follows:

205.461 As used in NRS 205.461 to 205.4657, inclusive, *and sections 2 to 5, inclusive, of this act*, unless the context otherwise requires, the words and terms defined in NRS 205.4613 to 205.4627, inclusive, *and sections 2, 3 and 4 of this act* have the meanings ascribed to them in those sections.

**Sec. 8.** NRS 205.4617 is hereby amended to read as follows:

205.4617 ~~["Personal"]~~

*1. Except as otherwise provided in subsection 2, “personal identifying information” means any information designed, commonly used or capable of being used, alone or in conjunction with any other information, to identify a living or deceased person, including, without limitation:*

~~1-1~~ (a) The *current or former* name, driver’s license number, *identification card number*, social security number, *checking account number*, savings account number, credit card number, debit card number, *financial services account number*, date of birth, place of employment and maiden name of the mother of a person . ~~1-2~~ *and*

~~2-1~~ (b) The *unique biometric data of a person, including, without limitation, the* fingerprints, *facial scan identifiers*, voiceprint, retina image and iris image of a person.

(c) *The electronic signature, unique electronic identification number, address or routing code, telecommunication identifying information or access device of a person.*

(d) *The personal identification number or password of a person.*

(e) *The alien registration number, government passport number, employer identification number, taxpayer identification number, Medicaid account number, food stamp account number,*



1 *medical identification number or health insurance identification*  
2 *number of a person.*

3 (f) *The number of any professional, occupational, recreational*  
4 *or governmental license, certificate, permit or membership of a*  
5 *person.*

6 (g) *The number, code or other identifying information of a*  
7 *person who receives medical treatment as part of a confidential*  
8 *clinical trial or study, who participates in a confidential clinical*  
9 *trial or study involving the use of prescription drugs or who*  
10 *participates in any other confidential medical, psychological or*  
11 *behavioral experiment, study or trial.*

13 2. *To the extent that any information listed in subsection 1 is*  
14 *designed, commonly used or capable of being used, alone or in*  
15 *conjunction with any other information, to identify an artificial*  
16 *person, "personal identifying information" includes information*  
17 *pertaining to an artificial person.*

18 **Sec. 9.** NRS 205.463 is hereby amended to read as follows:

14      3. *An issuer that is subject to and complies with the privacy*  
15 *and security provisions of the Gramm-Leach-Bliley Act, 15 U.S.C.*  
16 *§§ 6801 et seq., shall be deemed to be in compliance with the*  
17 *notification requirements of this section.*

18      4. *As used in this section:*

19      (a) *“Credit information” means any information that is related*  
20 *to credit and derived from a consumer credit report, found on a*  
21 *consumer credit report or provided on an application for a credit*  
22 *card.*

23      (b) *“Personal identifying information” has the meaning*  
24 *ascribed to it in NRS 205.4617.*

25      **Sec. 15.** NRS 97A.140 is hereby amended to read as follows:

26      97A.140 1. An issuer located in this State shall not issue a  
27 credit card to a cardholder unless ~~he first receives~~ *the issuer first:*

28      (a) *Provides the written notice required pursuant to section 14*  
29 *of this act to the cardholder; and*

30      (b) *Receives* a written or oral request from the cardholder for the  
31 issuance of the credit card.

32      2. An issuer shall provide the cardholder with the terms and  
33 conditions that govern the use of the credit card, in writing, before  
34 or at the time of the receipt of the credit card. A cardholder shall be  
35 deemed to have accepted the written terms and conditions provided  
36 by the issuer upon subsequent actual use of the credit card.

37      3. The rate of interest charged, and any other fees or charges  
38 imposed for the use of the credit card, must be in an amount agreed  
39 upon by the issuer and cardholder.

40      4. An issuer may unilaterally change any term or condition for  
41 the use of a credit card without prior written notice to the cardholder  
42 unless the change will adversely affect or increase the costs to the  
43 cardholder for the use of the credit card. If the change will increase  
44 such costs, the issuer shall provide notice to the cardholder of the  
45 change at least 30 days before the change becomes effective.



1        5. Unless otherwise stated as a term or condition, the law of  
2 this State governs all transactions relating to the use of a credit card  
3 if an issuer, or the service provider of an issuer, is located in this  
4 State.

5        **Sec. 16.** Chapter 239B of NRS is hereby amended by adding  
6 thereto a new section to read as follows:

7        *1. If a public body maintains a website on the Internet, the*  
8 *public body shall not disclose on that website personal information*  
9 *unless the disclosure is required by a federal or state statute or*  
10 *regulation.*

11        *2. If it appears that a public body has engaged in or is about*  
12 *to engage in any act or practice which violates subsection 1, the*  
13 *Attorney General or the appropriate district attorney may file an*  
14 *action in any court of competent jurisdiction for an injunction to*  
15 *prevent the occurrence or continuance of that act or practice.*

16        *3. An injunction:*

17        *(a) May be issued without proof of actual damage sustained by*  
18 *any person.*

19        *(b) Does not preclude the criminal prosecution and*  
20 *punishment of an act or practice that may otherwise be prohibited*  
21 *by law.*

22        *4. As used in this section:*

23        *(a) "Personal information" has the meaning ascribed to it in*  
24 *section 21 of this act.*

25        *(b) "Public body" has the meaning ascribed to it in*

27        **Sec. 17.** Title 52 of NRS is hereby amended by adding thereto  
28 a new chapter to consist of the provisions set forth as sections 18 to  
29 28, inclusive, of this act.

30        **Sec. 18.** *As used in this chapter, unless the context otherwise*  
31 *requires, the words and terms defined in sections 19, 20 and 21 of*  
32 *this act have the meanings ascribed to them in those sections.*

33        **Sec. 19.** *"Breach of the security of the system data" means*  
34 *unauthorized acquisition of computerized data that materially*  
35 *compromises the security, confidentiality or integrity of personal*  
36 *information maintained by the data collector. The term does not*  
37 *include the good faith acquisition of personal information by an*  
38 *employee or agent of the data collector for a legitimate purpose of*  
39 *the data collector, so long as the personal information is not used*  
40 *for a purpose unrelated to the data collector or subject to further*  
41 *unauthorized disclosure.*

42        **Sec. 20.** *"Data collector" means any governmental agency,*  
43 *institution of higher education, corporation, financial institution*  
44 *or retail operator or any other type of business entity or*  
45 *association that, for any purpose, whether by automated collection*



1 *or otherwise, handles, collects, disseminates or otherwise deals*  
2 *with nonpublic personal information.*

3 **Sec. 21.** *“Personal information” means a natural person’s*  
4 *first name or first initial and last name in combination with any*  
5 *one or more of the following data elements, when the name and*  
6 *data elements are not encrypted:*

7 *1. Social security number or employer identification number.*

8 *2. Driver’s license number or identification card number.*

9 *3. Account number, credit card number or debit card*  
10 *number, in combination with any required security code, access*  
11 *code or password that would permit access to the person’s*  
12 *financial account.*

13 *↪ The term does not include publicly available information that is*  
14 *lawfully made available to the general public.*

15 **Sec. 22.** *1. A business that maintains records which*  
16 *contain personal information concerning the customers of the*  
17 *business shall take reasonable measures to ensure the destruction*  
18 *of those records when the business decides that it will no longer*  
19 *maintain the records.*

20 *2. As used in this section:*

21 *(a) “Business” means a proprietorship, corporation,*  
22 *partnership, association, trust, unincorporated organization or*  
23 *other enterprise doing business in this State.*

24 *(b) “Reasonable measures to ensure the destruction” means*  
25 *any method that modifies the records containing the personal*  
26 *information in such a way as to render the personal information*  
27 *contained in the records unreadable or undecipherable, including,*  
28 *without limitation:*

29 *(1) Shredding of the record containing the personal*  
30 *information; or*

31 *(2) Erasing of the personal information from the records.*

32 **Sec. 23.** *1. A data collector that maintains records which*  
33 *contain personal information of a resident of this State shall*  
34 *implement and maintain reasonable security measures to protect*  
35 *those records from unauthorized access, acquisition, destruction,*  
36 *use, modification or disclosure.*

37 *2. A contract for the disclosure of the personal information of*  
38 *a resident of this State which is maintained by a data collector*  
39 *must include a provision requiring the person to whom the*  
40 *information is disclosed to implement and maintain reasonable*  
41 *security measures to protect those records from unauthorized*  
42 *access, acquisition, destruction, use, modification or disclosure.*

43 *3. If a state or federal law requires a data collector to provide*  
44 *greater protection to records that contain personal information of*  
45 *a resident of this State which are maintained by the data collector*



1 *and the data collector is in compliance with the provisions of that*  
2 *state or federal law, the data collector shall be deemed to be in*  
3 *compliance with the provisions of this section.*

4 **Sec. 24.** 1. *Any data collector that owns or licenses*  
5 *computerized data which includes personal information shall*  
6 *disclose any breach of the security of the system data following*  
7 *discovery or notification of the breach to any resident of this State*  
8 *whose unencrypted personal information was, or is reasonably*  
9 *believed to have been, acquired by an unauthorized person. The*  
10 *disclosure must be made in the most expedient time possible and*  
11 *without unreasonable delay, consistent with the legitimate needs*  
12 *of law enforcement, as provided in subsection 3, or any measures*  
13 *necessary to determine the scope of the breach and restore the*  
14 *reasonable integrity of the system data.*

15 2. *Any data collector that maintains computerized data which*  
16 *includes personal information that the data collector does not own*  
17 *shall notify the owner or licensee of the information of any breach*  
18 *of the security of the system data immediately following discovery*  
19 *if the personal information was, or is reasonably believed to have*  
20 *been, acquired by an unauthorized person.*

21 3. *The notification required by this section may be delayed if*  
22 *a law enforcement agency determines that the notification will*  
23 *impede a criminal investigation. The notification required by this*  
24 *section must be made after the law enforcement agency*  
25 *determines that the notification will not compromise the*  
26 *investigation.*

27 4. *For purposes of this section, except as otherwise provided*  
28 *in subsection 5, the notification required by this section may be*  
29 *provided by one of the following methods:*

30 (a) *Written notification.*

31 (b) *Electronic notification, if the notification provided is*  
32 *consistent with the provisions of the Electronic Signatures in*  
33 *Global and National Commerce Act, 15 U.S.C. §§ 7001 et seq.*

34 (c) *Substitute notification, if the data collector demonstrates*  
35 *that the cost of providing notification would exceed \$250,000, the*  
36 *affected class of subject persons to be notified exceeds 500,000 or*  
37 *the data collector does not have sufficient contact information.*  
38 *Substitute notification must consist of all the following:*

39 (1) *Notification by electronic mail when the data collector*  
40 *has electronic mail addresses for the subject persons.*

41 (2) *Conspicuous posting of the notification on the Internet*  
42 *website of the data collector, if the data collector maintains an*  
43 *Internet website.*

44 (3) *Notification to major statewide media.*

45 5. *A data collector which:*



1       (a) *Maintains its own notification policies and procedures as*  
2 *part of an information security policy for the treatment of personal*  
3 *information that is otherwise consistent with the timing*  
4 *requirements of this section shall be deemed to be in compliance*  
5 *with the notification requirements of this section if the data*  
6 *collector notifies subject persons in accordance with its policies*  
7 *and procedures in the event of a breach of the security of the*  
8 *system data.*

9       (b) *Is subject to and complies with the privacy and security*  
10 *provisions of the Gramm-Leach-Bliley Act, 15 U.S.C. §§ 6801, et*  
11 *seq., shall be deemed to be in compliance with the notification*  
12 *requirements of this section.*

13       6. *If a data collector determines that notification is required*  
14 *to be given pursuant to the provisions of this section to more than*  
15 *1,000 persons at any one time, the data collector shall also notify,*  
16 *without unreasonable delay, any consumer reporting agency, as*  
17 *that term is defined in 15 U.S.C. § 1681a, that compiles and*  
18 *maintains files on consumers on a nationwide basis, of the time*  
19 *the notification is distributed and the content of the notification.*

20       **Sec. 25.** *A data collector who provides the notification*  
21 *required pursuant to section 24 of this act may commence an*  
22 *action for damages against a person that unlawfully obtained or*  
23 *benefited from personal information obtained from records*  
24 *maintained by the data collector. A data collector that prevails in*  
25 *such an action may be awarded damages which may include,*  
26 *without limitation, the reasonable costs of notification, reasonable*  
27 *attorney's fees and costs and punitive damages when appropriate.*  
28 *The costs of notification include, without limitation, labor,*  
29 *materials, postage and any other costs reasonably related to*  
30 *providing the notification.*

31       **Sec. 26.** *In addition to any other penalty provided by law for*  
32 *the breach of the security of the system data maintained by a data*  
33 *collector, the court may order a person who is convicted of*  
34 *unlawfully obtaining or benefiting from personal information*  
35 *obtained as a result of such breach to pay restitution to the data*  
36 *collector for the reasonable costs incurred by the data collector in*  
37 *providing the notification required pursuant to section 24 of this*  
38 *act, including, without limitation, labor, materials, postage and*  
39 *any other costs reasonably related to providing such notification.*

40       **Sec. 27.** *Any waiver of the provisions of this chapter is*  
41 *contrary to public policy, void and unenforceable.*

42       **Sec. 28.** *If the Attorney General or a district attorney of any*  
43 *county has reason to believe that any person is violating, proposes*  
44 *to violate or has violated the provisions of this chapter, he may*



1 *bring an action against that person to obtain a temporary or*  
2 *permanent injunction against the violation.*

3 **Sec. 29.** Chapter 597 of NRS is hereby amended by adding  
4 thereto a new section to read as follows:

5 *1. A business in this State shall not transfer any personal*  
6 *information of a customer through an electronic transmission*  
7 *other than a facsimile to a person outside of the secure system of*  
8 *the business unless the business uses encryption to ensure the*  
9 *security of the electronic transmission. A secure system must not*  
10 *be accessible to any person outside of the business.*

11 *2. As used in this section:*

12 *(a) "Encryption" has the meaning ascribed to it in*  
13 *NRS 205.4742.*

14 *(b) "Personal information" has the meaning ascribed to it in*  
15 *section 21 of this act.*

16 **Sec. 30.** 1. This section and sections 1 to 13, inclusive, of  
17 this act become effective on October 1, 2005.

18 2. Sections 14 to 28, inclusive, of this act become effective on  
19 January 1, 2006.

20 3. Section 29 of this act becomes effective on October 1, 2008.
