**SUMMARY**—Makes various changes relating to Commission for Cultural Affairs. (BDR 18-398)

AN ACT relating to the Commission for Cultural Affairs; authorizing the Commission to reimburse members for certain expenses; increasing the amount of financial assistance that the Commission may grant from the proceeds of certain bonds; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

1 Existing law establishes the Commission for Cultural Affairs, which advises the  
2 Department of Cultural Affairs on matters relating to the preservation and  
3 promotion of Nevada's cultural resources. (NRS 233C.200) Commission members  
4 currently are not entitled to be paid a salary, a per diem allowance or travel  
5 expenses. (NRS 233C.200) The Commission may use the interest earned on money  
6 in the Fund for the Preservation and Promotion of Cultural Resources, which the  
7 Commission administers, to pay for administrative services required by the  
8 Commission. (NRS 233C.200, 233C.230)

9 This bill allows Commission members to receive the same per diem allowance  
10 and travel expenses provided for state officers and employees generally while those  
11 members are attending meetings of the Commission or engaging in other activities  
12 related to the duties of the Commission. The Commission may pay for those  
13 expenses from interest earned on money in the Fund.

14 As part of its duties under existing law, the Commission for Cultural Affairs  
15 awards financial assistance to governmental entities and nonprofit corporations that  
16 are conducting projects that preserve or protect historical buildings that will be used  
17 to develop a network of cultural centers and activities. (NRS 233C.220) This  
18 financial assistance is derived from the proceeds of general obligation bonds issued  
19 by the State and interest earned on the deposit or investment of the money in the

20 Fund for the Preservation and Promotion of Cultural Resources. (NRS 233C.225,  
21 233C.230)

22 This bill increases from \$2 million to \$3 million the maximum amount of such  
23 financial assistance that may be granted by the Commission each year and,  
24 correspondingly, increases from \$20 million to \$30 million the maximum amount  
25 of such financial assistance that the Commission may grant in a 10-year period.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     **Section 1.** NRS 233C.200 is hereby amended to read as  
2 follows:

3     233C.200 1. The Commission for Cultural Affairs is hereby  
4 created. The Commission is advisory to the Department and consists  
5 of:

6         (a) The Chairman of the Nevada Humanities Committee or a  
7 member of the Committee designated by him;

8         (b) The Chairman of the Board or a member of the Board  
9 designated by him;

10         (c) The Chairman of the Board of Museums and History or a  
11 member of the Board *of Museums and History* designated by him;

12         (d) A member of the Board of Museums and History, to be  
13 appointed by the Governor;

14         (e) One representative of the general public who has a working  
15 knowledge of the promotion of tourism in Nevada, to be appointed  
16 by the Governor; and

17         (f) The Chairman of the State Council on Libraries and Literacy  
18 or a member of the Council designated by him.

19         2. The Commission shall:

20             (a) Elect from its membership a Chairman who shall serve for a  
21 term of 2 years. A vacancy occurring in this position must be filled  
22 by election of the members of the Commission for the remainder of  
23 the unexpired term.

24             (b) Prescribe rules for its own management and government.

25             (c) Meet biannually, or at more frequent times if it deems  
26 necessary, and may, within the limitations of its budget, hold special  
27 meetings at the call of its Chairman.

28         3. Three members of the Commission constitute a quorum, but  
29 a majority of the members of the Commission is necessary to  
30 consider the particular business before it and to exercise the power  
31 conferred on the Commission.

32         4. The members of the Commission are not entitled to be paid  
33 a salary ~~for receive reimbursement for~~, *but are entitled, while*  
34 *engaged in the business of the Commission, to receive the* per diem



1    ~~for~~ allowance and travel expenses ~~is~~ provided for state officers  
2    and employees generally.

3    5. The Commission may use the money derived from interest  
4    earned on the money in the Fund for the Preservation and Promotion  
5    of Cultural Resources created pursuant to NRS 233C.230 to pay for:

6    (a) Any administrative services required by the Commission ~~is~~;  
7    and

8    (b) The per diem allowances and travel expenses of members  
9    of the Commission authorized pursuant to subsection 4.

10   **Sec. 2.** NRS 233C.225 is hereby amended to read as follows:

11   233C.225 1. The Commission shall determine annually the  
12 total amount of financial assistance it will grant from the proceeds  
13 of bonds issued pursuant to this section in that calendar year  
14 pursuant to NRS 233C.200 to 233C.230, inclusive. The Commission  
15 shall notify the State Board of Examiners and the State Board of  
16 Finance of that amount. In no case may the amount to be granted  
17 from the proceeds of such bonds exceed ~~\$2,000,000~~ \$3,000,000  
18 per year.

19   2. After receiving the notice given pursuant to subsection 1, the  
20 State Board of Finance shall issue general obligation bonds of the  
21 State of Nevada in the amount necessary to generate the amount to  
22 be granted by the Commission from the proceeds of bonds issued  
23 pursuant to this section and to pay the expenses related to the  
24 issuance of the bonds. The expenses related to the issuance of bonds  
25 pursuant to this section must be paid from the proceeds of the bonds,  
26 and must not exceed 2 percent of the face amount of the bonds sold.  
27 No public debt is created, within the meaning of Section 3 of Article  
28 9 of the Constitution of the State of Nevada, until the issuance of the  
29 bonds.

30   3. The proceeds from the sale of the bonds authorized by this  
31 section, after deducting the expenses relating to the issuance of the  
32 bonds, must be deposited with the State Treasurer and credited to  
33 the Fund for the Preservation and Promotion of Cultural Resources.

34   4. The provisions of the State Securities Law, contained in  
35 chapter 349 of NRS, apply to the issuance of bonds pursuant to this  
36 section.

37   5. The amount of financial assistance granted from the  
38 proceeds of bonds issued pursuant to this section must not exceed  
39 ~~\$20,000,000~~ \$30,000,000 in any 10-year period. The total face  
40 amount of the bonds issued pursuant to this section must not exceed  
41 the sum of:

42    (a) The amount of financial assistance granted pursuant to this  
43 section; and



1       (b) The amount necessary to pay the expenses related to the  
2 issuance of the bonds, which must not exceed 2 percent of the face  
3 amount of the bonds sold.

4       **Sec. 3.** This act becomes effective upon passage and approval.
