

SENATE BILL NO. 458—COMMITTEE ON
HUMAN RESOURCES AND EDUCATION

MARCH 29, 2005

Referred to Committee on Human Resources and Education

SUMMARY—Makes various changes concerning time within which person who is transported to hospital is transferred to place in hospital where he can receive services. (BDR 40-1321)

EXPLANATION – Matter in ***bolded italics*** is new; matter between brackets **[omitted material]** is material to be omitted.

AN ACT relating to health care; requiring a hospital to ensure that certain persons who are transported to the hospital are transferred to an appropriate place in the hospital to receive emergency services and care in a timely manner; requiring the Health Division of the Department of Human Resources to conduct a study concerning the cause of excessive waiting times for a person to receive emergency services and care from a hospital after being transported to the hospital by a provider of emergency medical services; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 450B of NRS is hereby amended by adding
2 thereto a new section to read as follows:

3 **1. *Each hospital in this State which receives a person in need***
4 ***of emergency services and care who has been transported to the***
5 ***hospital by an ambulance, air ambulance or vehicle of a fire-***
6 ***fighting agency that has a permit to operate pursuant to this***
7 ***chapter shall ensure that the person is transferred to a bed, chair,***
8 ***gurney or other appropriate place in the hospital to receive***

1 **emergency services and care as soon as practicable, but not later
2 than 30 minutes after the time at which the person arrives at the
3 hospital.**

4 **2. The Health Division shall adopt regulations concerning
5 the manner in which a hospital and an attendant responsible for
6 the care of a person in need of emergency services and care
7 during transport to the hospital shall determine and track the time
8 at which a person arrives at a hospital and the time at which the
9 person is transferred to an appropriate place in the hospital to
10 receive emergency services and care for the purposes of this
11 section. The regulations must provide that:**

12 **(a) The time at which a person arrives at a hospital is the time
13 at which he is presented to the emergency room of the hospital;
14 and**

15 **(b) The time at which the person is transferred to an
16 appropriate place in the hospital to receive emergency services and
17 care is the time at which the person is physically in that place and
18 the staff of the emergency room of the hospital have received a
19 report concerning the person.**

20 **3. This section does not create a duty of care and is not a
21 ground for civil or criminal liability.**

22 **4. As used in this section:**

23 **(a) "Emergency services and care" has the meaning ascribed
24 to it in NRS 439B.410.**

25 **(b) "Hospital" has the meaning ascribed to it in NRS 449.012.**

26 **Sec. 2. 1. The Health Division of the Department of Human
27 Resources shall conduct a study to identify:**

28 **(a) The causes of excessive waiting time at hospitals for the
29 provision of emergency services and care of persons in need of such
30 services and care who have been transported to the hospital by an
31 ambulance, air ambulance or vehicle of a fire-fighting agency which
32 has a permit to operate pursuant to chapter 450B of NRS; and**

33 **(b) Any corrective actions that may eliminate such excessive
34 waiting times.**

35 **2. Except as otherwise provided in subsection 7, each hospital,
36 each operator of an ambulance or air ambulance and each fire-
37 fighting agency which has a permit to operate pursuant to chapter
38 450B of NRS and which provides transportation for persons in need
39 of emergency services and care to a hospital must:**

40 **(a) Participate in the study conducted by the Health Division
41 pursuant to this section by collecting information concerning the
42 waiting time for the provision of emergency services and care to
43 each person who is transported to a hospital in accordance with the
44 system of tracking such information that is developed by the Health
45 Division pursuant to subsection 3; and**

1 (b) Submit to the Health Division the information which is
2 collected pursuant to paragraph (a).

3 3. For the purpose of collecting data for the study required
4 pursuant to this section, the Health Division shall establish a system
5 of tracking information concerning the waiting times of persons for
6 the provision of emergency services and care at a hospital and the
7 surrounding circumstances for such waiting times each time a
8 person is transported to a hospital by an ambulance, air ambulance
9 or vehicle of a fire-fighting agency. The system of tracking must
10 include, without limitation, an electronic or manual method of
11 tracking, in accordance with the regulations adopted by the Health
12 Division pursuant to section 1 of this act:

13 (a) The time at which a person arrives at the hospital;
14 (b) The time at which the person is transferred to an appropriate
15 place in the hospital to receive emergency services and care;

16 (c) Information relating to the circumstances surrounding the
17 arrival of the person provided by the providers of emergency
18 medical services who transport the person to the hospital and by the
19 personnel of the hospital who are responsible for the care of the
20 person after the person arrives at the hospital, including, without
21 limitation, information concerning the volume of patients at the
22 hospital at the time of arrival, the number of personnel at the
23 hospital available to treat the person and the medical condition of
24 the person at the time of his arrival at the hospital;

25 (d) A unique identifier that is assigned to each transfer of a
26 person to a hospital by an ambulance, air ambulance or vehicle of a
27 fire-fighting agency which allows the transfer to be identified and
28 reviewed; and

29 (e) The names and signatures of the providers of emergency
30 medical services who transport the person to the hospital and of the
31 personnel of the hospital who are responsible for the care of the
32 person after the person arrives at the hospital.

33 4. The Health Division shall ensure that:

34 (a) The information collected pursuant to subsection 3 is
35 available to any person or entity participating in the study; and

36 (b) The system of tracking established pursuant to subsection 3
37 and all other aspects of the study comply with the Health Insurance
38 Portability and Accountability Act of 1996, Public Law 104-191.

39 5. The Health Division shall appoint for each county in which
40 hospitals and providers of emergency medical services are
41 participating in the study conducted by the Division pursuant to this
42 section an advisory committee consisting of the health officer of the
43 county, a representative of each hospital in the county and a
44 representative of each operator of an ambulance or air ambulance
45 and a representative of each fire-fighting agency which has a permit

1 to operate pursuant to chapter 450B of NRS and which provides
2 transportation for persons in need of emergency services and care to
3 hospitals in the county. Each member of the advisory committee
4 serves without compensation and is not entitled to receive a per
5 diem allowance or travel expenses. The advisory committee shall:

6 (a) Review the data which has been collected and submitted to
7 the Health Division concerning the waiting times for the provision
8 of emergency services and care, the manner in which such data was
9 collected and any circumstances surrounding such waiting times;

10 (b) Review each incident in which a person was transferred to an
11 appropriate place in the hospital to receive emergency services and
12 care more than 30 minutes after arriving at the hospital and
13 determine all causes for such a delay; and

14 (c) Submit a report of its findings to the Health Division.

15 6. Each hospital and each operator of an ambulance or air
16 ambulance and each fire-fighting agency which has a permit to
17 operate pursuant to chapter 450B of NRS and which provides
18 transportation for persons in need of emergency services and care to
19 the hospitals in a county whose population is 400,000 or more must
20 participate in the study required pursuant to this section.

21 7. Except as otherwise provided in subsection 8, the hospitals
22 and the providers of emergency medical services which provide
23 transportation for persons in need of emergency services and care to
24 the hospitals in a county whose population is less than 400,000 are
25 not required to participate in the study required pursuant to this
26 section unless the county health officer, each hospital and each
27 operator of an ambulance or air ambulance and each fire-fighting
28 agency which has a permit to operate pursuant to chapter 450B of
29 NRS and which provides transportation for persons in need of
30 emergency services and care to the hospitals in the county agree in
31 writing that the county will participate in the study. The county must
32 submit the written agreement to the Health Division.

33 8. If the Health Division determines that the waiting times for
34 persons transported to a hospital to be transferred to an appropriate
35 place in the hospital to receive emergency care and treatment are
36 excessive in a county whose population is 100,000 or more but less
37 than 400,000 which has not elected to participate in the study in
38 accordance with the provisions set forth in subsection 7, the Health
39 Division may require the county to implement a system of tracking
40 data concerning the extent of waiting times and the circumstances
41 surrounding such waiting times for review by the Health Division in
42 the manner set forth in this section.

43 9. The Health Division shall submit a quarterly report to the
44 Legislative Committee on Health Care concerning its findings
45 pursuant to the study conducted pursuant to this section.

1 10. The Legislative Committee on Health Care shall submit a
2 final report of the results of the study conducted pursuant to this
3 section and any recommendations for legislation to the 74th Session
4 of the Nevada Legislature.

5 11. If only one county participates in the study conducted
6 pursuant to this section, the Health Division may delegate its duties
7 set forth in this section to the county or district board of health of
8 that county.

9 **Sec. 3.** 1. This act becomes effective upon passage and
10 approval for the purpose of adopting regulations and on October 1,
11 2005, for all other purposes.

12 2. Section 2 of this act expires by limitation on December 31,
13 2006.
