SUMMARY—Repeals, reenacts, reorganizes and revises provisions relating to Department of Human Resources and Department of Employment, Training and Rehabilitation. (BDR 38-178)

AN ACT relating to public welfare; repealing, reenacting, reorganizing and revising certain provisions relating to the Welfare Division, the Division of Health Care Financing and Policy and the Division of Child and Family Services of the Department of Human Resources; revising certain provisions relating to property tax assistance for senior citizens; revising certain provisions relating to the Chief Research and Statistical Analyst of the Health Division of the Department of Human Resources; providing that the Director of the Department or his designee is responsible for appointing and removing certain employees of the Department; repealing certain provisions which require the Department of Employment, Training and Rehabilitation to employ job development coordinators to promote employment for persons who receive public assistance; repealing certain provisions concerning community service block grants; transferring certain duties of the Health Division of the Department of Human Resources concerning services for the abuse of alcohol or drugs to the Division of Mental



Health and Developmental Services of the Department; changing the name of the Department of Human Resources to the Department of Health and Human Services; changing the name of the Welfare Division of the Department of Human Resources to the Division of Welfare and Supportive Services of the Department of Health and Human Services; reenacting certain penalties; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Title 38 of NRS is hereby amended by adding
2 thereto a new chapter to consist of the provisions set forth as
3 sections 2 to 97, inclusive, of this act.

4 **Sec. 2.** *As used in this chapter, unless the context otherwise*
5 *requires, the words and terms defined in sections 3 to 19,*
6 *inclusive, of this act have the meanings ascribed to them in those*
7 *sections.*

8 **Sec. 3.** *“Administrator” means the Administrator of the*
9 *Division.*

10 **Sec. 4.** *“Board” means the State Board of Welfare and*
11 *Supportive Services.*

12 **Sec. 5.** *“Children’s Health Insurance Program” means the*
13 *program established pursuant to 42 U.S.C. §§ 1397aa to 1397jj,*
14 *inclusive, to provide health insurance for uninsured children from*
15 *low-income families in this State.*

16 **Sec. 6.** *“Department” means the Department of Health and*
17 *Human Services.*

18 **Sec. 7.** *“Director” means the Director of the Department.*

19 **Sec. 8.** *“Division” means the Division of Welfare and*
20 *Supportive Services of the Department.*

21 **Sec. 9.** *“Division of Health Care Financing and Policy”*
22 *means the Division of Health Care Financing and Policy of the*
23 *Department.*

24 **Sec. 10.** *“Food Stamp Assistance” means the program*
25 *established to provide persons of low income with an opportunity*
26 *to obtain a more nutritious diet through the issuance of coupons*
27 *pursuant to the Food Stamp Act of 1977, 7 U.S.C. §§ 2011 et seq.,*
28 *as amended.*

29 **Sec. 11.** *“Low-Income Home Energy Assistance” means the*
30 *program established to assist persons of low income to meet the*
31 *costs of heating and cooling their homes pursuant to the Low-*
32 *Income Home Energy Assistance Act of 1981, 42 U.S.C. §§ 8621*
33 *et seq., as amended.*



1 **Sec. 12.** *“Medicaid” has the meaning ascribed to it in*
2 *NRS 439B.120.*

3 **Sec. 13.** *“Program for Child Care and Development” means*
4 *the program established to provide assistance for the care and*
5 *development of children pursuant to 42 U.S.C. §§ 9858 et seq.*

6 **Sec. 14.** *“Program for the Enforcement of Child Support”*
7 *means the program established to locate absent parents, establish*
8 *paternity and obtain child support pursuant to Part D of Title IV*
9 *of the Social Security Act, 42 U.S.C. §§ 651 et seq., and other*
10 *provisions of that act relating to the enforcement of child support.*

11 **Sec. 15. 1.** *“Public assistance” includes:*

12 *(a) State Supplemental Assistance;*

13 *(b) Temporary Assistance for Needy Families;*

14 *(c) Medicaid;*

15 *(d) Food Stamp Assistance;*

16 *(e) Low-Income Home Energy Assistance;*

17 *(f) The Program for Child Care and Development;*

18 *(g) Benefits provided pursuant to any other public welfare*
19 *program administered by the Division pursuant to such additional*
20 *federal legislation as is not inconsistent with the purposes of this*
21 *chapter; and*

22 *(h) Benefits provided pursuant to any other public welfare*
23 *program administered by the Division of Health Care Financing*
24 *and Policy of the Department pursuant to chapter 422 of NRS.*

25 **2.** *The term does not include the Children’s Health Insurance*
26 *Program.*

27 **Sec. 16.** *“State Supplementary Assistance” means the*
28 *program established to provide state assistance to aged or blind*
29 *persons in connection with the Supplemental Security Income*
30 *Program.*

31 **Sec. 17.** *“Supplemental Security Income Program” means*
32 *the program established for aged, blind or disabled persons*
33 *pursuant to Title XVI of the Social Security Act, 42 U.S.C. §§ 1381*
34 *et seq., as amended.*

35 **Sec. 18.** *“Temporary Assistance for Needy Families” means*
36 *the program established to provide temporary assistance for needy*
37 *families pursuant to Title IV of the Social Security Act, 42 U.S.C.*
38 *§§ 601 et seq., and other provisions of that act relating to*
39 *temporary assistance for needy families.*

40 **Sec. 19.** *(Deleted by amendment.)*

41 **Sec. 20. 1.** *Notwithstanding any other provision of state or*
42 *local law, a person or governmental entity that provides a state or*
43 *local public benefit:*

44 *(a) Shall comply with the provisions of 8 U.S.C. § 1621*
45 *regarding the eligibility of an alien for such a benefit.*



1 ***(b) Is not required to pay any costs or other expenses relating***
2 ***to the provision of such a benefit after July 1, 1997, to an alien***
3 ***who, pursuant to 8 U.S.C. § 1621, is not eligible for the benefit.***

4 ***2. Compliance with the provisions of 8 U.S.C. § 1621 must***
5 ***not be construed to constitute any form of discrimination,***
6 ***distinction or restriction made, or any other action taken, on the***
7 ***basis of national origin.***

8 ***3. As used in this section, "state or local public benefit" has***
9 ***the meaning ascribed to it in 8 U.S.C. § 1621.***

10 ***Sec. 21. The State Board of Welfare and Supportive Services,***
11 ***consisting of seven members appointed by the Governor, is hereby***
12 ***created within the Division.***

13 ***Sec. 22. 1. The Governor shall appoint members who have***
14 ***an interest in and a knowledge of the field of public welfare.***

15 ***2. Members of the Board must be selected to give statewide***
16 ***representation, and not more than three members may be residents***
17 ***of the same county.***

18 ***3. Members of the Board may be removed for failure to***
19 ***attend Board meetings.***

20 ***Sec. 23. 1. The members of the Board shall meet at least***
21 ***twice each calendar year to consider any issues related to public***
22 ***assistance and other programs for which the Division is***
23 ***responsible that may be of importance to members of the general***
24 ***public, the Governor or the Division, at such places as the Board,***
25 ***the Chairman of the Board, the Administrator or the Director***
26 ***deems appropriate.***

27 ***2. Four members of the Board constitute a quorum, and a***
28 ***quorum may exercise all the power and authority conferred on the***
29 ***Board.***

30 ***3. The Board shall:***

31 ***(a) At least 14 days before the date it holds a meeting, provide***
32 ***public notice of the date, time and location of the meeting, in***
33 ***addition to the notice required pursuant to NRS 241.020.***

34 ***(b) Keep minutes of all meetings of the Board, which must***
35 ***include records of testimony and written comments presented to***
36 ***the Board, and file the minutes with the Division. The minutes***
37 ***must be maintained as public records.***

38 ***Sec. 24. 1. At the first meeting after the adjournment of***
39 ***any regular session of the Legislature, the Board shall elect from***
40 ***its members a Chairman and Vice Chairman. The terms of the***
41 ***offices of Chairman and Vice Chairman expire upon the election***
42 ***of a Chairman and Vice Chairman at the first meeting following***
43 ***the adjournment of the next regular session of the Legislature.***

44 ***2. If a vacancy occurs in the office of Chairman, the Vice***
45 ***Chairman shall assume the duties of Chairman for the unexpired***



1 *term. If a vacancy occurs in the office of Vice Chairman, the*
2 *Board shall, at its next meeting, fill the vacancy for the unexpired*
3 *term.*

4 *3. The Administrator shall act as the nonvoting recording*
5 *Secretary.*

6 **Sec. 25.** *1. For each day's attendance at each meeting of*
7 *the Board, each member of the Board is entitled to receive a salary*
8 *of not more than \$80 per day, as fixed by the Board.*

9 *2. While engaged in the business of the Board, each member*
10 *and employee of the Board is entitled to receive the per diem*
11 *allowance and travel expenses provided for state officers and*
12 *employees generally.*

13 **Sec. 26.** *1. The Board has only those powers and duties*
14 *authorized by law.*

15 *2. The Board shall:*

16 *(a) Adopt regulations for its own management and*
17 *government.*

18 *(b) Not later than 90 days after the date it holds a meeting,*
19 *advise the Legislature, if it is in regular session, the Governor, the*
20 *Director and the Division, based upon any testimony, written*
21 *comments and other matters considered at the meeting, of any*
22 *recommendations of the Board for legislation or other action*
23 *relating to the administration of public assistance and other*
24 *programs for which the Division is responsible.*

25 **Sec. 27.** *The Administrator must:*

26 *1. Be selected on the basis of his training, experience,*
27 *capacity and interest in public welfare services.*

28 *2. Be a graduate in public or business administration from an*
29 *accredited college or university.*

30 *3. Have not less than 3 years of demonstrated successful*
31 *experience in public welfare administration, with responsibility for*
32 *general direction and determination of a policy of a general*
33 *assistance and social service program, or any equivalent*
34 *combination of training and experience.*

35 *4. Possess qualities of leadership in the field of human*
36 *welfare and health.*

37 **Sec. 28.** *The Administrator:*

38 *1. Shall serve as the Executive Officer of the Division.*

39 *2. Shall establish policies for the administration of the*
40 *programs of the Division and shall administer all activities and*
41 *services of the Division in accordance with those policies and any*
42 *regulations of the Administrator, subject to administrative*
43 *supervision by the Director.*

44 *3. Is responsible for the management of the Division.*



Sec. 29. The Administrator shall make:

1. Such reports, subject to approval by the Director, as will comply with the requirements of federal legislation and this chapter.

2. Reports to the Board.

3. A biennial report to the Director on the condition, operation and functioning of the Division.

Sec. 30. The Administrator:

1. Is responsible for and shall supervise the fiscal affairs and responsibilities of the Division, subject to administrative supervision by the Director.

2. Shall present the biennial budget of the Division to the Legislature in conjunction with the Budget Division of the Department of Administration.

3. Shall allocate, in the interest of efficiency and economy, the State's appropriation for the administration of each program for which the Division is responsible, subject to administrative supervision by the Director.

Sec. 31. The Administrator:

1. May establish, consolidate and abolish sections within the Division.

2. Shall organize the Division to comply with the requirements of this chapter and with the standards required by federal legislation, subject to approval by the Director.

3. Shall appoint the heads of the sections of the Division.

4. May employ such assistants and employees as may be necessary for the efficient operation of the Division.

5. Shall set standards of service.

Sec. 32. 1. *The Administrator or his designated representative may administer oaths and take testimony thereunder and issue subpoenas requiring the attendance of witnesses before the Division at a designated time and place and the production of books, papers and records relative to eligibility or continued eligibility for public assistance.*

2. The Director or his designated representative may administer oaths and take testimony thereunder and issue subpoenas requiring the attendance of witnesses before the Department at a designated time and place and the production of books, papers and records relative to verification of treatment and payments to a provider of medical care, remedial care or other services pursuant to the State Plan for Medicaid.

3. If a witness fails to appear or refuses to give testimony or to produce books, papers and records as required by a subpoena issued pursuant to this section, the district court of the county in which the investigation is being conducted may compel the



1 *attendance of the witness, the giving of testimony and the*
2 *production of books, papers and records as required by the*
3 *subpoena.*

4 **Sec. 33.** *The Administrator may adopt such regulations as*
5 *are necessary for the administration of this chapter and any*
6 *program of the Division.*

7 **Sec. 34.** *1. Before adopting, amending or repealing any*
8 *regulation for the administration of a program of public*
9 *assistance or any other program for which the Division is*
10 *responsible, the Administrator must give at least 30 days' notice of*
11 *his intended action.*

12 *2. The notice of intent to act upon a regulation must:*

13 *(a) Include a statement of the need for and purpose of the*
14 *proposed regulation, and either the terms or substance of the*
15 *proposed regulation or a description of the subjects and issues*
16 *involved, and of the time when, the place where and the manner in*
17 *which, interested persons may present their views thereon.*

18 *(b) Include a statement identifying the entities that may be*
19 *financially affected by the proposed regulation and the potential*
20 *financial impact, if any, upon local government.*

21 *(c) State each address at which the text of the proposed*
22 *regulation may be inspected and copied.*

23 *(d) Be mailed to all persons who have requested in writing that*
24 *they be placed upon a mailing list, which must be kept by the*
25 *Administrator for that purpose.*

26 *3. All interested persons must be afforded a reasonable*
27 *opportunity to submit data, views or arguments upon a proposed*
28 *regulation, orally or in writing. The Administrator shall consider*
29 *fully all oral and written submissions relating to the proposed*
30 *regulation.*

31 *4. The Administrator shall keep, retain and make available*
32 *for public inspection written minutes of each public hearing held*
33 *pursuant to this section in the manner provided in subsections 1*
34 *and 2 of NRS 241.035.*

35 *5. The Administrator may record each public hearing held*
36 *pursuant to this section and make those recordings available for*
37 *public inspection in the manner provided in subsection 4 of*
38 *NRS 241.035.*

39 *6. No objection to any regulation on the ground of*
40 *noncompliance with the procedural requirements of this section*
41 *may be made more than 2 years after its effective date.*

42 **Sec. 35.** *The Administrator shall:*

43 *1. Supply the Director with material on which to base*
44 *proposed legislation.*



1 2. *Cooperate with the Federal Government and state*
2 *governments for the more effective attainment of the purposes of*
3 *this chapter.*

4 3. *Coordinate the activities of the Division with other*
5 *agencies, both public and private, with related or similar activities.*

6 4. *Keep a complete and accurate record of all proceedings,*
7 *record and file all bonds and contracts, and assume responsibility*
8 *for the custody and preservation of all papers and documents*
9 *pertaining to his office.*

10 5. *Inform the public in regard to the activities and operation*
11 *of the Division, and provide other information which will acquaint*
12 *the public with problems relating to welfare.*

13 6. *Conduct studies into the causes of the social problems with*
14 *which the Division is concerned.*

15 7. *Provide leadership in the community in order that all*
16 *welfare activities are pointed toward the single goal of improving*
17 *the public welfare.*

18 8. *Invoke any legal, equitable or special procedures for the*
19 *enforcement of his orders or the enforcement of the provisions of*
20 *this chapter.*

21 9. *Exercise any other powers that are necessary and proper*
22 *for the standardization of state work, to expedite business, to*
23 *ensure fair consideration of applications for aid and to promote*
24 *the efficiency of the service provided by the Division.*

25 **Sec. 36.** *The Administrator and the Division shall administer*
26 *the provisions of this chapter, subject to administrative supervision*
27 *by the Director.*

28 **Sec. 37.** 1. *Any gifts or grants of money which the Division*
29 *is authorized to accept must be deposited in the State Treasury to*
30 *the credit of the Division of Welfare and Supportive Services' Gift*
31 *and Cooperative Account in the Department of Health and*
32 *Human Services' Gift Fund.*

33 2. *Money in the Account must be used for welfare purposes*
34 *only and expended in accordance with the terms of the gift or*
35 *grant.*

36 3. *All claims must be approved by the Administrator before*
37 *they are paid.*

38 **Sec. 38.** 1. *Money to carry out the provisions of this*
39 *chapter, including, without limitation, any federal money allotted*
40 *to the State of Nevada pursuant to the program to provide*
41 *Temporary Assistance for Needy Families and the Program for*
42 *Child Care and Development, must be provided by appropriation*
43 *by the Legislature from the State General Fund.*



1 2. Disbursements for the purposes of this chapter must be
2 made upon claims duly filed and allowed in the same manner as
3 other money in the State Treasury is disbursed.

4 **Sec. 39.** Any federal money allotted to the State of Nevada
5 for public assistance programs and other programs for which the
6 Division is responsible and such other money as may be received
7 by the State for such purposes must, except as otherwise provided
8 in NRS 425.363, be deposited in the appropriate accounts of the
9 Division in the State General Fund.

10 **Sec. 40.** 1. The State of Nevada assents to the purposes of
11 the Act of Congress of the United States entitled the "Social
12 Security Act," approved August 14, 1935, and assents to such
13 additional federal legislation as is not inconsistent with the
14 purposes of this chapter and NRS 432.010 to 432.085, inclusive,
15 and sections 154 to 163.8, inclusive, of this act.

16 2. The State of Nevada further accepts, with the approval of
17 the Governor, the appropriations of money by Congress in
18 pursuance of the Social Security Act and authorizes the receipt of
19 such money into the State Treasury for the use of the Department
20 in accordance with this chapter, NRS 432.010 to 432.085,
21 inclusive, sections 154 to 163.8, inclusive, of this act and the
22 conditions imposed by the Social Security Act.

23 3. The State of Nevada may accept, with the approval of the
24 Governor, any additional funds which may become or are made
25 available for extension of programs and services administered by
26 the Department under the provisions of the Social Security Act.
27 Such money must be deposited in the State Treasury for the use of
28 the Department in accordance with this chapter, NRS 432.010 to
29 432.085, inclusive, sections 154 to 163.8, inclusive, of this act and
30 the conditions and purposes under which granted by the Federal
31 Government.

32 **Sec. 41.** If Congress passes any law increasing the
33 participation of the Federal Government in a Nevada program for
34 public assistance, whether relating to eligibility for assistance or
35 otherwise:

36 1. The Director may accept, with the approval of the
37 Governor, the increased benefits of such congressional legislation;
38 and

39 2. The Administrator may adopt any regulations required by
40 the Federal Government as a condition of acceptance.

41 **Sec. 42.** The Director shall have the power to sign and
42 execute, in the name of the State, by "The Department of Health
43 and Human Services," any contract or agreement with the Federal
44 Government or its agencies.



Sec. 43. The Department shall:

1. Administer all public welfare programs of this State, including:

- (a) State Supplementary Assistance;**
- (b) Temporary Assistance for Needy Families;**
- (c) Medicaid;**
- (d) Food Stamp Assistance;**
- (e) Low-Income Home Energy Assistance;**
- (f) The Program for Child Care and Development;**
- (g) The Program for the Enforcement of Child Support;**
- (h) The Children's Health Insurance Program; and**
- (i) Other welfare activities and services provided for by the laws of this State.**

2. Act as the single state agency of the State of Nevada and its political subdivisions in the administration of any federal money granted to the State of Nevada to aid in the furtherance of any of the services and activities set forth in subsection 1.

3. Cooperate with the Federal Government in adopting state plans, in all matters of mutual concern, including adoption of methods of administration found by the Federal Government to be necessary for the efficient operation of welfare programs, and in increasing the efficiency of welfare programs by prompt and judicious use of new federal grants which will assist the Department in carrying out the provisions of this chapter.

4. Observe and study the changing nature and extent of welfare needs and develop through tests and demonstrations effective ways of meeting those needs and employ or contract for personnel and services supported by legislative appropriations from the State General Fund or money from federal or other sources.

5. Enter into reciprocal agreements with other states relative to public assistance, welfare services and institutional care, when deemed necessary or convenient by the Director.

6. Make such agreements with the Federal Government as may be necessary to carry out the Supplemental Security Income Program.

Sec. 44. 1. The Director shall adopt each state plan required by the Federal Government, either directly or as a condition to the receipt of federal money, for the administration of any public assistance or other program for which the Division is responsible. Such a plan must set forth, regarding the particular program to which the plan applies:

- (a) The requirements for eligibility;**
- (b) The nature and amounts of grants and other assistance which may be provided;**



1 (c) *The conditions imposed; and*

2 (d) *Such other provisions relating to the development and*
3 *administration of the program as the Director deems necessary.*

4 2. *In developing and revising such a plan, the Director shall*
5 *consider, among other things:*

6 (a) *The amount of money available from the Federal*
7 *Government;*

8 (b) *The conditions attached to the acceptance of that money;*
9 *and*

10 (c) *The limitations of legislative appropriations and*
11 *authorizations,*

12 *↳ for the particular program to which the plan applies.*

13 3. *The Division shall make available to members of the*
14 *general public a summary of the State Plan for Temporary*
15 *Assistance for Needy Families established pursuant to this section.*

16 4. *The Division shall comply with each state plan adopted*
17 *pursuant to this section.*

18 **Sec. 45.** 1. *The Department shall provide public assistance*
19 *pursuant to:*

20 (a) *The program established to provide Temporary Assistance*
21 *for Needy Families;*

22 (b) *Medicaid; or*

23 (c) *Any program for which a grant has been provided to this*
24 *State pursuant to 42 U.S.C. §§ 1397 et seq.,*

25 *↳ to a qualified alien who complies with the requirements*
26 *established by the Department pursuant to federal law and this*
27 *chapter for the receipt of benefits pursuant to that program.*

28 2. *As used in this section, "qualified alien" has the meaning*
29 *ascribed to it in 8 U.S.C. § 1641.*

30 **Sec. 46.** *The Attorney General and his deputies are the legal*
31 *advisers for the Division.*

32 **Sec. 47.** 1. *Subject to the provisions of subsection 2, if an*
33 *application for public assistance or claim for services is not acted*
34 *upon by the Department within a reasonable time after the filing*
35 *of the application or claim for services, or is denied in whole or in*
36 *part, or if any grant of public assistance or claim for services is*
37 *reduced, suspended or terminated, the applicant for or recipient of*
38 *public assistance or services may appeal to the Department and*
39 *may be represented in the appeal by counsel or by another*
40 *representative of his choice.*

41 2. *Upon the initial decision to deny, reduce, suspend or*
42 *terminate public assistance or services, the Department shall*
43 *notify that applicant or recipient of its decision, the regulations*
44 *involved and his right to request a hearing within a certain period.*
45 *If a request for a hearing is received within that period, the*



1 *Department shall notify that person of the time, place and nature*
2 *of the hearing. The Department shall provide an opportunity for a*
3 *hearing of that appeal and shall review his case regarding all*
4 *matters alleged in that appeal.*

5 *3. The Department is not required to grant a hearing*
6 *pursuant to this section if the request for the hearing is based*
7 *solely upon the provisions of a federal law or a law of this State*
8 *that requires an automatic adjustment to the amount of public*
9 *assistance or services that may be received by an applicant or*
10 *recipient.*

11 **Sec. 48.** *1. At any hearing held pursuant to the provisions*
12 *of subsection 2 of section 47 of this act, opportunity must be*
13 *afforded all parties to respond and present evidence and argument*
14 *on all issues involved.*

15 *2. Unless precluded by law, informal disposition may be made*
16 *of any hearing by stipulation, agreed settlement, consent order or*
17 *default.*

18 *3. The record of a hearing must include:*

19 *(a) All pleadings, motions and intermediate rulings.*

20 *(b) Evidence received or considered.*

21 *(c) Questions and offers of proof and objections, and rulings*
22 *thereon.*

23 *(d) Any decision, opinion or report by the hearing officer*
24 *presiding at the hearing.*

25 *4. Oral proceedings, or any part thereof, must be transcribed*
26 *on request of any party seeking judicial review of the decision.*

27 *5. Findings of fact must be based exclusively on substantial*
28 *evidence.*

29 *6. Any employee or other representative of the Department*
30 *who investigated or made the initial decision to deny, modify or*
31 *cancel a grant of public assistance or services shall not participate*
32 *in the making of any decision made pursuant to the hearing.*

33 **Sec. 49.** *In any hearing held pursuant to the provisions of*
34 *subsection 2 of section 47 of this act:*

35 *1. Irrelevant, immaterial or unduly repetitious evidence must*
36 *be excluded. Unless it is privileged pursuant to chapter 49 of NRS,*
37 *evidence, including, without limitation, hearsay, may be admitted*
38 *if it is of a type commonly relied upon by reasonable and prudent*
39 *persons in the conduct of their affairs. Objections to evidentiary*
40 *offers may be made. Subject to the requirements of this subsection,*
41 *if a hearing will be expedited and the interests of the parties will*
42 *not be prejudiced substantially, any part of the evidence may be*
43 *received in written form.*



2. *Documentary evidence may be received in the form of copies or excerpts. Upon request, parties must be given an opportunity to compare the copy with the original.*

3. *Each party may call and examine witnesses, introduce exhibits, cross-examine opposing witnesses on any matter relevant to the issues whether or not the matter was covered in the direct examination, impeach any witness, regardless of which party first called him to testify, and rebut the evidence against him.*

Sec. 50. *Any person who is:*

1. *The subject of a hearing conducted under the authority of the Division; or*

2. *A witness at that hearing, and who is a person with a disability as defined in NRS 50.050, is entitled to the services of an interpreter at public expense, subject to the provisions of NRS 50.052 and 50.053. The interpreter must be qualified to engage in the practice of interpreting in this State pursuant to subsection 2 of NRS 656A.100 and must be appointed by the person who presides at the hearing.*

Sec. 51. 1. *A decision or order issued by a hearing officer must be in writing. A final decision must include findings of fact and conclusions of law, separately stated. Findings of fact, if set forth in statutory or regulatory language, must be accompanied by a concise and explicit statement of the underlying facts supporting the findings. A copy of the decision or order must be delivered by certified mail to each party and to his attorney or other representative.*

2. *The Department or an applicant for or recipient of public assistance or services may, at any time within 90 days after the date on which the written notice of the decision is mailed, petition the district court of the judicial district in which the applicant for or recipient of public assistance or services resides to review the decision. The district court shall review the decision on the record of the case before the hearing officer. The decision and record must be certified as correct and filed with the clerk of the court by the Department.*

21 (c) *Made upon unlawful procedure;*

22 (d) *Affected by other error of law;*

23 (e) *Clearly erroneous in view of the reliable, probative and*
24 *substantial evidence on the whole record; or*

25 (f) *Arbitrary or capricious or characterized by abuse of*
26 *discretion or clearly unwarranted exercise of discretion.*

27 4. *An aggrieved party may obtain review of any final*
28 *judgment of the district court by appeal to the Supreme Court. The*
29 *appeal must be taken in the manner provided for civil cases.*

30 **Sec. 53.** *To ensure accuracy, uniformity and completeness in*
31 *statistics and information, the Division may prescribe forms of*
32 *reports and records to be kept by all persons, associations or*
33 *institutions, subject to its supervision or investigation, and each*
34 *such person, association or institution shall keep such records and*
35 *render such reports in the form so prescribed.*

36 **Sec. 54.** *As a part of the health and welfare programs of this*

6 2. *A head of a household may not claim the exemption*
7 *prescribed in subparagraph (4) of paragraph (a) of subsection 1*
8 *for more than 12 months during his lifetime, regardless of*
9 *whether those months are consecutive or cumulative.*

10 3. *The Division shall not exempt a head of a household*
11 *pursuant to this section if the exemption would violate a*
12 *requirement of federal law or a condition to the receipt of federal*
13 *money.*

14 **Sec. 86.** 1. *Except as otherwise provided in this section:*

15 (a) *If the Division determines that the head of a household has*
16 *not complied with the terms of the plan for personal responsibility*
17 *signed by the head of the household pursuant to section 81 of this*
18 *act or the agreement of cooperation signed by the head of the*
19 *household pursuant to section 82 of this act, the Division shall*
20 *notify him that if his failure to comply does not cease within 30*
