AN ACT making an appropriation to the Department of Cultural Affairs for the purchase of state artifacts; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1       **Section 1.** There is hereby appropriated from the State  
2 General Fund to the Department of Cultural Affairs the sum of  
3 \$1,571,125 for the purchase of state artifacts. The money  
4 appropriated must be allocated as follows:

5       For the Nevada State Railroad Museum at  
6       Boulder City to transport the GE 80 ton  
7       Center Cab locomotive from the Nevada  
8       Test Site to the Boulder City Railroad  
9       Museum.....\$15,000  
10      For the Nevada Historical Society in Reno to  
11       purchase the Grosh Papers .....\$160,000  
12      For the Nevada State Railroad Museum in  
13       Carson City to purchase, transport and repair  
14       the Virginia City Steam Locomotive .....\$70,000  
15      For the Nevada State Museum in Carson City to  
16       purchase:  
17       The John Falkowski Mining Equipment  
18       Collection .....\$19,125

2                   For the Nevada State Museum and Historical

13               **Sec. 2.** Any remaining balance of the appropriation made by

17               **Sec. 3.** This act becomes effective upon passage and approval.
