**SUMMARY**—Authorizes creation of Rural Nevada Legal Services Corps within William S. Boyd School of Law. (BDR 34-184)

AN ACT relating to legal services; authorizing the William S. Boyd School of Law of the University of Nevada, Las Vegas, to create a Rural Nevada Legal Services Corps to encourage attorneys to practice in legally underserved areas of the State and to establish and administer a program of repayment of loans for such attorneys; creating the Account for Rural Legal Services; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

Existing law creates various programs to encourage certain professionals to seek employment in certain areas of the State which are underserved by that type of professional. For example, the Nevada Health Service Corps recruits certain licensed medical professionals to serve in underserved areas of the State and administers a program under which money for loans is repaid on behalf of those professionals for each year the professional practices in an area of Nevada in which there is a shortage of that type of professional. (NRS 396.899-396.903)

This bill authorizes the William S. Boyd School of Law of the University of Nevada, Las Vegas, to establish a Rural Nevada Legal Services Corps to encourage attorneys to practice in areas of the State which are designated to be legally underserved. This bill requires the Rural Nevada Legal Services Corps to recruit attorneys and to match attorneys with those areas designated as legally

13 underserved. This bill further authorizes the Rural Nevada Legal Services Corps to  
14 establish and administer a program under which money for loans is repaid on behalf  
15 of an attorney who practices law in a legally underserved area. The Rural Nevada  
16 Legal Services Corps is required to submit a report to the Governor and the  
17 Legislature before each legislative session outlining its transactions and making any  
18 recommendations for legislative action deemed advisable.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1       **Section 1.** Chapter 396 of NRS is hereby amended by adding  
2 thereto the provisions set forth as sections 2 to 11, inclusive, of this  
3 act.

4       **Sec. 2.** *As used in sections 2 to 11, inclusive, of this act,  
5 unless the context otherwise requires, the words and terms defined  
6 in sections 3 to 7, inclusive, of this act have the meanings ascribed  
7 to them in those sections.*

8       **Sec. 3.** *“Account” means the Account for Rural Legal  
9 Services created by section 10 of this act.*

10      **Sec. 4.** *“Boyd School of Law” means the William S. Boyd  
11 School of Law at the University of Nevada, Las Vegas.*

12      **Sec. 5.** *“Legally underserved area” means an area of rural  
13 Nevada that is designated as legally underserved pursuant to  
14 section 8 of this act.*

15      **Sec. 6.** *“Practitioner” means a person who is:*

16       **1.** *An attorney licensed and admitted to practice law in the  
17 courts of this State; and*

18       **2.** *In good standing as a member of the State Bar of Nevada.*

19      **Sec. 7.** *“Program” means the program established and  
20 administered by the Rural Nevada Legal Services Corps pursuant  
21 to section 9 of this act.*

22      **Sec. 8. 1.** *The Boyd School of Law may establish a Rural  
23 Nevada Legal Services Corps to encourage practitioners to  
24 practice law in legally underserved areas of rural Nevada.*

25       **2.** *The primary purposes of the Rural Nevada Legal Services  
26 Corps must be to:*

27           **(a)** *Designate as legally underserved areas of rural Nevada  
28 that it determines to be legally underserved;*

29           **(b)** *Recruit practitioners for participation in the program; and*

30           **(c)** *Match practitioners with areas designated as legally  
31 underserved.*

32      **Sec. 9. 1.** *The Boyd School of Law shall authorize the  
33 Rural Nevada Legal Services Corps to establish and administer a  
34 program under which money for loans is repaid on behalf of a*

1      *practitioner for each year that the practitioner practices law in a  
2      legally underserved area.*

3      2. *The Rural Nevada Legal Services Corps shall:*

4      (a) *Establish and administer the program; and*

5      (b) *Carry out the purposes and duties set forth in sections 2 to  
6      11, inclusive, of this act.*

7      3. *The Rural Nevada Legal Services Corps may:*

8      (a) *Apply for any grants or matching money available for the  
9      program from the Federal Government.*

10     (b) *Solicit and accept gifts, grants and donations from any  
11     source.*

12     (c) *Adopt any regulations necessary to carry out the provisions  
13     of sections 2 to 11, inclusive, of this act.*

14     Sec. 10. 1. *There is hereby created the Account for Rural  
15     Legal Services in the State General Fund.*

16     2. *The Account must be administered by the Rural Nevada  
17     Legal Services Corps.*

18     3. *All money received by the Rural Nevada Legal Services  
19     Corps pursuant to sections 2 to 11, inclusive, of this act, including,  
20     without limitation, all money received from gifts, grants,  
21     donations, the Federal Government or any other source, must be  
22     deposited into the Account.*

23     4. *The interest and income earned on the money in the  
24     Account, after deducting any applicable charges, must be credited  
25     to the Account.*

26     5. *The money in the Account must be used solely to:*

27     (a) *Defray the costs and expenses of the Boyd School of Law  
28     and the Rural Nevada Legal Services Corps related to carrying out  
29     and administering the provisions of the program; and*

30     (b) *Repay the loans of practitioners who are participating in  
31     the program.*

32     Sec. 11. 1. *The Rural Nevada Legal Services Corps shall  
33     keep accurate records of its activities and shall report those  
34     activities to the Governor and the Legislature before September 1  
35     of any year preceding a regular session of the Legislature, setting  
36     forth in detail the transactions conducted by the Rural Nevada  
37     Legal Services Corps during the biennium ending June 30 of such  
38     a year.*

39     2. *The Rural Nevada Legal Services Corps may make  
40     recommendations for any legislative action deemed to be  
41     advisable, including, without limitation, amendments to any  
42     statutes that may be necessary or appropriate to carry out the  
43     intent and purposes of sections 2 to 11, inclusive, of this act.*
