AN ACT relating to public lands; clarifying the authority of the Legislative Committee on Public Lands to review and comment on certain matters relating to public lands; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law establishes the powers and duties of the Legislative Committee on
2 Public Lands. (NRS 218.5367)
3 This bill authorizes the Committee to review and comment on any matter
4 relating to the preservation, conservation, use, management or disposal of public
5 lands, which the Chairman of the Committee or a majority of the members of the
6 Committee considers appropriate.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 218.5367 is hereby amended to read as
2 follows:
3 218.5367 1. The Committee may:
4 (a) Review and comment on any administrative policy, rule or
5 regulation of the:

1 (1) Secretary of the Interior which pertains to policy
2 concerning or management of public lands under the control of the
3 Federal Government; and

4 (2) Secretary of Agriculture which pertains to policy
5 concerning or management of national forests;

6 (b) Conduct investigations and hold hearings in connection with
7 its review, including , but not limited to , investigating the effect on
8 the State, its citizens, political subdivisions, businesses and
9 industries of those policies, rules, regulations and related laws;

10 (c) Consult with and advise the State Land Use Planning
11 Agency on matters concerning federal land use, policies and
12 activities in this State;

13 (d) Direct the Legislative Counsel Bureau to assist in its
14 research, investigations, review and comment;

15 (e) Recommend to the Legislature as a result of its review any
16 appropriate state legislation or corrective federal legislation;

17 (f) Advise the Attorney General if it believes that any federal
18 policy, rule or regulation which it has reviewed encroaches on the
19 sovereignty respecting land or water or their use which has been
20 reserved to the State pursuant to the Constitution of the United
21 States;

22 (g) Enter into a contract for consulting services for land
23 planning and any other related activities, including, but not limited
24 to:

25 (1) Advising the Committee and the State Land Use Planning
26 Agency concerning the revision of the plans pursuant to
27 NRS 321.7355;

28 (2) Assisting local governments in the identification of lands
29 administered by the Federal Government in this State which are
30 needed for residential or economic development or any other
31 purpose; and

32 (3) Assisting local governments in the acquisition of federal
33 lands in this State; ~~and~~

34 (h) Apply for any available grants and accept any gifts, grants or
35 donations to ~~aid~~ assist the committee in carrying out its duties ~~;~~
36 *and*

37 *(i) Review and comment on any other matter relating to the
38 preservation, conservation, use, management or disposal of public
39 lands deemed appropriate by the Chairman of the Committee or by
40 a majority of the members of the Committee.*

41 2. Any reference in this section to federal policies, rules,
42 regulations and related federal laws includes those which are
43 proposed as well as those which are enacted or adopted.
