SUMMARY—Makes supplemental appropriation to Department of Corrections for unanticipated operating, maintenance, inmate-driven expenses and utilities for Fiscal Year 2004-2005 and for expenses for services relating to takeover of Southern Nevada Women’s Correctional Facility for Fiscal Year 2004-2005. AN ACT making a supplemental appropriation to the Department of Corrections for unanticipated operating, maintenance, inmate-driven expenses and utilities for the Fiscal Year 2004-2005 and for expenses for services relating to the takeover of the Southern Nevada Women’s Correctional Facility for the Fiscal Year 2004-2005; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** 1. There is hereby appropriated from the State
2 General Fund to the Department of Corrections the sum of
3 \$3,719,069 to be allocated as follows:
