SUMMARY—Provides additional benefits to members of the Nevada National Guard and their dependents under certain circumstances. (BDR 34-835)

AN ACT relating to the state militia; providing that the Board of Regents of the University of Nevada may grant a waiver of certain fees for the dependents of a person who was killed while he was performing his duties as a member of the Nevada National Guard; authorizing payments for courses on reintegration to certain members of the Nevada National Guard; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

- 1 Existing law authorizes the Board of Regents of the University of Nevada to
2 waive certain fees for a member of the Nevada National Guard or a recruit for the
3 Nevada National Guard. (NRS 396.544) Additionally, existing law requires the
4 Board of Regents to pay certain fees for the dependent child of a police officer,
5 firefighter, officer of the Nevada Highway Patrol or volunteer ambulance driver or
6 attendant killed while performing his duties. (NRS 396.545) **Section 1** of this bill
7 authorizes the Board of Regents to waive certain fees for any dependent of a person
8 who was killed while he was performing his duties as a member of the Nevada
9 National Guard.
- 10 Existing law authorizes the payment of various benefits to members of the
11 Nevada National Guard from the Patriot Relief Account. (NRS 412.1435) **Section 2**
12 of this bill authorizes payment of \$100 from that account to certain members of the

13 Nevada National Guard to attend a class on reintegrating into society after leaving
14 active service.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 396 of NRS is hereby amended by adding
2 thereto a new section to read as follows:

3 **1. *The Board of Regents may grant a waiver of registration***
4 ***fees and laboratory fees for any dependent of a person who was***
5 ***killed while he was performing his duties as a member of the***
6 ***Nevada National Guard. For the purpose of assessing fees and***
7 ***charges against a person to whom such a waiver is granted,***
8 ***including, without limitation, tuition charges pursuant to NRS***
9 ***396.540, the person shall be deemed to be a bona fide resident of***
10 ***this State.***

11 **2. *To be eligible for a waiver pursuant to subsection 1, a***
12 ***person must maintain at least a 2.0 grade point average, on a 4.0***
13 ***grading scale, each semester, or the equivalent of a 2.0 grade point***
14 ***average if a different grading scale is used.***

15 **3. *The Board of Regents may request the Adjutant General to***
16 ***verify that a person is the dependent of a person who was killed***
17 ***while he was performing his duties as a member of the Nevada***
18 ***National Guard. The Adjutant General shall, upon receiving such***
19 ***a request, notify the Board of Regents in writing concerning the***
20 ***status of that person.***

21 **Sec. 2.** NRS 412.1435 is hereby amended to read as follows:

22 412.1435 1. The Patriot Relief Account is hereby created as a
23 special account in the State General Fund.

24 2. The money in the Patriot Relief Account does not lapse to
25 the State General Fund at the end of any fiscal year. The interest and
26 income earned on the money in the Patriot Relief Account, after
27 deducting any applicable charges, must be credited to the Account.
28 All claims against the Patriot Relief Account must be paid as other
29 claims against the State are paid.

30 3. The Office may accept gifts, grants and donations from any
31 source for deposit in the Patriot Relief Account.

32 4. The money in the Patriot Relief Account may only be used
33 to provide:

34 (a) Reimbursement to members of the Nevada National Guard
35 for the cost of:

36 (1) Premiums on a policy of group life insurance purchased
37 pursuant to the provisions of 38 U.S.C. §§ 1965 et seq.; and



1 (2) Textbooks required for a course of study in which the
2 member is enrolled at an institution within the Nevada System of
3 Higher Education; ~~and~~

4 (b) Monetary relief from economic hardships experienced by members
5 of the Nevada National Guard who have been called into active service ~~;~~
6 ; and

7 (c) *A payment of \$100 to a member of the Nevada National*
8 *Guard who leaves active service if:*

9 (1) *The member was on active service in full-time National*
10 *Guard duty, as defined in 10 U.S.C. § 101(d)(5), for 120 days or*
11 *more; and*

12 (2) *Not more than 30 days after leaving active service, the*
13 *member attends a course on reintegration.*

14 5. The Adjutant General shall adopt any regulations necessary
15 to determine eligibility for reimbursement or monetary relief from
16 the Patriot Relief Account and to carry out a program to provide
17 such reimbursement and monetary relief.

18 6. *As used in this section, "course on reintegration" means a*
19 *class designed to provide a member of the Nevada National Guard*
20 *who is leaving active service with skills and training focused on*
21 *returning to a life that does not include being in active service.*
