AN ACT relating to veterans; requiring the Executive Director for Veterans' Services to prepare, maintain and make available for public inspection a register that includes the names of the veterans interred in each cemetery in this State; requiring the Executive Director to provide flags of the United States to certain persons and civic organizations for placement on the graves of veterans on certain holidays; requiring the Executive Director to provide a flag of the United States to each resident of a veterans' home in this State to commemorate certain holidays; making an appropriation; and providing other matters properly relating thereto.



**Legislative Counsel's Digest:**

1 The Office of Veterans' Services provides various services to persons serving  
 2 in the Armed Forces of the United States and veterans and their families. (Chapter  
 3 417 of NRS) **Section 2** of this bill requires the Executive Director for Veterans'  
 4 Services to prepare, maintain and make available for public inspection a register  
 5 that includes the names of the veterans interred in the cemeteries in this State.  
 6 **Section 3** of this bill requires the Executive Director to provide, without charge,  
 7 flags of the United States to certain persons and civic organizations for placement  
 8 on the graves of veterans on certain holidays. This bill also requires the Executive  
 9 Director each year to provide a flag of the United States to each resident of a  
 10 veterans' home in this State to commemorate certain holidays. **Section 4** of this bill  
 11 appropriates \$15,000 to the Office of Veterans' Services to provide the flags.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
 SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 417 of NRS is hereby amended by adding  
 2 thereto the provisions set forth as sections 2 and 3 of this act.

3 **Sec. 2.** *The Executive Director shall prepare, maintain and*  
 4 *make available for public inspection a register that includes the*  
 5 *names of the veterans interred in the veterans' cemetery in*  
 6 *northern Nevada, the veterans' cemetery in southern Nevada and*  
 7 *all other public and private cemeteries in this State. The register*  
 8 *must include the number of veterans interred in each cemetery in*  
 9 *this State and, if known, the date of interment of each veteran.*

10 **Sec. 3. 1.** *The Executive Director shall, upon the request of*  
 11 *the owner or operator of a cemetery in this State or a civic*  
 12 *organization recognized by the Executive Director, provide a*  
 13 *sufficient number of flags of the United States for placement on*  
 14 *the graves of veterans interred in the cemetery to commemorate*  
 15 *Memorial Day, Flag Day, Independence Day and Veterans' Day.*  
 16 *The flags must be of a size suitable for placement on a grave and*  
 17 *provided without charge.*

18 *2. Each year, on or before Memorial Day, Flag Day,*  
 19 *Independence Day and Veterans' Day, the Executive Director*  
 20 *shall, without charge, provide to each resident of a veterans' home*  
 21 *in this State a flag of the United States of an appropriate size for*  
 22 *use in commemorating those holidays.*

23 *3. The flags the Executive Director is required to provide*  
 24 *pursuant to this section must be manufactured in the United*  
 25 *States.*

26 **Sec. 4. 1.** There is hereby appropriated from the State  
 27 General Fund to the Office of Veterans' Services to carry out the  
 28 provisions of section 3 of this act:

29 For the Fiscal Year 2007-2008.....\$7,500  
 30 For the Fiscal Year 2008-2009.....\$7,500



1        2. The sums appropriated by subsection 1 are available for  
2 either fiscal year. Any remaining balance of those sums must not be  
3 committed for expenditure after June 30, 2009, by the entity to  
4 which the appropriation is made or any entity to which money from  
5 the appropriation is granted or otherwise transferred in any manner,  
6 and any portion of the appropriated money remaining must not be  
7 spent for any purpose after September 18, 2009, by either the entity  
8 to which the money was appropriated or the entity to which the  
9 money was subsequently granted or transferred, and must be  
10 reverted to the State General Fund on or before September 18, 2009.
