AN ACT relating to industrial programs for correctional institutions; authorizing the appointment of alternate members of the Committee on Industrial Programs; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

1 Existing law creates the Committee on Industrial Programs and establishes the  
2 composition of the Committee, which consists of the Director of the Department of  
3 Corrections, the Chief of the Purchasing Division of the Department of  
4 Administration and eight members appointed by the Interim Finance Committee.  
5 (NRS 209.4817) This bill authorizes the Chairman of the Committee on Industrial  
6 Programs to appoint eight alternate members to serve in place of regular members  
7 who are unable to attend a meeting or perform their duties.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1      **Section 1.** NRS 209.4817 is hereby amended to read as  
2 follows:  
3      209.4817    1. The Committee on Industrial Programs is hereby  
4 created.  
5      2. The Committee **[on Industrial Programs]** consists of the  
6 Director of the Department, the Chief of the Purchasing Division of

1 the Department of Administration and eight **regular** members  
2 appointed by the Interim Finance Committee as follows:

- 3     (a) Two members of the Senate.  
4     (b) Two members of the Assembly.  
5     (c) Two persons who represent manufacturing in this State.  
6     (d) One person who represents business in this State.  
7     (e) One person who represents organized labor in this State.  
8     3. The **regular** members of the Committee ~~[on Industrial~~  
9 ~~Programs]~~ shall select a Chairman from among their membership.  
10    4. Each **regular** member of the Committee ~~[on Industrial~~  
11 ~~Programs]~~ appointed by the Interim Finance Committee must be  
12 appointed to a term of 2 years and may be reappointed.

13    5. *At the first meeting of the Committee following each*  
14 *regular session of the Legislature, the Chairman of the Committee*  
15 *may appoint eight alternate members to serve in the place of*  
16 *regular members who are unable to attend a meeting or perform*  
17 *their duties, as follows:*

18     (a) *Two members of the Senate, each of whom may serve in*  
19 *the place of a member of the Senate appointed pursuant to*  
20 *paragraph (a) of subsection 2.*

21     (b) *Two members of the Assembly, each of whom may serve in*  
22 *the place of a regular member of the Assembly appointed pursuant*  
23 *to paragraph (b) of subsection 2.*

24     (c) *Two persons who represent manufacturing in this State,*  
25 *each of whom may serve in the place of a person appointed*  
26 *pursuant to paragraph (c) of subsection 2.*

27     (d) *One person who represents business in this State, who may*  
28 *serve in the place of the person appointed pursuant to paragraph*  
29 *(d) of subsection 2.*

30     (e) *One person who represents organized labor in this State,*  
31 *who may serve in the place of the person appointed pursuant to*  
32 *paragraph (e) of subsection 2.*

33     *Each alternate member appointed by the Chairman must be*  
34 *appointed to a term of 2 years and may be reappointed.*

35    6. Except during a regular or special session of the Legislature,  
36 each Legislator who is a **regular** member **or an alternate member**  
37 of the Committee ~~[on Industrial Programs]~~ is entitled to receive the  
38 compensation provided for a majority of the members of the  
39 Legislature during the first 60 days of the preceding regular session  
40 for each day or portion of a day during which he attends a meeting  
41 of the Committee ~~[on Industrial Programs]~~ or is otherwise engaged  
42 in the work of the Committee . ~~[on Industrial Programs]~~ Each  
43 nonlegislative **regular** member **or alternate member** appointed by  
44 the Interim Finance Committee **or the Chairman of the Committee**  
45 **on Industrial Programs** is entitled to receive compensation for his

1 service on the Committee on Industrial Programs in the same  
2 amount and manner as the legislative *regular* members *or alternate*  
3 *members* whether or not the Legislature is in session. Each  
4 nonlegislative *regular* member *or alternate member* of the  
5 Committee ~~for Industrial Programs~~ is entitled to receive the per  
6 diem allowance and travel expenses provided for state officers and  
7 employees generally. Each Legislator who is a *regular* member *or*  
8 *an alternate member* of the Committee ~~for Industrial Programs~~ is  
9 entitled to receive the per diem allowance provided for state officers  
10 and employees generally and the travel expenses provided pursuant  
11 to NRS 218.2207. All compensation, allowances and travel  
12 expenses must be paid from the Fund for Prison Industries.

13      **Sec. 2.** This act becomes effective upon passage and approval.
