SUMMARY—Requires certain water authorities to notify their customers of certain charitable contributions made by the water authority. (BDR 22-187)

AN ACT relating to water authorities; requiring certain water authorities to notify their customers of certain charitable contributions made by the water authority; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 This bill requires a water authority created by an interlocal agreement in a
2 county whose population is 100,000 or more but less than 400,000 (currently
3 Washoe County) and which is the largest retail water purveyor in that county
4 (currently the Truckee Meadows Water Authority) to notify its customers of any
5 charitable contributions made by the water authority to a nonprofit religious,
6 charitable, fraternal or other tax-exempt organization.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 277 of NRS is hereby amended by adding
2 thereto a new section to read as follows:

3 *If a water authority that is created by an interlocal agreement
4 pursuant to NRS 277.080 to 277.180, inclusive, in a county whose
5 population is 100,000 or more but less than 400,000 and is the
6 largest purveyor of water in that county makes a charitable
7 contribution of money to a nonprofit religious, charitable,
8 fraternal or other organization that qualifies as tax-exempt
9 pursuant to 26 U.S.C. § 501(c)(3), the water authority shall notify
10 its customers of the amount, purpose and recipient of the
11 contribution in the next billing statement sent to customers after
12 the water authority makes the contribution.*

13 **Sec. 2.** NRS 277.080 is hereby amended to read as follows:
14 277.080 NRS 277.080 to 277.180, inclusive, **and section 1 of
15 this act** may be cited as the Interlocal Cooperation Act.

16 **Sec. 3.** This act becomes effective on July 1, 2007.
