

ASSEMBLY BILL NO. 215—COMMITTEE ON COMMERCE AND LABOR

FEBRUARY 28, 2007

**SUMMARY**—Makes various changes concerning financial institutions. (BDR 55-1125)

AN ACT relating to financial institutions; limiting interstate banking by an out-of-state depository institution that establishes or acquires a branch office in certain counties pursuant to certain statutory provisions; authorizing certain out-of-state depository institutions to issue a credit card under certain circumstances; prohibiting the issuer of a credit card from increasing the rate of interest it charges to a cardholder under certain circumstances; requiring the issuer of a credit card to provide certain information to credit reporting agencies under certain circumstances; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

1 Existing law provides limitations upon banking in this State by out-of-state  
2 depository institutions and out-of-state holding companies. (Chapter 666 of NRS)  
3 An exception to these limitations allows the establishment of a branch office or the  
4 acquisition of an existing branch of a depository institution in a county whose  
5 population is less than 100,000 (currently counties other than Clark and Washoe  
6 Counties). (NRS 666.410) **Section 1** of this bill provides that an out-of-state  
7 depository institution that establishes or acquires a branch office pursuant to this  
8 exception is still considered an out-of-state depository institution for the purposes  
9 of all other provisions limiting interstate banking. **Section 1** also provides that an  
10 out-of-state depository institution that has established or acquired, or been approved  
11 to establish or acquire, a branch pursuant to this exception may also establish or  
12 acquire a branch in a county whose population is 100,000 or more, but only so long  
13 as the out-of-state depository institution continues to operate a branch in a county  
14 whose population is less than 100,000.

15 Existing law governs the issuance of credit cards by financial institutions in this  
16 State. (Chapter 97A of NRS) **Section 1.4** of this bill prohibits the issuer of a credit  
17 card from increasing the interest rate it charges a cardholder based upon a late

18 payment by the cardholder to an unrelated credit card issuer or creditor. **Section 1.4**  
19 also prohibits a credit card issuer from including a universal default clause in a  
20 contract or other agreement relating to a credit card account. **Section 1.6** of this bill  
21 prohibits the issuer of a credit card from prohibiting or attempting to prohibit a  
22 merchant from offering a discount to a customer to induce the customer to pay for  
23 goods or services with by cash, check or other means instead of with a credit card.  
24 **Section 1.8** of this bill provides that if a cardholder voluntarily closes a credit card  
25 account to avoid a change in the terms or conditions of the account made by the  
26 issuer of the credit card, the issuer must notify any credit reporting agency to which  
27 it provides information concerning the cardholder's account that the closure of the  
28 account was voluntary on the part of the cardholder.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1       **Section 1.** NRS 666.410 is hereby amended to read as follows:

2       666.410 **1.** An out-of-state depository institution without a  
3 branch in Nevada or an out-of-state holding company without a  
4 depository institution in Nevada may not establish a de novo branch  
5 in this State or acquire, through merger or otherwise, a branch of a  
6 depository institution in Nevada without acquiring the institution  
7 itself or its charter, except that, with the written approval of the  
8 Commissioner:

9       ~~1. (a)~~ An out-of-state depository institution without a branch  
10 in Nevada ~~for an out-of-state holding company without a depository~~  
11 ~~institution in Nevada~~ may establish a branch office or acquire an  
12 existing branch in a county whose population is less than 100,000  
13 without acquiring or merging with a Nevada depository institution  
14 or a Nevada holding company . ~~;~~ ~~and~~ Except as otherwise  
15 provided in subsection 2, an out-of-state depository institution that  
16 establishes or acquires a branch office pursuant to this paragraph  
17 continues to be considered an out-of-state depository institution  
18 without a branch in Nevada for the purposes of all other  
19 provisions of this chapter.

20       ~~2. (b)~~ An out-of-state depository institution without a branch  
21 in Nevada which is owned or controlled by a holding company that  
22 is entitled to the exemption set forth in section 4(c)(i) of the Bank  
23 Holding Company Act of 1956, as amended, 12 U.S.C. § 1843(c)(i),  
24 may acquire an existing branch in Nevada without acquiring or  
25 merging with a Nevada depository institution or a Nevada holding  
26 company.

27       **2. An out-of-state depository institution that on or before**  
28 **April 1, 2007, has, pursuant to paragraph (a) of subsection 1,**  
29 **established or acquired, or been approved by the Commissioner to**  
30 **establish or acquire, a branch in a county whose population is less**  
31 **than 100,000, may establish or acquire a branch in a county**

1   **whose population is 100,000 or more so long as the out-of-state**  
2   **depository institution continues to operate a branch in a county**  
3   **whose population is less than 100,000.**

4   **3. An out-of-state depository institution that establishes or**  
5   **acquires a branch office pursuant to this section may issue a**  
6   **credit card pursuant to the provisions of chapter 97A of NRS.**

7   **Sec. 1.2.** Chapter 97A of NRS is hereby amended by adding  
8 thereto the provisions set forth as sections 1.4 and 1.6 of this act.

9   **Sec. 1.4. 1. An issuer shall not:**

10   **(a) Increase the interest rate it charges a cardholder for the**  
11   **use of the card based upon the late payment by the cardholder to**  
12   **another issuer or a creditor of the cardholder that is not an**  
13   **affiliate or subsidiary of the issuer; or**

14   **(b) Include a universal default clause in a contract or other**  
15   **agreement relating to a credit card account.**

16   **2. Notwithstanding the provisions of subsection 1, an issuer**  
17   **may increase the interest rate it charges a cardholder for the use**  
18   **of the card based on a change in the credit rating of the**  
19   **cardholder.**

20   **3. As used in this section:**

21   **(a) "Affiliate or subsidiary of the issuer" means an affiliate or**  
22   **subsidiary that conducts business under a name that is:**

23   **(1) The same as the name of the issuer; or**

24   **(2) Sufficiently similar to the name of the issuer that a**  
25   **cardholder could reasonably believe that he is conducting business**  
26   **with the issuer.**

27   **(b) "Universal default clause" means a clause or provision**  
28   **that allows an issuer to increase the interest rate it charges a**  
29   **cardholder for the use of the card based upon the late payment by**  
30   **the cardholder to another issuer or a creditor of the cardholder**  
31   **that is not an affiliate or subsidiary of the issuer.**

32   **Sec. 1.6. An issuer shall not, by contract or any other**  
33   **method, prohibit or attempt to prohibit a merchant who provides**  
34   **goods or services to a cardholder from offering a discount to the**  
35   **cardholder to induce the customer to pay for the goods or services**  
36   **by cash, check or other means instead of by use of a credit card or**  
37   **credit card account.**

38   **Sec. 1.8.** NRS 97A.140 is hereby amended to read as follows:

39   **97A.140 1. An issuer located in this State shall not issue a**  
40   **credit card to a cardholder unless the issuer first:**

41   **(a) Provides the written notice required pursuant to NRS**  
42   **97A.145 to the cardholder; and**

43   **(b) Receives a written or oral request from the cardholder for the**  
44   **issuance of the credit card.**

1        2. An issuer shall provide the cardholder with the terms and  
2 conditions that govern the use of the credit card, in writing, before  
3 or at the time of the receipt of the credit card. A cardholder shall be  
4 deemed to have accepted the written terms and conditions provided  
5 by the issuer upon subsequent actual use of the credit card.

6        3. The rate of interest charged, and any other fees or charges  
7 imposed for the use of the credit card, must be in an amount agreed  
8 upon by the issuer and cardholder.

9        4. An issuer may unilaterally change any term or condition for  
10 the use of a credit card without prior written notice to the cardholder  
11 unless the change will adversely affect or increase the costs to the  
12 cardholder for the use of the credit card. If the change will increase  
13 such costs, the issuer shall provide [notice] to the cardholder :

14        (a) *An identifiable notice* of the change at least 30 days before  
15 the change becomes effective ~~H~~; and

16        (b) *An opportunity to avoid the change, including, without  
17 limitation, by voluntarily closing his credit card account after  
18 providing notice to the issuer. If the cardholder closes his credit  
19 card account and the issuer provides any information about the  
20 account to a credit reporting agency, the issuer must notify the  
21 agency that the cardholder voluntarily closed the credit card  
22 account.*

23        5. Unless otherwise stated as a term or condition, the law of  
24 this State governs all transactions relating to the use of a credit card  
25 if an issuer, or the service provider of an issuer, is located in this  
26 State.

27        **Sec. 2.** 1. This section and section 1 of this act become  
28 effective upon passage and approval.

29        2. Sections 1.2 to 1.8, inclusive, of this act become effective on  
30 July 1, 2007.
