**SUMMARY**—Authorizes the State Land Registrar to transfer certain real property owned by the State of Nevada to Washoe County and the Sierra Fire Protection District. (BDR S-367)

AN ACT relating to state property; authorizing the State Land Registrar to transfer certain real property owned by the State of Nevada to Washoe County and the Sierra Fire Protection District; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

- 1       The State Land Registrar may transfer land owned by the State of Nevada.  
2       (NRS 321.003)  
3       **Section 1** of this bill authorizes the State Land Registrar to transfer certain real  
4       property owned by the State of Nevada to Washoe County and the Sierra Fire  
5       Protection District. **Section 2** of this bill requires deed restrictions concerning  
6       future use of the transferred property to provide fire protection services and consent  
7       of the State on any transfer of property by the fire protection district. **Section 3** of  
8       this bill provides a legal description of the real property that the State Land  
9       Registrar is authorized to transfer to Washoe County and the Sierra Fire Protection  
10      District.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1       **Section 1.** The State Land Registrar may transfer to:

2       1. The Sierra Fire Protection District, without consideration, all  
3 the interest of the State of Nevada in the real property described in  
4 subsection 1 of section 3 of this act. If the real property is  
5 transferred pursuant to this subsection, the Sierra Fire Protection  
6 District shall pay the costs relating to the transfer of the real  
7 property.

8       2. Washoe County, without consideration, all the interest of the  
9 State of Nevada in the real property described in subsection 2 of  
10 section 3 of this act. If the real property is transferred pursuant to  
11 this subsection, Washoe County shall pay the costs relating to the  
12 transfer of the real property.

13      **Sec. 2.** If the real property is transferred to the Sierra Fire  
14 Protection District pursuant to subsection 1 of section 1 of this act,  
15 the deed from the State of Nevada to the Sierra Fire Protection  
16 District must:

17       1. Include restrictions that:

18       (a) Require the use of the property for the provision of services  
19 for fire protection; and

20       (b) Prohibit the Sierra Fire Protection District or any successor  
21 in title from transferring the property without the consent of the  
22 State of Nevada; and

23       2. Provide for the reversion of title to the property to the  
24 State of Nevada upon the breach of any restriction specified in  
25 subsection 1.

26      **Sec. 3.** 1. The real property that may be transferred to the  
27 Sierra Fire Protection District is commonly known as the Joy Lake  
28 Fire Station and is described as follows:

29       Parcel "A" of St. James's Village Unit 1B, according to the  
30 official map thereof, filed in the office of the County Recorder of  
31 Washoe County, State of Nevada, on June 23, 1995, under File  
32 No. 1902968, as Tract Map No. 3155.

33       2. The real property that may be transferred to Washoe County  
34 is located in the town of Verdi, Nevada, and is described as follows:

35       All that certain tract, piece or parcel of land situate, lying and  
36 being in the northwest quarter of Section 17, T. 19 N., R. 18 E.,  
37 M.D.B. & M., and more particularly described as follows: All of  
38 Lot 8 and the easterly 10 feet of Lot 9, Block H of the Town of  
39 Verdi, County of Washoe, State of Nevada.
