AN ACT relating to homeopathy; eliminating the Nevada Institutional Review Board; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

1 Existing law establishes the Nevada Institutional Review Board which, under  
2 the supervision of the Board of Homeopathic Medical Examiners, oversees,  
3 reviews and controls certain research studies. (NRS 630A.800-630A.910) This bill  
4 eliminates the Nevada Institutional Review Board.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 630A.090 is hereby amended to read as  
2 follows:  
3 630A.090 1. ~~[Except as otherwise provided in NRS~~  
4 ~~630A.800 to 630A.910, inclusive, this]~~ *This* chapter does not apply  
5 to:  
6 (a) The practice of dentistry, chiropractic, Oriental medicine,  
7 podiatry, optometry, respiratory care, faith or Christian Science  
8 healing, nursing, veterinary medicine or fitting hearing aids.  
9 (b) A medical officer of the Armed Services or a medical officer  
10 of any division or department of the United States in the discharge  
11 of his official duties.



1 (c) Licensed or certified nurses in the discharge of their duties as  
2 nurses.

3 (d) Homeopathic physicians who are called into this State, other  
4 than on a regular basis, for consultation or assistance to any  
5 physician licensed in this State, and who are legally qualified to  
6 practice in the state or country where they reside.

7 2. This chapter does not repeal or affect any statute of Nevada  
8 regulating or affecting any other healing art.

9 3. This chapter does not prohibit:

10 (a) Gratuitous services of a person in case of emergency.

11 (b) The domestic administration of family remedies.

12 4. This chapter does not authorize a homeopathic physician to  
13 practice medicine, including allopathic medicine, except as  
14 otherwise provided in NRS 630A.040.

15 **Sec. 2.** NRS 630A.155 is hereby amended to read as follows:

16 630A.155 The Board shall:

17 1. Regulate the practice of homeopathic medicine in this State  
18 and any activities that are within the scope of such practice, to  
19 protect the public health and safety and the general welfare of the  
20 people of this State.

21 2. Determine the qualifications of, and examine, applicants for  
22 licensure or certification pursuant to this chapter, and specify by  
23 regulation the methods to be used to check the background of such  
24 applicants.

25 3. License or certify those applicants it finds to be qualified.

26 4. Investigate and, if required, hear and decide in a manner  
27 consistent with the provisions of chapter 622A of NRS all  
28 complaints made against any homeopathic physician, advanced  
29 practitioner of homeopathy, homeopathic assistant or any agent or  
30 employee of any of them, or any facility where the primary practice  
31 is homeopathic medicine. If a complaint concerns a practice which  
32 is within the jurisdiction of another licensing board or any other  
33 possible violation of state law, the Board shall refer the complaint to  
34 the other licensing board.

35 5. ~~Supervise the Nevada Institutional Review Board created~~  
36 ~~by NRS 630A.865, including, without limitation, approving or~~  
37 ~~denying the regulations adopted by the Nevada Institutional Review~~

39 ~~6.]~~ Submit an annual report to the Legislature and make  
40 recommendations to the Legislature concerning the enactment of  
41 legislation relating to alternative and complementary integrative  
42 medicine, including, without limitation, homeopathic medicine.

43 **Sec. 3.** NRS 630A.800, 630A.815, 630A.825, 630A.835,  
44 630A.855, 630A.865, 630A.870, 630A.875, 630A.880, 630A.900,  
45 630A.905 and 630A.910 are hereby repealed.



1       **Sec. 4.** 1. The Nevada Institutional Review Board shall, not  
2 later than July 1, 2007:

3       (a) Return the unexpended portion of any grant, gift,  
4 appropriation or donation that was received by the Board subject to  
5 a condition that requires its return if it cannot be used to carry out  
6 the duties of the Board;

7       (b) Transfer any money that remains in any account maintained  
8 by the Nevada Institutional Review Board after complying with  
9 paragraph (a) to the Board of Homeopathic Medical Examiners; and

10       (c) Transfer all books, records, minutes, documents and other  
11 property of the Nevada Institutional Review Board to the Board of  
12 Homeopathic Medical Examiners.

13       2. Any regulations adopted by the Nevada Institutional Review  
14 Board, or by the Board of Homeopathic Medical Examiners  
15 concerning the Nevada Institutional Review Board, are void on  
16 July 1, 2007. The Legislative Counsel shall remove those  
17 regulations from the Nevada Administrative Code as soon as  
18 practicable after July 1, 2007.

19       3. Any contract entered into by the Nevada Institutional  
20 Review Board, or by the Board of Homeopathic Medical Examiners  
21 concerning the Nevada Institutional Review Board, including,  
22 without limitation, a contract for employment and a contract for the  
23 services of a person pursuant to NRS 284.013, that is not fully  
24 performed on July 1, 2007, is void.

25       4. If the Board of Homeopathic Medical Examiners has created  
26 a nonprofit organization pursuant to NRS 630A.875, including,  
27 without limitation, the NIRB Medical Foundation, the Board of  
28 Homeopathic Medical Examiners shall, not later than July 1, 2007,  
29 dissolve the nonprofit organization.

30       5. The Nevada Institutional Review Board shall cooperate with  
31 the Board of Homeopathic Medical Examiners to ensure that the  
32 provisions of this act are carried out in an orderly manner.

33       6. The terms of the members of the Nevada Institutional  
34 Review Board expire on July 1, 2007.

35       **Sec. 5.** 1. This section and section 4 of this act become  
36 effective upon passage and approval.

37       2. Sections 1, 2 and 3 of this act become effective on July 1,  
38 2007.
