SUMMARY—Provides for the impoundment of motor vehicles in certain situations. (BDR 43-973)

AN ACT relating to motor vehicles; requiring a peace officer to impound a motor vehicle if the driver does not have a driver's license or evidence of insurance in his possession; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law provides that a driver who does not have his driver's license or
2 evidence of insurance in his possession while driving must be issued a citation,
3 though he may not be convicted if he later produces his driver's license or evidence
4 of insurance in court or to the arresting officer. (NRS 483.350, 484.792) **Sections 1**
5 **and 2** of this bill require that, in addition to issuing a citation, a peace officer shall
6 impound a vehicle if the driver does not have his driver's license or evidence of
7 insurance in his possession. The driver or owner must produce the driver's license
8 or evidence of insurance and pay the towing and impounding fees before the
9 vehicle is returned to him.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 483.350 is hereby amended to read as follows:
2 483.350 **1.** Every licensee shall have his driver's license in
3 his immediate possession at all times when driving a motor vehicle
4 and shall manually surrender the license for examination, upon

1 demand, to a justice of the peace, a peace officer ~~[1]~~ or a deputy of
2 the Department. ~~[However, no]~~

3 *2. If a licensee fails to have his driver's license in his*
4 *immediate possession when driving a motor vehicle, the peace*
5 *officer or deputy of the Department shall cause the vehicle to be*
6 *towed and impounded until:*

7 *(a) The licensee produces in court or in the office of the*
8 *arresting officer a driver's license theretofore issued to him and*
9 *valid at the time of the demand; and*

10 *(b) The owner of the motor vehicle claims the vehicle by*
11 *paying the cost of the towing and impoundment.*

12 *3. Neither the peace officer or deputy of the Department nor*
13 *the governmental entity which employs him is civilly liable for any*
14 *damage to a motor vehicle seized pursuant to subsection 2 that*
15 *occurs after the vehicle is seized, but before the towing process*
16 *begins.*

17 *4. No person charged with violating this section shall be*
18 *convicted pursuant to NRS 483.620 if he produces in court or in the*
19 *office of the arresting officer a driver's license theretofore issued to*
20 *him and valid at the time of the demand.*

21 **Sec. 2.** NRS 484.792 is hereby amended to read as follows:

22 484.792 *1.* Whenever the driver of a vehicle is stopped by a
23 peace officer for violating a provision of this chapter, except for
24 violating a provision of NRS 484.395 to 484.443, inclusive, the
25 officer shall demand ~~[proof]~~ *evidence* of the insurance required by
26 NRS 485.185, and issue a citation as provided in NRS 484.799 if
27 the officer has probable cause to believe that the driver of the
28 vehicle is in violation of NRS 485.187.

29 *2.* If the driver of the vehicle is not the owner, a citation must
30 also be issued to the owner, and in such a case the driver:

31 ~~[1-]~~ *(a)* May sign the citation on behalf of the owner; and

32 ~~[2-]~~ *(b)* Shall notify the owner of the citation within 3 days after
33 it is issued.

34 ➔ The agency which employs the peace officer shall immediately
35 forward a copy of the citation to the registered owner of the vehicle,
36 by certified mail, at his address as it appears on the certificate of
37 registration.

38 *3. If the driver of the vehicle fails to provide evidence of*
39 *insurance upon demand pursuant to subsection 1, and the peace*
40 *officer has probable cause to believe that the driver is in violation*
41 *of NRS 485.187, the officer shall cause the vehicle to be towed and*
42 *impounded until:*

43 *(a) The driver or owner presents evidence of insurance in*
44 *effect at the time of demand to the court pursuant to NRS 485.187;*
45 *and*



- 1 ***(b) The owner of the motor vehicle claims the vehicle by***
- 2 ***paying the cost of the towing and impoundment.***
- 3 ***4. Neither the peace officer nor the governmental entity***
