AN ACT making an appropriation to the Food Bank of Northern Nevada, Inc., to supplement costs associated with the distribution of food from the Commodity Supplemental Food Program in northern Nevada; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** 1. There is hereby appropriated from the State
- 2 General Fund to the Food Bank of Northern Nevada, Inc., the sum
- 3 of \$100,000 to supplement costs associated with the distribution of
- 4 food from the Commodity Supplemental Food Program in northern
- 5 Nevada.
- 6 2. Upon acceptance of the money appropriated by subsection 1,
- 7 the Food Bank of Northern Nevada, Inc., shall:
- 8 (a) Prepare and transmit a report to the Interim Finance
- 9 Committee on or before December 15, 2008, that describes each

1 expenditure made from the money appropriated by subsection 1
2 from the date on which the money was received by the Food Bank
3 of Northern Nevada, Inc., through December 1, 2008; and

4 (b) Upon request of the Legislative Commission, make available
5 to the Legislative Auditor any books, accounts, claims, reports,
6 vouchers or other records of information, confidential or otherwise,
7 of the Food Bank of Northern Nevada, Inc., regardless of their
8 form or location, that the Legislative Auditor deems necessary to
9 conduct an audit of the use of the money appropriated pursuant to
10 subsection 1.

11 3. Any remaining balance of the appropriation made by
12 subsection 1 must not be committed for expenditure after June 30,
13 2009, by the entity to which the appropriation is made or any
14 entity to which money from the appropriation is granted or
15 otherwise transferred in any manner, and any portion of the
16 appropriated money remaining must not be spent for any purpose
17 after September 18, 2009, by either the entity to which the money
18 was appropriated or the entity to which the money was subsequently
19 granted or transferred, and must be reverted to the State General
20 Fund on or before September 18, 2009.

21 **Sec. 2.** This act becomes effective upon passage and approval.
