AN ACT relating to wildlife; requiring the Department of Wildlife to submit a financial report to the Legislature relating to certain accounts and subaccounts administered by the Department; and providing other matters properly relating thereto.

**Legislative Counsel’s Digest:**

- 1 Existing law creates the Department of Wildlife. The Department is required to
- 2 administer the laws of this State relating to wildlife and the provisions of chapter
- 3 488 of NRS relating to watercraft and the use of watercraft. (NRS 501.331)
- 4 **Section 26** of this bill requires the Department to submit to the Legislature, on
- 5 or before the fifth calendar day of each regular session, a financial report setting
- 6 forth the activity and status of the Wildlife Obligated Reserve Account and any
- 7 other account or subaccount administered by the Department for which the use of
- 8 the money in the account or subaccount is restricted. The report must include,
- 9 without limitation, a description of each project for which money is spent and a
- 10 description of each recipient of that money.

- 36    (b) *The total amount of money expended from each of those*
- 37    *accounts and subaccounts for each fiscal year, including, without*
- 38    *limitation, the amount of any matching contributions received for*
- 39    *those accounts and subaccounts for each fiscal year.*
