SUMMARY—Requires the board of trustees of a school district in certain counties to cause each meeting of the board to be televised. (BDR 34-1164)

AN ACT relating to school districts; requiring the board of trustees of a school district in certain counties to cause each meeting of the board to be televised; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 This bill requires the board of trustees of a school district in a county whose
2 population is 400,000 or more (currently Clark County) to cause each meeting of
3 the board to be broadcast on a television station created to provide community
4 access to cable television by using the facilities of the county or any city located in
5 the county.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 386.330 is hereby amended to read as follows:
2 386.330 1. The board of trustees shall hold a regular meeting
3 at least once each month, at such time and place as the board shall
4 determine.

1 2. Special meetings of the board of trustees shall be held at the
2 call of the president whenever there is sufficient business to come
3 before the board, or upon the written request of three members of
4 the board.

5 3. The clerk of the board of trustees shall give written notice of
6 each special meeting to each member of the board of trustees by
7 personal delivery of the notice of the special meeting to each trustee
8 at least 1 day before the meeting, or by mailing the notice to each
9 trustee's residence of record, by deposit in the United States mails,
10 postage prepaid, at least 4 days before the meeting. The notice shall
11 specify the time, place and purpose of the meeting. If all of the
12 members of the board of trustees are present at a special meeting,
13 the lack of notice shall not invalidate the proceedings of the board of
14 trustees.

15 4. A majority of the members of the board of trustees shall
16 constitute a quorum for the transaction of business, and no action of
17 the board of trustees shall be valid unless such action shall receive,
18 at a regularly called meeting, the approval of a majority of all the
19 members of the board of trustees.

20 5. *In any county whose population is 400,000 or more, the
21 board of trustees shall cause each meeting of the board to be
22 broadcast on a television station created to provide community
23 access to cable television by using the facilities of the county or
24 any city located in the county. The board and the county or city
25 shall cooperate fully with each other in arranging for the use of
26 the facilities by the board in carrying out the requirements of this
27 subsection.*

28 Sec. 2. This act becomes effective on July 1, 2007.
