AN ACT making appropriations to the Department of Health and Human Services to replace vehicles, appliances, radios and other equipment at certain youth facilities; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1      **Section 1.** 1. There is hereby appropriated from the State  
2 General Fund to the Division of Child and Family Services of the  
3 Department of Health and Human Services for the Juvenile  
4 Correctional Facility the sum of \$54,315 for replacement  
5 equipment, including a dishwasher, a walk-in freezer, hot water  
6 heaters, a culinary mixer and a meat slicer.

7      2. There is hereby appropriated from the State General Fund to  
8 the Division of Child and Family Services of the Department of  
9 Health and Human Services for the Nevada Youth Training Center  
10 the sum of \$100,073 for replacement of equipment, including two-  
11 way radios, a riding lawn mower, washers and dryers for cottages,  
12 an infirmary refrigerator, lockers for cottages, an industrial fryer and  
13 maintenance utility vehicles.

1       3. There is hereby appropriated from the State General Fund to  
2 the Division of Child and Family Services of the Department of  
3 Health and Human Services for the Caliente Youth Center the sum  
4 of \$86,425 to replace agency-owned vehicles and equipment for  
5 youth dormitories, the facility kitchen and grounds maintenance.

6       **Sec. 2.** Any remaining balance of the appropriations made by  
7 section 1 of this act must not be committed for expenditure after  
8 June 30, 2009, by the entity to which the appropriations are made or  
9 any entity to which money from the appropriations is granted or  
10 otherwise transferred in any manner, and any portion of the  
11 appropriated money remaining must not be spent for any purpose  
12 after September 18, 2009, by either the entity to which the money  
13 was appropriated or the entity to which the money was subsequently  
14 granted or transferred, and must be reverted to the State General  
15 Fund on or before September 18, 2009.

16       **Sec. 3.** This act becomes effective upon passage and approval.
