**SUMMARY**—Requires certain care facilities to maintain and provide certain information to parents, guardians or legal representatives of persons cared for in the facilities. (BDR 38-1124)

AN ACT relating to care facilities; requiring child care facilities and facilities for the care of adults during the day to maintain and provide certain information to the parents, guardians or legal representatives of persons cared for in those facilities; requiring licensing authorities to provide summaries and reports to the facilities of certain complaints against the facilities; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

Existing law requires the licensing of child care facilities (chapter 432A of NRS) and facilities for the care of adults during the day (chapter 449 of NRS). **Section 1** of this bill requires child care facilities to maintain records of licensure and disciplinary action, and to make that information available to the public and the parents or guardians of children cared for in the facility. **Section 2** of this bill makes failure to comply with this requirement a ground for revocation of the facility's license. **Sections 3 and 4** of this bill impose similar requirements with respect to facilities for the care of adults during the day. **Sections 2 and 4** also require that summaries and reports of complaints against the facilities be provided to the facilities under certain circumstances and made available to the public.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1       **Section 1.** Chapter 432A of NRS is hereby amended by  
2 adding thereto a new section to read as follows:

3       ***1. A child care facility shall maintain a copy of:***

4       ***(a) The license issued to the facility by the Bureau or an  
5 agency for the licensing of child care facilities established by a  
6 county or incorporated city;***

7       ***(b) Any summaries of complaints provided to the facility  
8 pursuant to subsection 3 of NRS 432A.190;***

9       ***(c) The report of any investigation conducted with respect to  
10 the complaints; and***

11       ***(d) The report of any disciplinary action taken against the  
12 facility pursuant to NRS 432A.190.***

13       ***2. The information maintained pursuant to subsection 1 must  
14 be provided in the form prescribed pursuant to subsection 3:***

15       ***(a) To the parent or guardian of a child who enrolls the child  
16 in the facility, at or before the time of enrollment.***

17       ***(b) To the parent or guardian of a child, upon request, who is  
18 considering enrolling the child in the facility.***

19       ***(c) In the case of disciplinary action taken pursuant to NRS  
20 432A.190, to the parents or guardians of all children admitted to  
21 the facility. Notice of disciplinary action must be provided to the  
22 parents or guardians of the children admitted to the facility within  
23 3 working days after receipt by the licensed child care facility.***

24       ***3. The Bureau shall develop a standard form for reporting  
25 the information required to be provided pursuant to subsection 2.  
26 The information reported on the form must include all required  
27 information for the 12-month period ending on the last day of the  
28 month immediately preceding the month in which the information  
29 is provided.***

30       ***4. The Bureau and every agency for the licensing of child  
31 care facilities established by a county or incorporated city shall  
32 inform persons seeking information concerning child care  
33 facilities of their right to information pursuant to this section.***

34       **Sec. 2.** NRS 432A.190 is hereby amended to read as follows:

35       **432A.190 1.** The Bureau may deny an application for a  
36 license or may suspend or revoke any license issued under the  
37 provisions of this chapter upon any of the following grounds:

38       **(a) Violation by the applicant or licensee or an employee of the  
39 applicant or licensee of any of the provisions of this chapter or of  
40 any other law of this State or of the standards and other regulations  
41 adopted thereunder.**

1       (b) Aiding, abetting or permitting the commission of any illegal  
2 act.

3       (c) Conduct inimical to the public health, morals, welfare and  
4 safety of the people of the State of Nevada in the maintenance and  
5 operation of the child care facility for which a license is issued.

6       (d) Conduct or practice detrimental to the health or safety of the  
7 occupants or employees of the child care facility, or the clients of  
8 the outdoor youth program.

9       (e) Conviction of any crime listed in subsection 2 of NRS  
10 432A.170 committed by the applicant or licensee or an employee of  
11 the applicant or licensee, or by a resident of the child care facility or  
12 participant in the outdoor youth program who is 18 years of age or  
13 older.

14      *(f) Failure to comply with the provisions of section 1 of this  
15 act.*

16      2. In addition to the provisions of subsection 1, the Bureau may  
17 revoke a license to operate a child care facility if, with respect to  
18 that facility, the licensee that operates the facility, or an agent or  
19 employee of the licensee:

20       (a) Is convicted of violating any of the provisions of  
21 NRS 202.470;

22       (b) Is ordered to but fails to abate a nuisance pursuant to NRS  
23 244.360, 244.3603 or 268.4124; or

24       (c) Is ordered by the appropriate governmental agency to correct  
25 a violation of a building, safety or health code or regulation but fails  
26 to correct the violation.

27      3. The Bureau shall maintain a log of any complaints that it  
28 receives relating to activities for which the Bureau may revoke the  
29 license to operate a child care facility pursuant to subsection 2. *The  
30 Bureau shall provide to a child care facility:*

31       *(a) A summary of a complaint against the facility if the  
32 investigation of the complaint by the Bureau either substantiates  
33 the complaint or is inconclusive;*

34       *(b) A report of any investigation conducted with respect to the  
35 complaint; and*

36       *(c) A report of any disciplinary action taken against the  
37 facility.*

38      *► The facility shall make the information available to the public  
39 pursuant to section 1 of this act.*

40      4. On or before February 1 of each odd-numbered year, the  
41 Bureau shall submit to the Director of the Legislative Counsel  
42 Bureau a written report setting forth, for the previous biennium:

43       (a) Any complaints included in the log maintained by the  
44 Bureau pursuant to subsection 3; and

3       **Sec. 3.** Chapter 449 of NRS is hereby amended by adding  
4 thereto a new section to read as follows:

5       *1. A facility for the care of adults during the day shall  
6 maintain a copy of:*

7       *(a) The license issued to the facility pursuant to NRS 449.001  
8 to 449.240, inclusive;*

9       *(b) Any summaries of complaints provided to the facility  
10 pursuant to subsection 3 of NRS 449.160;*

11       *(c) The report of any investigation conducted with respect to  
12 the complaints; and*

13       *(d) The report of any disciplinary action taken against the  
14 facility pursuant to NRS 449.160 or 449.163.*

15       *2. The information maintained pursuant to subsection 1 must  
16 be provided in the form prescribed pursuant to subsection 3:*

17       *(a) To each patient or his legal representative, at or before the  
18 time of admission.*

19       *(b) To a prospective patient or his legal representative, upon  
20 request, who is considering admission of the patient to the facility.*

21       *(c) In the case of disciplinary action taken pursuant to NRS  
22 449.160 or 449.163, to all patients admitted to the facility and their  
23 legal representatives. Notice of disciplinary action must be  
24 provided to the legal representatives of all patients admitted to the  
25 facility within 3 working days after receipt by the facility.*

26       *3. The Health Division shall develop a standard form for  
27 reporting the information required to be provided pursuant to  
28 subsection 2. The information reported on the form must include  
29 all required information for the 12-month period ending on the  
30 last day of the month immediately preceding the month in which  
31 the information is provided.*

32       *4. The Health Division shall inform persons seeking  
33 information concerning facilities for the care of adults during the  
34 day of their right to information pursuant to this section.*

35       **Sec. 4.** NRS 449.160 is hereby amended to read as follows:

36       *449.160 1. The Health Division may deny an application for  
37 a license or may suspend or revoke any license issued under the  
38 provisions of NRS 449.001 to 449.240, inclusive, upon any of the  
39 following grounds:*

40       *(a) Violation by the applicant or the licensee of any of the  
41 provisions of NRS 439B.410 or 449.001 to 449.245, inclusive, or of  
42 any other law of this State or of the standards, rules and regulations  
43 adopted thereunder.*

44       *(b) Aiding, abetting or permitting the commission of any illegal  
45 act.*

1       (c) Conduct inimical to the public health, morals, welfare and  
2 safety of the people of the State of Nevada in the maintenance and  
3 operation of the premises for which a license is issued.

4       (d) Conduct or practice detrimental to the health or safety of the  
5 occupants or employees of the facility.

6       (e) Failure of the applicant to obtain written approval from the  
7 Director of the Department of Health and Human Services as  
8 required by NRS 439A.100 or as provided in any regulation adopted  
9 pursuant to this chapter, if such approval is required.

10      (f) ***Failure to comply with the provisions of section 3 of this  
11 act.***

12      2. In addition to the provisions of subsection 1, the Health  
13 Division may revoke a license to operate a facility for the dependent  
14 if, with respect to that facility, the licensee that operates the facility,  
15 or an agent or employee of the licensee:

16       (a) Is convicted of violating any of the provisions of  
17 NRS 202.470;

18       (b) Is ordered to but fails to abate a nuisance pursuant to NRS  
19 244.360, 244.3603 or 268.4124; or

20       (c) Is ordered by the appropriate governmental agency to correct  
21 a violation of a building, safety or health code or regulation but fails  
22 to correct the violation.

23      3. The Health Division shall maintain a log of any complaints  
24 that it receives relating to activities for which the Health Division  
25 may revoke the license to operate a facility for the dependent  
26 pursuant to subsection 2. ***The Health Division shall provide to a  
27 facility for the care of adults during the day:***

28       (a) ***A summary of a complaint against the facility if the  
29 investigation of the complaint by the Health Division either  
30 substantiates the complaint or is inconclusive;***

31       (b) ***A report of any investigation conducted with respect to the  
32 complaint; and***

33       (c) ***A report of any disciplinary action taken against the  
34 facility.***

35      ↳ ***The facility shall make the information available to the public  
36 pursuant to section 3 of this act.***

37      4. On or before February 1 of each odd-numbered year, the  
38 Health Division shall submit to the Director of the Legislative  
39 Counsel Bureau a written report setting forth, for the previous  
40 biennium:
