SUMMARY—Prohibits the use of certain lasers and other light sources to interfere with the operation of an aircraft.
(BDR 15-1181)

AN ACT relating to crimes; prohibiting the use of certain lasers and other light sources to interfere with the operation of an aircraft; providing a penalty; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 This bill prohibits the willful use of a laser device or other similar light source
2 with the intent to interfere with the operation of an aircraft. A violation of the
3 provisions of this bill that does not result in injury to any person on the aircraft or
4 damage to the aircraft is a misdemeanor. A violation that does result in injury to
5 any person on the aircraft or damage to the aircraft is a category E felony.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 202 of NRS is hereby amended by adding
2 thereto a new section to read as follows:

3 *1. A person shall not willfully direct at an aircraft any light
4 emitted from a laser device or other source which is capable of
5 interfering with the vision of a person operating the aircraft with
6 the intent to interfere with the operation of the aircraft.*

7 *2. A person who violates this section:*

8 *(a) If the violation does not result in injury to any person on
9 the aircraft or damage to the aircraft, is guilty of a misdemeanor.*

10 *(b) If the violation results in injury to any person on the
11 aircraft or damage to the aircraft, is guilty of a category E felony
12 and shall be punished as provided in NRS 193.130.*

13 *3. As used in this section:*

14 *(a) "Aircraft" means any contrivance intended for and capable
15 of transporting persons through airspace.*

16 *(b) "Laser device" means a device that uses the natural
17 oscillations of atoms or molecules between energy levels for
18 generating coherent electromagnetic radiation in the ultraviolet,
19 visible or infrared region of the spectrum and when discharged
20 exceeds one milliwatt continuous wave.*
