AN ACT making an appropriation for the Women’s Research
Institute of Nevada and the National Education for
Women’s Leadership program at the University of
Nevada, Las Vegas; and providing other matters properly
relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. There is hereby appropriated from the State
General Fund to the University of Nevada, Las Vegas, to fund
operational expenses for the Women’s Research Institute of Nevada
and the National Education for Women’s Leadership program which
develops civic leaders among college women:

For the Fiscal Year 2007-2008..... \$200,000
For the Fiscal Year 2008-2009..... \$200,000

Sec. 2. The sums appropriated by section 1 of this act are
available for either fiscal year. Any remaining balance of those sums

1 must not be committed for expenditure after June 30, 2009, by the
2 entity to which the appropriation is made or any entity to which
3 money from the appropriation is granted or otherwise transferred in
4 any manner, and any portion of the appropriated money remaining
5 must not be spent for any purpose after September 18, 2009, by
6 either the entity to which the money was appropriated or the entity
7 to which the money was subsequently granted or transferred, and
8 must be reverted to the State General Fund on or before
9 September 18, 2009.

10 **Sec. 3.** The appropriations made by the provisions of this act
11 are intended to finance ongoing expenditures of state agencies, and
12 the expenditures financed with those appropriations must be
13 included as base budget expenditures in the proposed budget for the
14 Executive Branch of State Government for the 2009-2011 biennium.

15 **Sec. 4.** This act becomes effective upon passage and approval.
