AN ACT making an appropriation to the Las Vegas-Clark County Urban League for a prisoner reentry program; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** 1. There is hereby appropriated from the State
- 2 General Fund to the Las Vegas-Clark County Urban League the sum
- 3 of \$3,000,000 to fund the Southern Nevada Prisoner Re-Entry
- 4 Coalition, a community-based collaboration to develop and
- 5 implement a demonstration project to provide alternatives to
- 6 incarceration for nonviolent offenders and to reintegrate prisoners
- 7 into community life.
- 8 2. Upon acceptance of the money appropriated by subsection 1,
- 9 the Las Vegas-Clark County Urban League shall:
 - 10 (a) Prepare and transmit a report to the Interim Finance
 - 11 Committee on or before December 15, 2008, that describes each
 - 12 expenditure made from the money appropriated by subsection 1
 - 13 from the date on which the money was received by the Las Vegas-
 - 14 Clark County Urban League through December 1, 2008;
 - 15 (b) Prepare and transmit a final report to the Interim Finance
 - 16 Committee on or before September 18, 2009, that describes each
 - 17 expenditure made from the money appropriated by subsection 1

1 from the date on which the money was received by the Las Vegas-
2 Clark County Urban League through June 30, 2009; and

3 (c) Upon request of the Legislative Commission, make available
4 to the Legislative Auditor any of the books, accounts, claims,
5 reports, vouchers or other records of information, confidential or
6 otherwise, of the Las Vegas-Clark County Urban League, regardless
7 of their form or location, that the Legislative Auditor deems
8 necessary to conduct an audit of the use of the money appropriated
9 pursuant to subsection 1.

10 **Sec. 2.** Any remaining balance of the appropriation made by
11 section 1 of this act must not be committed for expenditure after
12 June 30, 2009, by the entity to which the appropriation is made or
13 any entity to which the money from the appropriation is granted or
14 otherwise transferred in any manner, and any portion of the
15 appropriated money remaining must not be spent for any purpose
16 after September 18, 2009, by either the entity to which the money
17 was appropriated or the entity to which the money was subsequently
18 granted or transferred, and must be reverted to the State General
19 Fund on or before September 18, 2009.

20 **Sec. 3.** This act becomes effective upon passage and approval.
