ASSEMBLY BILL NO. 317—COMMITTEE ON WAYS AND MEANS

MARCH 14, 2007

Referred to Committee on Ways and Means

SUMMARY—Makes an appropriation to the Department of Administration for allocation to the Nevada Commission for National and Community Service for continuation of its programs dedicated to promoting citizen volunteerism. (BDR S-1440)

AN ACT making an appropriation to the Department of Administration for allocation to the Nevada Commission for National and Community Service for continuation of its programs dedicated to promoting citizen volunteerism; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** 1. There is hereby appropriated from the State
- 2 General Fund to the Department of Administration the sum of
- 3 \$365,000 for allocation to the Nevada Commission for National and
- 4 Community Service to match federal funding for continuation of its
- 5 programs dedicated to promoting citizen volunteerism.
- 6 2. Upon acceptance of the money appropriated by subsection 1
- 7 and allocated by the Department, the Commission shall:
- 8 (a) Prepare and transmit a report to the Interim Finance
- 9 Committee on or before December 15, 2008, that describes each
- 10 expenditure made from the money appropriated by subsection 1
- 11 from the date on which the money was received by the Commission
- 12 through December 1, 2008;
- 13 (b) Prepare and transmit a final report to the Interim Finance
- 14 Committee on or before September 18, 2009, that describes each

1 expenditure made from the money appropriated by subsection 1
2 from the date on which the money was received by the Commission
3 through June 30, 2009; and

4 (c) Upon request of the Legislative Commission, make available
5 to the Legislative Auditor any of the books, accounts, claims,
6 reports, vouchers or other records of information, confidential or
7 otherwise, of the Nevada Commission for National and Community
8 Service, regardless of their form or location, that the Legislative
9 Auditor deems necessary to conduct an audit of the use of the
10 money appropriated pursuant to subsection 1.

11 **Sec. 2.** Any remaining balance of the appropriation made by
12 subsection 1 of section 1 of this act must not be committed for
13 expenditure after June 30, 2009, by the entity to which the
14 appropriation is made or any entity to which the money from the
15 appropriation is granted or otherwise transferred in any manner, and
16 any portion of the appropriated money remaining must not be spent
17 for any purpose after September 18, 2009, by either the entity to
18 which the money was appropriated or the entity to which the money
19 was subsequently granted or transferred, and must be reverted to the
20 State General Fund on or before September 18, 2009.

21 **Sec. 3.** This act becomes effective upon passage and approval.
