SUMMARY—Exempts certain vehicles from inspection
requirements for the control of emissions.
(BDR 43-1185)

AN ACT relating to motor vehicles; exempting replica vehicles
from inspection requirements for the control of emissions;
and providing other matters properly relating thereto.

Legislative Counsel's Digest:

- 1 **Section 1** of this bill provides that the Department of Motor Vehicles may not
2 register more than 100 replica vehicles per year. Existing law exempts military
3 tactical vehicles from the inspection requirements required by chapter 445B of
4 NRS. (NRS 445B.759) **Section 3** of this bill defines “replica vehicles” and expands
5 the exemption to apply to replica vehicles as well.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** Chapter 482 of NRS is hereby amended by adding
2 thereto a new section to read as follows:
3 ***1. The Department may not issue a certificate of registration***
4 ***for more than 100 replica vehicles each year. The fact that the***
5 ***vehicle is to be registered as a replica vehicle must be stated in the***
6 ***application for registration.***
7 ***2. For purposes of this section, “replica vehicle” has the***
8 ***meaning ascribed to it in NRS 445B.759.***



1 **Sec. 2.** NRS 445B.759 is hereby amended to read as follows:
2 445B.759 1. The provisions of NRS 445B.700 to 445B.845,
3 inclusive, do not apply to ~~[(military)]~~ :

4 (a) *Military* tactical vehicles ~~[()]~~ ; or

5 (b) *Replica vehicles.*

6 2. As used in this section ~~[(, “military tactical vehicle”)]~~ :

7 (a) *“Military tactical vehicle”* means a motor vehicle that is:

8 ~~[(a)]~~ (1) Owned or controlled by the United States Department
9 of Defense or by a branch of the Armed Forces of the United States;
10 and

11 ~~[(b)]~~ (2) Used in combat, combat support, combat service
12 support, tactical or relief operations, or training for such operations.

13 (b) *“Replica vehicle” means any passenger car or light-duty*
14 *motor vehicle which:*

15 (1) *Has a body manufactured after 1968 which is made to*
16 *resemble a vehicle of a model manufactured before 1968;*

17 (2) *Has been altered from the original design of the*
18 *manufacturer or has a body constructed from materials which are*
19 *not original to the vehicle;*

20 (3) *Is maintained solely for occasional transportation,*
21 *including exhibitions, club activities, parades, tours or other*
22 *similar uses; and*

23 (4) *Is not used for daily transportation.*

24 ↪ *The term does not include a vehicle which has been restored to*
25 *its original design by replacing parts.*

26 **Sec. 3.** This act becomes effective on July 1, 2007.
