

ASSEMBLY BILL NO. 331—ASSEMBLYMEN HOGAN, ANDERSON,
CLABORN, DENIS, KIHUEN, MUNFORD, PARKS, PIERCE,
SEGERBLOM AND WOMACK

MARCH 15, 2007

SUMMARY—Makes various changes relating to the conservation of water. (BDR 48-915)

AN ACT relating to water; making various changes to the requirements for plans and joint plans of water conservation; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law requires each supplier of water to prepare and adopt a plan of
2 water conservation and sets forth the requirements for such a plan. Suppliers
3 of water may also adopt joint plans of water conservation with other suppliers of
4 water. (NRS 540.131, 540.141) **Section 3** of this bill requires such plans to include
5 an estimate of the amount of water that will be conserved each year as the result of
6 specified conservation measures and an analysis of how the rates proposed in the
7 plans to be charged for the use of water will maximize water conservation. Also,
8 **section 3** requires the State Engineer to review and evaluate the accuracy of the
9 estimate of the amount of water that will be conserved as a result of the adoption of
10 the plans.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 540.011 is hereby amended to read as follows:
2 540.011 1. The Legislature determines that it is the policy of
3 the State of Nevada to continue to recognize the critical nature
4 of the State's limited water resources. It is acknowledged that many
5 of the State's surface water resources are committed to existing
6 uses, under existing water rights, and that in many areas of the State

1 the available groundwater supplies have been appropriated for
2 current uses. It is the policy of the State of Nevada to recognize and
3 provide for the protection of these existing water rights. It is ~~also~~
4 the policy of the State to encourage efficient and nonwasteful use of
5 these limited supplies. *It is also the policy of the State to encourage
6 suppliers of water to establish prices for the use of water that
7 maximize water conservation with due consideration to the
8 essential service needs of customers and the economic burdens on
9 businesses, public services and low-income households.*

10 2. The Legislature further recognizes the relationship between
11 the critical nature of the State's limited water resources and the
12 increasing demands placed on these resources as the population of
13 the State continues to grow.

14 3. The Legislature further recognizes the relationship between
15 the quantity of water and the quality of water, and the necessity to
16 consider both factors simultaneously when planning the uses of
17 water.

18 4. The Legislature further recognizes the important role of
19 water resource planning and that such planning must be based upon
20 identifying current and future needs for water. The Legislature
21 determines that the purpose of the State's water resource planning is
22 to assist the State, its local governments and its citizens in
23 developing effective plans for the use of water.

24 *5. The Legislature further recognizes that many communities
25 in the arid western United States have reduced system-wide water
26 consumption to 200 gallons per person per day or less.*

27 **Sec. 2.** NRS 540.131 is hereby amended to read as follows:

28 540.131 1. Except as otherwise provided in subsection 5,
29 each supplier of water which supplies water for municipal, industrial
30 or domestic purposes shall, on or before July 1, 1992, adopt a plan
31 of water conservation based on the climate and the living conditions
32 of its service area in accordance with the provisions of NRS
33 540.141, and shall update the plan pursuant to paragraph (c) of
34 subsection 4. The provisions of the plan must apply only to the
35 supplier's property and its customers. The supplier of water shall
36 submit the plan to the Section for review by the Section pursuant to
37 subsection 3.

38 2. As part of the procedure of adopting a plan, the supplier of
39 water shall provide an opportunity for any interested person,
40 including, but not limited to, any private or public entity that
41 supplies water for municipal, industrial or domestic purposes, to
42 submit written views and recommendations on the plan.

43 3. The plan must be reviewed by the Section ~~[within 30 days]~~
44 after its submission and approved for compliance with this section
45 *and NRS 540.141* before it is adopted by the supplier of water.

1 4. The plan:

2 (a) Must be available for inspection by members of the public
3 during office hours at the offices of the supplier of water;

4 (b) May be revised from time to time to reflect the changing
5 needs and conditions of the service area. Each such revision must be
6 made available for inspection by members of the public; and

7 (c) Must be updated every 5 years and comply with the
8 requirements of this section and NRS 540.141.

9 5. Suppliers of water:

10 (a) Who are required to adopt a plan of water conservation
11 pursuant to this section; and

12 (b) Whose service areas are located in a common geographical
13 area,

14 → may adopt joint plans of water conservation based on the
15 climate and living conditions of that common geographical area.
16 Such a plan must comply with the requirements of this section and
17 NRS 540.141.

18 6. The board of county commissioners of a county, the
19 governing body of a city and the town board or board of county
20 commissioners having jurisdiction of the affairs of a town shall:

21 (a) Adopt any ordinances necessary to carry out a plan of
22 conservation adopted pursuant to this section which applies to
23 property within its jurisdiction;

24 (b) Establish a schedule of fines for the violation of any
25 ordinances adopted pursuant to this subsection; and

26 (c) Hire such employees as it deems necessary to enforce the
27 provisions of any ordinances it adopts pursuant to this subsection.

28 **Sec. 3.** NRS 540.141 is hereby amended to read as follows:

29 540.141 1. A plan or joint plan of water conservation
30 submitted to the Section for review must include provisions relating
31 to:

32 (a) Methods of public education to:

33 (1) Increase public awareness of the limited supply of water
34 in this State and the need to conserve water.

35 (2) Encourage reduction in the size of lawns and encourage
36 the use of plants that are adapted to arid and semiarid climates.

37 (b) Specific conservation measures required to meet the needs of
38 the service area, including, but not limited to, any conservation
39 measures required by law.

40 (c) The management of water to:

41 (1) Identify and reduce leakage in water supplies,
42 inaccuracies in water meters and high pressure in water supplies;
43 and

44 (2) Where applicable, increase the reuse of effluent.

1 (d) A contingency plan for drought conditions that ensures a
2 supply of potable water.

3 (e) A schedule for carrying out the plan **[H] or joint plan.**

4 (f) Measures to evaluate the effectiveness of the plan **[H] or joint
5 plan.**

6 (g) *For each conservation measure specified in the plan or
7 joint plan, an estimate of the amount of water that will be
8 conserved each year as a result of the adoption of the plan or joint
9 plan, stated in terms of gallons of water per person per day.*

10 2. A plan or joint plan submitted for review must be
11 accompanied by an analysis of **[the]**:

12 (a) *The feasibility of charging variable rates for the use of water
13 to encourage the conservation of water.*

14 (b) *How the rates that are proposed to be charged for the use
15 of water in the plan or joint plan will maximize water
16 conservation, including, without limitation, an estimate of the
17 manner in which the rates will affect consumption of water.*

18 3. **[The]** Within 30 days after the plan or joint plan is
19 submitted, the State Engineer shall review and evaluate the
20 accuracy of the estimate provided with the plan or joint plan
21 pursuant to paragraph (g) of subsection 1 and paragraph (b) of
22 subsection 2 and submit his findings to the Section.

23 4. Within 30 days after the State Engineer submits his
24 findings to the Section pursuant to subsection 3, the Section shall
25 review **[any]** the plan or joint plan **[submitted to it within 30 days
26 after its submission]** and approve the plan if it is based on the
27 climate and living conditions of the service area and complies with
28 the requirements of this section.

29 **[4.]** 5. The Chief may exempt wholesale water purveyors from
30 the provisions of this section which do not reasonably apply to
31 wholesale supply.
