AN ACT relating to the Elko Convention and Visitors Authority; revising the boundaries and composition of the Authority; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law specifies the number and qualifications of members of the Board
2 of Governors of the Elko Convention and Visitors Authority. Certain of the
3 members must reside within the boundaries of the Authority. (Elko Convention and
4 Visitors Authority Act § 8) This bill revises the boundaries of the Authority and,
5 thus, also revises the composition (membership) of the Authority. (Elko
6 Convention and Visitors Authority Act § 18)

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Section 18 of the Elko Convention and Visitors
2 Authority Act, being chapter 227, Statutes of Nevada 1975, as
3 amended by chapter 70, Statutes of Nevada 2001, at page 517, is
4 hereby amended to read as follows:

5 Sec. 18. The boundaries of the Authority **[include all**
6 **lands, except the incorporated City of Carlin and those lands**
7 **that have a current agricultural use assessment from the**
8 **county assessor of Elko County pursuant to chapter 361A of**
9 **NRS, located within the boundaries described as follows:**
10 **Beginning at the southwest corner of Elko County, and**
11 **running thence northerly and westerly along the boundary**
12 **common to Elko and Eureka Counties to its intersection with**

1 a line perpendicular to the northern boundary of the City of
2 Carlin; thence easterly along the northern boundary of the
3 City of Carlin to its extended intersection with the Cadastral
4 Survey Range Line common to Range 52 and Range 53, M.D.B. & M.; thence north along the Cadastral Survey Range
5 Line common to Range 52 and Range 53, M.D.B. & M., to its
6 intersection with Fish Creek; thence easterly to the summit of
7 Swales Mountain of the Independence Mountain Range; thence
8 northerly along the crest of the Independence
9 Mountain Range to its intersection with the Cadastral Survey
10 Township Line common to Township 43 and Township 44,
11 M.D.B. & M.; thence east along the Cadastral Survey
12 Township Line common to Township 43 and Township 44,
13 M.D.B. & M., to its intersection with the Cadastral Survey
14 Range Line common to Range 61 and Range 62, M.D.B. &
15 M.; thence south along the Cadastral Survey Range Line
16 common to Range 61 and Range 62, M.D.B. & M., to its
17 intersection with the centerline of State Route 231, also
18 known as the Angel Lake access road; thence southerly and
19 westerly along the centerline of State Route 231 to Angel
20 Lake; thence west to the crest of the East Humboldt Mountain
21 Range; thence southerly and westerly along the crest of the
22 East Humboldt Mountain Range and the Ruby Mountain
23 Range to its intersection with the southern boundary of Elko
24 County; thence west along the southern boundary of
25 Elko County to the point of beginning.] *include a portion of*
26 *Elko County westerly of the crest of the Ruby Mountain*
27 *Range, East Humboldt Mountain Range and U.S. Highway*
28 *93, excluding the incorporated City of Wells, incorporated*
29 *City of Carlin, unincorporated Town of Jackpot, Town of*
30 *Jarbidge, Town of Mountain City and the Town of*
31 *Midas/Gold Circle all located in Elko County more*
32 *particularly described as follows:*

33 *Commencing at the northwest corner of Elko County*
34 *common to the northeast corner of Humboldt County and*
35 *the Nevada and Idaho state boundary, the point of*
36 *beginning, thence southerly along the most western*
37 *boundary of Elko County to a point 30 feet northerly of and*

6 *Town of Midas/Gold Circle as shown on said official map of*
7 *Gold Circle to its intersection with a point 30 feet easterly of*
8 *and parallel to the centerline of said Elko County Road 724;*
9 *thence southeasterly along a line 30 feet easterly of and*
10 *parallel to the centerline of that portion of Elko County*
11 *Road 724 traversing to the main portion of Elko County*
12 *Road 724 to a point on a line 30 feet southerly of and*

21 *corner to Elko County and the northeast corner of said*
22 *Eureka County; thence southerly along the common*
23 *boundary of Elko County and Eureka County to a point on*
24 *the most northerly right-of-way of U.S. Interstate Highway*
25 *80; thence easterly along the most northerly right-of-way of*
26 *said U.S. Interstate Highway 80 to its intersection with the*
27 *most westerly boundary of the incorporated city limits of*
28 *Carlin; thence northerly along the western boundary of said*
29 *City of Carlin to the northwest corner of said City of Carlin;*
30 *thence easterly traversing along the most northerly*
31 *boundary of said City of Carlin to the northeast corner of*

28 *feet east of and parallel to the centerline of Elko County*

30 *parallel to the centerline of said Elko County Road 748 to*
31 *its intersection with the Town of Jarbridge boundary as*
32 *shown on the official map of the Town of Jarbridge filed in*

34 *thence traversing easterly, southerly, westerly and northerly*
35 *around the exterior boundary of the Town of Jarbridge to its*
36 *intersection with a point 30 feet west of and parallel to the*
37 *centerline of said Elko County Road 748; thence northerly*
38 *along a line 30 feet west of and parallel to the centerline of*
39 *said Elko County Road 748 to its intersection with the*
40 *northern boundary of Elko County; thence westerly along*
41 *the northern boundary of Elko County to a point on the*
42 *eastern boundary of the Duck Valley Indian Reservation;*
43 *thence southerly along the eastern boundary of said Duck*

45 *northerly right-of-way of State Route 225; thence*

southeasterly along the most northerly right-of-way of said State Route 225 to its intersection with the most westerly boundary of the Town of Mountain City as shown on the official map of Mountain City filed in the Office of the Elko County Recorder as File No. 52684; thence traversing easterly, southerly, westerly and northerly around the exterior boundary of Mountain City to its intersection with the most southerly right-of-way of said State Route 225; thence northwesterly along the most southerly right-of-way of said State Route 225 to its intersection with the eastern boundary of said Duck Valley Indian Reservation; thence southerly along the eastern boundary of said Duck Valley Indian Reservation to the southeast corner of said Duck Valley Indian Reservation; thence westerly along the southern boundary of said Duck Valley Indian Reservation to the southwest corner of said Duck Valley Indian Reservation; thence northerly along the western boundary of said Duck Valley Indian Reservation to a point on the northern boundary of Elko County; thence westerly along the northern boundary of Elko County to the northwest corner of Elko County to the point of beginning.

Sec. 2. This act becomes effective on July 1, 2007.
