

ASSEMBLY BILL NO. 35—COMMITTEE ON COMMERCE AND LABOR
(ON BEHALF OF THE BOARD OF HEARING AID SPECIALISTS)

SUMMARY—Reduces the period during which a license issued by the Board of Hearing Aid Specialists may be renewed without an examination. (BDR 54-611)

AN ACT relating to hearing aid specialists; reducing the period during which a license issued by the Board of Hearing Aid Specialists may be renewed without an examination; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

Under existing law, a person who is issued a license by the Board of Hearing Aid Specialists and who fails to pay the annual license fee or submit all information required to renew the license may have the license renewed without an examination within 5 years after the date of expiration of the license if the person complies with certain requirements and pays, in addition to the annual license fee, the lapsed renewal fee for each year or portion of a year that the person has not paid the annual license fee. (NRS 637A.200, 637A.210)

This bill reduces the period during which the person may have the expired license renewed without an examination from 5 years to 1 year.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 637A.200 is hereby amended to read as
2 follows:

3 637A.200 1. Licenses expire on June 30 next following the
4 date of issuance.

5 2. A licensee may have his license renewed for 1 year
6 beginning on July 1, by:

7 (a) Showing that he has fulfilled any requirements established
8 by the Board for continuing education;

9 (b) Paying the annual license fee; and

10 (c) Submitting all information required to complete the renewal.

11 3. A licensee who fails to pay the annual license fee or submit
12 all information required to complete the renewal may have his
13 license renewed without *an* examination within **[5 years] 1 year**
14 after the date of expiration by:

15 (a) Complying with the requirements of subsection 2; and

16 (b) Paying the lapsed renewal fee in addition to the annual
17 license fee.

18 **Sec. 2.** NRS 637A.210 is hereby amended to read as follows:
