SUMMARY—Prohibits the issuance of certain work cards to persons who have been convicted of certain crimes.

AN ACT relating to work cards; prohibiting the issuance of work cards for employment at certain kinds of dwelling units to persons who have been convicted of certain crimes; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

- 1 Under existing law, a landlord of dwelling units intended and operated
2 exclusively for persons 55 years of age and older is prohibited from employing
3 persons to perform certain work on the premises unless the person has obtained a
4 work card from the county sheriff. (NRS 118A.335) This bill prohibits the sheriff
5 from issuing such a work card to a person who has been convicted of certain
6 crimes, including a felony, a sexual offense, certain crimes against the elderly or
7 other vulnerable persons, certain batteries, certain thefts or certain violations of
8 state or federal drug laws.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 118A.335 is hereby amended to read as
2 follows:

3 118A.335 1. Except as otherwise provided in subsection [4,
4 **5**, a landlord of dwelling units intended and operated exclusively for
5 persons 55 years of age and older may not employ any person who
6 will work 36 hours or more per week and who will have access to
7 all dwelling units to perform work on the premises unless the person
8 has obtained a work card issued pursuant to subsection 2 by the
9 sheriff of the county in which the dwelling units are located and
10 renewed that work card as necessary.

11 2. The sheriff of a county shall issue a work card to each
12 person who is required by this section to obtain a work card and
13 who complies with the requirements established by the sheriff for
14 the issuance of such a card. A work card issued pursuant to this
15 section must be renewed:

16 (a) Every 5 years; and

17 (b) Whenever the person changes his employment to perform
18 work for an employer other than the employer for which his current
19 work card was issued.

20 3. If the sheriff of a county requires an applicant for a work
21 card to be investigated:

22 (a) The applicant must submit with his application a complete
23 set of his fingerprints and written permission authorizing the sheriff
24 to forward the fingerprints to the Central Repository for Nevada
25 Records of Criminal History for submission to the Federal Bureau
26 of Investigation for its report.

27 (b) The sheriff may submit the fingerprints to the Central
28 Repository for Nevada Records of Criminal History for submission
29 to the Federal Bureau of Investigation to determine the criminal
30 history of the applicant.

31 (c) The sheriff shall issue a temporary work card pending the
32 determination of the criminal history of the applicant by the Federal
33 Bureau of Investigation.

34 4. ***The sheriff shall not issue a work card to any person who:***

35 (a) ***Has been convicted of a felony;***

36 (b) ***Has been convicted of a sexual offense;***

37 (c) ***Has been convicted of a crime against any person who is 60***
38 ***years of age or older or against a vulnerable person for which an***
39 ***additional term of imprisonment was imposed pursuant to NRS***
40 ***193.167 or the laws of any other jurisdiction;***

41 (d) ***Has been convicted of a battery punishable as a gross***
42 ***misdemeanor; or***

1 (e) *Within the immediately preceding 5 years:*

2 (1) *Has been convicted of a theft; or*

3 (2) *Has been convicted of a violation of any state or federal*

4 *law regulating the possession, distribution or use of a controlled*
5 *substance.*

6 5. The following persons are not required to obtain a work card
7 pursuant to this section:

8 (a) A person who holds a permit to engage in property
9 management pursuant to chapter 645 of NRS.

10 (b) An independent contractor. As used in this paragraph,
11 “independent contractor” means a person who performs services for
12 a fixed price according to his own methods and without subjection
13 to the supervision or control of the landlord, except as to the results
14 of the work, and not as to the means by which the services are
15 accomplished.

16 (c) An offender in the course and scope of his employment in a
17 work program directed by the warden, sheriff, administrator or other
18 person responsible for administering a prison, jail or other detention
19 facility.

20 (d) A person performing work through a court-assigned
21 restitution or community-service program.

22 6. *As used in this section, unless the context otherwise*
23 *requires:*

24 (a) *“Sexual offense” has the meaning ascribed to it in*
25 *NRS 179D.410.*

26 (b) *“Vulnerable person” has the meaning ascribed to it in*
27 *NRS 200.5092.*
