AN ACT relating to hearing aid specialists; increasing the maximum allowable amount of certain fees charged by the Board of Hearing Aid Specialists; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

- 1 This bill increases the maximum allowable amount that the Board of Hearing  
2 Aid Specialists may charge for each fee other than the duplicate license fee for a  
3 license as a hearing aid specialist. The maximum allowable amount of that fee  
4 remains unchanged at \$20.
