

ASSEMBLY BILL NO. 39—COMMITTEE ON TRANSPORTATION

(ON BEHALF OF THE DEPARTMENT OF MOTOR VEHICLES)

SUMMARY—Revises the definition of “special mobile equipment.” (BDR 43-619)

AN ACT relating to motor vehicles; revising the definition of “special mobile equipment”; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 **Sections 1-4** of this bill clarify that concrete pumpers, cranes and drill rigs with
2 highway-rated tires are not considered special mobile equipment in certain
3 circumstances. **Sections 1-4** also require the Department of Motor Vehicles to
4 define, by regulation, “incidentally operated or moved upon a highway” for
5 purposes of those sections of NRS that use the phrase in the definition of “special
6 mobile equipment.” (NRS 366.085, 482.123, 484.173, 706.121)

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 482.123 is hereby amended to read as follows:
2 482.123 1. “Special mobile equipment” means every *motor*
3 vehicle not designed or used primarily for the transportation of
4 persons or property and only incidentally operated or moved upon a
5 highway, including, but not limited to, scoopmobiles, forklifts,
6 ditch-digging apparatus, well-boring apparatus and road
7 construction and maintenance machinery such as asphalt graders,
8 bituminous mixers, bucket loaders, tractors other than truck tractors,
9 leveling graders, finishing machines, motor graders, road rollers,

1 scarifiers, earth-moving carryalls and scrapers, power shovels and
2 draglines, ~~and self-propelled cranes~~ and earth-moving equipment.

3 2. "Special mobile equipment" does not include house trailers,
4 dump trucks, truck-mounted transit mixers, *concrete pumps,*
5 *cranes or drill rigs with highway-rated tires* or other vehicles
6 designed for the transportation of persons or property to which
7 machinery has been attached.

8 3. The Director may make ~~[an individual]~~ *the final*
9 determination as to whether ~~[any particular vehicle or kind of]~~ *a*

14 **Sec. 2.** Chapter 484 of NRS is hereby amended by adding
15 thereto a new section to read as follows:

16 *The Department may adopt regulations relating to the*
17 *administration and enforcement of provisions in this chapter*
18 *pertaining to special mobile equipment, as defined in*
19 *NRS 484.173.*

20 **Sec. 3.** NRS 484.173 is hereby amended to read as follows:

21 484.173 1. "Special mobile equipment" means every *motor*
22 vehicle not designed or used primarily for the transportation of
23 persons or property and only incidentally operated or moved upon a
24 highway, including but not limited to scoomobiles, forklifts, ditch-
25 digging apparatus, well-boring apparatus and road construction and
26 maintenance machinery such as asphalt graders, bituminous mixers,
27 bucket loaders, tractors other than truck-tractors, leveling graders,
28 finishing machines, motor graders, road rollers, scarifiers, earth-
29 moving carryalls and scrapers, power shovels and draglines, ~~and~~
30 ~~self-propelled cranes~~ and earth-moving equipment.

31 2. "Special mobile equipment" does not include house trailers,
32 dump trucks, truck-mounted transit mixers, *concrete pumps,*

6 finishing machines, motor graders, road rollers, scarifiers, earth-

9 2. "Special mobile equipment" does not include house trailers,
