AN ACT making an appropriation to the Anthony L. Pollard Foundation for construction of the Carter G. Woodson Library in west Las Vegas; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** 1. There is hereby appropriated from the State
2 General Fund to the Anthony L. Pollard Foundation the sum of
3 \$5,000,000 for the design, planning and construction of the Carter
4 G. Woodson Library to promote cultural awareness and appreciation
5 in west Las Vegas.

6 2. Upon acceptance of the money appropriated by subsection 1,
7 the Anthony L. Pollard Foundation shall:

8 (a) Prepare and transmit a report to the Interim Finance
9 Committee on or before December 15, 2010, that describes each
10 expenditure made from the money appropriated by subsection 1
11 from the date on which the money was received by the Anthony L.
12 Pollard Foundation through December 1, 2010;

13 (b) Prepare and transmit a final report to the Interim Finance
14 Committee on or before September 16, 2011, that describes each
15 expenditure made from the money appropriated by subsection 1
16 from the date on which the money was received by the Anthony L.
17 Pollard Foundation through June 30, 2011; and

1 (c) Upon request of the Legislative Commission, make available
2 to the Legislative Auditor any of the books, accounts, claims,
3 reports, vouchers or other records of information, confidential or
4 otherwise, of the Anthony L. Pollard Foundation, regardless of their
5 form or location, that the Legislative Auditor deems necessary to
6 conduct an audit of the use of the money appropriated pursuant to
7 subsection 1.

8 **Sec. 2.** Any remaining balance of the appropriation made by
9 subsection 1 of section 1 of this act must not be committed for
10 expenditure after June 30, 2011, by the entity to which the
11 appropriation is made or any entity to which money from the
12 appropriation is granted or otherwise transferred in any manner, and
13 any portion of the appropriated money remaining must not be spent
14 for any purpose after September 16, 2011, by either the entity to
15 which the money was appropriated or the entity to which the money
16 was subsequently granted or transferred, and must be reverted to the
17 State General Fund on or before September 16, 2011.

18 **Sec. 3.** This act becomes effective upon passage and approval.
