ASSEMBLY BILL NO. 402—COMMITTEE ON WAYS AND MEANS

AN ACT making an appropriation to the City of Las Vegas for allocation to the Las Vegas Regional Clean Cities Coalition for an educational initiative; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1       **Section 1.** 1. There is hereby appropriated from the State  
2 General Fund to the City of Las Vegas for allocation to the Las  
3 Vegas Regional Clean Cities Coalition for an educational initiative  
4 aimed at informing Nevada residents of the tax credits available to  
5 them when purchasing vehicles that run on alternative fuels:

6              For the Fiscal Year 2007-2008.....\$250,000  
7              For the Fiscal Year 2008-2009.....\$250,000

8        2. Upon acceptance of the money appropriated by subsection 1  
9 and allocated to the Las Vegas Regional Clean Cities Coalition, the  
10 Coalition shall:

11              (a) Prepare and transmit a report to the Interim Finance  
12 Committee on or before December 15, 2008, that describes each  
13 expenditure made from the money appropriated by subsection 1  
14 from the date on which the money was received by the Coalition  
15 through December 1, 2008;

1       (b) Prepare and transmit a final report to the Interim Finance  
2 Committee on or before September 18, 2009, that describes each  
3 expenditure made from the money appropriated by subsection 1  
4 from the date on which the money was received by the Coalition  
5 through June 30, 2009; and

6       (c) Upon request of the Legislative Commission, make available  
7 to the Legislative Auditor any of the books, accounts, claims,  
8 reports, vouchers or other records of information, confidential or  
9 otherwise, of the Coalition, regardless of their form or location, that  
10 the Legislative Auditor deems necessary to conduct an audit of the  
11 use of the money appropriated pursuant to subsection 1.

12      **Sec. 2.** The sums appropriated by section 1 of this act are  
13 available for either fiscal year. Any remaining balance of those sums  
14 must not be committed for expenditure after June 30, 2009, by the  
15 entity to which the appropriation is made or any entity to which the  
16 money from the appropriation is granted or otherwise transferred in  
17 any manner, and any portion of the appropriated money remaining  
18 must not be spent for any purpose after September 18, 2009, by  
19 either the entity to which the money was appropriated or the entity  
20 to which the money was subsequently granted or transferred,  
21 and must be reverted to the State General Fund on or before  
22 September 18, 2009.

23      **Sec. 3.** This act becomes effective on July 1, 2007.
