SUMMARY—Revises provisions governing taxes imposed on financial institutions. (BDR 32-1332)

EXPLANATION – Matter in **bolded italics** is new; matter between brackets ~~omitted material~~ is material to be omitted.

AN ACT relating to taxation; repealing the excise tax imposed on banks that is based on the number of branch offices maintained in this State; reducing the rate of tax imposed on financial institutions that is based on wages paid to employees; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

- 1 Existing law imposes a payroll tax on financial institutions at a rate that is
2 higher than the payroll tax imposed on other businesses and an excise tax on the
3 branch offices of a bank that is not imposed on other businesses. This bill repeals
4 the higher payroll tax on July 1, 2009, and the additional branch tax on July 1,
5 2007, and makes financial institutions subject to the same payroll tax as other
6 businesses as of July 1, 2009. (NRS 363A.120, 363A.130)

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN

- 1 **Section 1.** NRS 360.297 is hereby amended to read as follows:
2 360.297 1. A responsible person who fails to collect or pay to
3 the Department any tax or fee imposed by this chapter, chapter
4 ~~363A,~~ 363B, 368A, 369, 370, 372 or 374 of NRS, NRS 444A.090
5 or 482.313, or chapter 680B of NRS, or who attempts to evade the
6 payment of any such tax or fee, is jointly and severally liable with
7 any other person who is required to pay such a tax or fee for the tax
8 or fee owed plus interest and all applicable penalties. The

1 responsible person shall pay the tax or fee upon notice from the
2 Department that it is due.

3 2. As used in this section, "responsible person" includes:

4 (a) An officer or employee of a corporation; and

5 (b) A member or employee of a partnership or limited-liability
6 company,

7 ↳ whose job or duty it is to collect, account for or pay to the
8 Department any tax or fee imposed by this chapter, chapter ~~363A,~~
9 363B, 368A, 369, 370, 372 or 374 of NRS, NRS 444A.090 or
10 482.313, or chapter 680B of NRS.

11 **Sec. 2.** NRS 360.300 is hereby amended to read as follows:

12 360.300 1. If a person fails to file a return or the Department
13 is not satisfied with the return or returns of any tax, contribution or
14 premium or amount of tax, contribution or premium required to be
15 paid to the State by any person, in accordance with the applicable
16 provisions of this chapter, chapter 360B, 362, ~~363A,~~ 363B, 369,
17 370, 372, 372A, 374, 377, 377A or 444A of NRS, NRS 482.313, or
18 chapter 585 or 680B of NRS as administered or audited by the
19 Department, it may compute and determine the amount required to
20 be paid upon the basis of:

21 (a) The facts contained in the return;

22 (b) Any information within its possession or that may come into
23 its possession; or

24 (c) Reasonable estimates of the amount.

25 2. One or more deficiency determinations may be made with
26 respect to the amount due for one or for more than one period.

27 3. In making its determination of the amount required to be
28 paid, the Department shall impose interest on the amount of tax
29 determined to be due, calculated at the rate and in the manner set
30 forth in NRS 360.417, unless a different rate of interest is
31 specifically provided by statute.

32 4. The Department shall impose a penalty of 10 percent in
33 addition to the amount of a determination that is made in the case of
34 the failure of a person to file a return with the Department.

35 5. When a business is discontinued, a determination may be
36 made at any time thereafter within the time prescribed in NRS
37 360.355 as to liability arising out of that business, irrespective of
38 whether the determination is issued before the due date of the
39 liability.

40 **Sec. 3.** NRS 360.417 is hereby amended to read as follows:

41 360.417 Except as otherwise provided in NRS 360.232 and
42 360.320, and unless a different penalty or rate of interest is
43 specifically provided by statute, any person who fails to pay any tax
44 provided for in chapter 362, ~~363A,~~ 363B, 369, 370, 372, 374, 377,
45 377A, 444A or 585 of NRS, or any fee provided for in NRS



1 482.313, to the State or a county within the time required, shall pay
2 a penalty of not more than 10 percent of the amount of the tax or fee
3 which is owed, as determined by the Department, in addition to the
4 tax or fee, plus interest at the rate of 1 percent per month, or fraction
5 of a month, from the last day of the month following the period for
6 which the amount or any portion of the amount should have been
7 reported until the date of payment. The amount of any penalty
8 imposed must be based on a graduated schedule adopted by the
9 Nevada Tax Commission which takes into consideration the length

11 **Sec. 4.** NRS 360.419 is hereby amended to read as follows:

12 360.419 1. If the Executive Director or a designated hearing
13 officer finds that the failure of a person to make a timely return or
14 payment of a tax imposed pursuant to NRS 361.320 or chapter
15 361A, 362, ~~363A,~~ 363B, 369, 370, 372, 372A, 374, 375A, 375B,
16 376A, 377 or 377A of NRS, is the result of circumstances beyond
17 his control and occurred despite the exercise of ordinary care and
18 without intent, the Department may relieve him of all or part of any
19 interest or penalty, or both.

20 2. A person seeking this relief must file with the Department a
21 statement under oath setting forth the facts upon which he bases his
22 claim.

23 3. The Department shall disclose, upon the request of any
24 person:

25 (a) The name of the person to whom relief was granted; and

26 (b) The amount of the relief.

27 4. The Executive Director or a designated hearing officer shall
28 act upon the request of a taxpayer seeking relief pursuant to NRS
29 361.4835 which is deferred by a county treasurer or county assessor.

30 **Sec. 5.** NRS 360.510 is hereby amended to read as follows:

31 360.510 1. If any person is delinquent in the payment of any
32 tax or fee administered by the Department or if a determination has
33 been made against him which remains unpaid, the Department may:

34 (a) Not later than 3 years after the payment became delinquent
35 or the determination became final; or

36 (b) Not later than 6 years after the last recording of an abstract
37 of judgment or of a certificate constituting a lien for tax owed,

38 ➤ give a notice of the delinquency and a demand to transmit
39 personally or by registered or certified mail to any person,
40 including, without limitation, any officer or department of this State
41 or any political subdivision or agency of this State, who has in his
42 possession or under his control any credits or other personal
43 property belonging to the delinquent, or owing any debts to the
44 delinquent or person against whom a determination has been made
45 which remains unpaid, or owing any debts to the delinquent or that



1 person. In the case of any state officer, department or agency, the
2 notice must be given to the officer, department or agency before
3 the Department presents the claim of the delinquent taxpayer to the
4 State Controller.

5 2. A state officer, department or agency which receives such a
6 notice may satisfy any debt owed to it by that person before it
7 honors the notice of the Department.

8 3. After receiving the demand to transmit, the person notified
9 by the demand may not transfer or otherwise dispose of the credits,
10 other personal property, or debts in his possession or under his
11 control at the time he received the notice until the Department
12 consents to a transfer or other disposition.

13 4. Every person notified by a demand to transmit shall, within
14 10 days after receipt of the demand to transmit, inform the
15 Department of and transmit to the Department all such credits, other
16 personal property or debts in his possession, under his control or
17 owing by him within the time and in the manner requested by the
18 Department. Except as otherwise provided in subsection 5, no
19 further notice is required to be served to that person.

20 5. If the property of the delinquent taxpayer consists of a series
21 of payments owed to him, the person who owes or controls the
22 payments shall transmit the payments to the Department until
23 otherwise notified by the Department. If the debt of the delinquent
24 taxpayer is not paid within 1 year after the Department issued the
25 original demand to transmit, the Department shall issue another
26 demand to transmit to the person responsible for making the
27 payments informing him to continue to transmit payments to
28 the Department or that his duty to transmit the payments to the
29 Department has ceased.

30 6. If the notice of the delinquency seeks to prevent the transfer
31 or other disposition of a deposit in a bank or credit union or other
32 credits or personal property in the possession or under the control of
33 a bank, credit union or other depository institution, the notice must
34 be delivered or mailed to any branch or office of the bank, credit
35 union or other depository institution at which the deposit is carried
36 or at which the credits or personal property is held.

37 7. If any person notified by the notice of the delinquency
38 makes any transfer or other disposition of the property or debts
39 required to be withheld or transmitted, to the extent of the value of
40 the property or the amount of the debts thus transferred or paid, he is
41 liable to the State for any indebtedness due pursuant to this chapter,
42 or chapter 360B, 362, ~~363A,~~ 363B, 369, 370, 372, 372A, 374, 377,
43 377A or 444A of NRS, NRS 482.313, or chapter 585 or 680B of
44 NRS from the person with respect to whose obligation the notice
45 was given if solely by reason of the transfer or other disposition the

3 **Sec. 6.** NRS 363B.030 is hereby amended to read as follows:

4 363B.030 "Employer" means any employer who is required to
5 pay a contribution pursuant to NRS 612.535 for any calendar quarter
6 with respect to any business activity of the employer, except ~~the~~
7 ~~financial institution,~~ an Indian tribe, a nonprofit organization, a
8 political subdivision or any person who does not supply a product or
9 service, but who only consumes a service. For the purposes of this
10 section:

20 **Sec. 7.** NRS 90.420 is hereby amended to read as follows:

21 90.420 1. The Administrator by order may deny, suspend or
22 revoke any license, fine any licensed person, limit the activities
23 governed by this chapter that an applicant or licensed person may
24 perform in this State, bar an applicant or licensed person from
25 association with a licensed broker-dealer or investment adviser or
26 bar from employment with a licensed broker-dealer or investment
27 adviser a person who is a partner, officer, director, sales
28 representative, investment adviser or representative of an investment
29 adviser, or a person occupying a similar status or performing a
30 similar function for an applicant or licensed person, if the
31 Administrator finds that the order is in the public interest and that
32 the applicant or licensed person or, in the case of a broker-dealer or
33 investment adviser, any partner, officer, director, sales
34 representative, investment adviser, representative of an investment
35 adviser, or person occupying a similar status or performing similar
36 functions or any person directly or indirectly controlling the broker-
37 dealer or investment adviser:

38 (a) Has filed an application for licensing with the Administrator
39 which, as of its effective date, or as of any date after filing in the
40 case of an order denying effectiveness, was incomplete in a material
41 respect or contained a statement that was, in light of the
42 circumstances under which it was made, false or misleading with
43 respect to a material fact;



(b) Has violated or failed to comply with a provision of this chapter as now or formerly in effect or a regulation or order adopted or issued under this chapter;

(c) Is the subject of an adjudication or determination after notice and opportunity for hearing, within the last 5 years by a securities agency or administrator of another state or a court of competent jurisdiction that the person has violated the Securities Act of 1933, the Securities Exchange Act of 1934, the Investment Advisers Act of 1940, the Investment Company Act of 1940, the Commodity Exchange Act or the securities law of any other state, but only if the acts constituting the violation of that state's law would constitute a violation of this chapter had the acts taken place in this State;

(d) Within the last 10 years has been convicted of a felony or misdemeanor which the Administrator finds:

(1) Involves the purchase or sale of a security, taking a false oath, making a false report, bribery, perjury, burglary, robbery or conspiracy to commit any of the foregoing offenses;

(2) Arises out of the conduct of business as a broker-dealer, investment adviser, depository institution, insurance company or fiduciary; or

(3) Involves the larceny, theft, robbery, extortion, forgery, counterfeiting, fraudulent concealment, embezzlement, fraudulent conversion or misappropriation of money or securities or conspiracy to commit any of the foregoing offenses;

(e) Is or has been permanently or temporarily enjoined by any court of competent jurisdiction, unless the order has been vacated, from acting as an investment adviser, representative of an investment adviser, underwriter, broker-dealer or as an affiliated person or employee of an investment company, depository institution or insurance company or from engaging in or continuing any conduct or practice in connection with any of the foregoing activities or in connection with the purchase or sale of a security;

(f) Is or has been the subject of an order of the Administrator, unless the order has been vacated, denying, suspending or revoking his license as a broker-dealer, sales representative, investment adviser or representative of an investment adviser;

(g) Is or has been the subject of any of the following orders which were issued within the last 5 years, unless the order has been vacated:

(1) An order by the securities agency or administrator of another state, Canadian province or territory or by the Securities and Exchange Commission or a comparable regulatory agency of another country, entered after notice and opportunity for hearing, denying, suspending or revoking the person's license as a broker-

1 dealer, sales representative, investment adviser or representative of
2 an investment adviser;

3 (2) A suspension or expulsion from membership in or
4 association with a member of a self-regulatory organization;

5 (3) An order of the United States Postal Service relating to
6 fraud;

7 (4) An order to cease and desist entered after notice and
8 opportunity for hearing by the Administrator, the securities agency
9 or administrator of another state, Canadian province or territory, the
10 Securities and Exchange Commission or a comparable regulatory
11 agency of another country, or the Commodity Futures Trading
12 Commission; or

13 (5) An order by the Commodity Futures Trading
14 Commission denying, suspending or revoking registration under the
15 Commodity Exchange Act;

16 (h) Has engaged in unethical or dishonest practices in the
17 securities business;

18 (i) Is insolvent, either in the sense that liabilities exceed assets or
19 in the sense that obligations cannot be met as they mature, but the
20 Administrator may not enter an order against a broker-dealer or
21 investment adviser under this paragraph without a finding of
22 insolvency as to the broker-dealer or investment adviser;

23 (j) Has failed to pay a tax as required pursuant to the provisions
24 of chapter ~~363A~~ 363B of NRS;

25 (k) Is determined by the Administrator , in compliance with
26 NRS 90.430 , not to be qualified on the basis of lack of training,
27 experience and knowledge of the securities business; or

28 (l) Has failed reasonably to supervise a sales representative,
29 employee or representative of an investment adviser.

30 2. The Administrator may not institute a proceeding on the
31 basis of a fact or transaction known to the director when the license
32 became effective unless the proceeding is instituted within 90 days
33 after issuance of the license.

34 3. If the Administrator finds that an applicant or licensed
35 person is no longer in existence or has ceased to do business as a
36 broker-dealer, sales representative, investment adviser or
37 representative of an investment adviser or is adjudicated mentally
38 incompetent or subjected to the control of a committee, conservator
39 or guardian or cannot be located after reasonable search, the
40 Administrator may by order deny the application or revoke the
41 license.

42 **Sec. 8.** NRS 90.730 is hereby amended to read as follows:

43 90.730 1. Except as otherwise provided in subsection 2,
44 information and records filed with or obtained by the Administrator
45 are public information and are available for public examination.



2. Except as otherwise provided in subsections 3 and 4, the following information and records do not constitute public information under subsection 1 and are confidential:

(a) Information or records obtained by the Administrator in connection with an investigation concerning possible violations of this chapter; and

(b) Information or records filed with the Administrator in connection with a registration statement filed under this chapter or a report under NRS 90.390 which constitute trade secrets or commercial or financial information of a person for which that person is entitled to and has asserted a claim of privilege or confidentiality authorized by law.

3. The Administrator may submit any information or evidence obtained in connection with an investigation to the:

(a) Attorney General or appropriate district attorney for the purpose of prosecuting a criminal action under this chapter; and

(b) Department of Taxation for its use in carrying out the provisions of chapter ~~363A~~ 363B of NRS.

4. The Administrator may disclose any information obtained in connection with an investigation pursuant to NRS 90.620 to the agencies and administrators specified in subsection 1 of NRS 90.740 but only if disclosure is provided for the purpose of a civil, administrative or criminal investigation or proceeding, and the receiving agency or administrator represents in writing that under applicable law protections exist to preserve the integrity, confidentiality and security of the information.

5. This chapter does not create any privilege or diminish any privilege existing at common law, by statute, regulation or otherwise.

Sec. 9. NRS 604A.820 is hereby amended to read as follows:

604A.820 1. If the Commissioner has reason to believe that grounds for revocation or suspension of a license exist, he shall give 20 days' written notice to the licensee stating the contemplated action and, in general, the grounds therefor and set a date for a hearing.

2. At the conclusion of a hearing, the Commissioner shall:

(a) Enter a written order either dismissing the charges, revoking the license or suspending the license for a period of not more than 60 days, which period must include any prior temporary suspension. The Commissioner shall send a copy of the order to the licensee by registered or certified mail.

(b) Impose upon the licensee an administrative fine of not more than \$10,000 for each violation by the licensee of any provision of this chapter or any regulation adopted pursuant thereto.



(c) If a fine is imposed pursuant to this section, enter such order as is necessary to recover the costs of the proceeding, including his investigative costs and attorney's fees.

3. The grounds for revocation or suspension of a license are that:

(a) The licensee has failed to pay the annual license fee;

(b) The licensee, either knowingly or without any exercise of due care to prevent it, has violated any provision of this chapter or any lawful regulation adopted pursuant thereto;

(c) The licensee has failed to pay a tax as required pursuant to the provisions of chapter ~~363A~~ 363B of NRS;

(d) Any fact or condition exists which would have justified the Commissioner in denying the licensee's original application for a license pursuant to the provisions of this chapter; or

(e) The licensee:

(1) Failed to open an office for the conduct of the business authorized by his license within 180 days after the date his license was issued; or

(2) Has failed to remain open for the conduct of the business for a period of 180 days without good cause therefor.

4. Any revocation or suspension applies only to the license granted to a person for the particular office for which grounds for revocation or suspension exist.

5. An order suspending or revoking a license becomes effective 5 days after being entered unless the order specifies otherwise or a stay is granted.

Sec. 10. NRS 612.265 is hereby amended to read as follows:

612.265 1. Except as otherwise provided in this section, information obtained from any employing unit or person pursuant to the administration of this chapter and any determination as to the benefit rights of any person is confidential and may not be disclosed or be open to public inspection in any manner which would reveal the person's or employing unit's identity.

2. Any claimant or his legal representative is entitled to information from the records of the Division, to the extent necessary for the proper presentation of his claim in any proceeding pursuant to this chapter. A claimant or an employing unit is not entitled to information from the records of the Division for any other purpose.

3. Subject to such restrictions as the Administrator may by regulation prescribe, the information obtained by the Division may be made available to:

(a) Any agency of this or any other state or any federal agency charged with the administration or enforcement of laws relating to unemployment compensation, public assistance, workers'



1 compensation or labor and industrial relations, or the maintenance
2 of a system of public employment offices;

3 (b) Any state or local agency for the enforcement of child
4 support;

5 (c) The Internal Revenue Service of the Department of the
6 Treasury;

7 (d) The Department of Taxation; and

8 (e) The State Contractors' Board in the performance of its duties
9 to enforce the provisions of chapter 624 of NRS.

10 ➔ Information obtained in connection with the administration of the
11 **State** Employment Service may be made available to persons or
12 agencies for purposes appropriate to the operation of a public
13 employment service or a public assistance program.

14 4. Upon written request made by a public officer of a local
15 government, the Administrator shall furnish from the records of the
16 Division the name, address and place of employment of any person
17 listed in the records of employment of the Division. The request
18 must set forth the social security number of the person about whom
19 the request is made and contain a statement signed by proper
20 authority of the local government certifying that the request is made
21 to allow the proper authority to enforce a law to recover a debt or
22 obligation owed to the local government. The information obtained
23 by the local government is confidential and may not be used or
24 disclosed for any purpose other than the collection of a debt or
25 obligation owed to that local government. The Administrator may
26 charge a reasonable fee for the cost of providing the requested
27 information.

28 5. The Administrator may publish or otherwise provide
29 information on the names of employers, their addresses, their type
30 or class of business or industry, and the approximate number of
31 employees employed by each such employer, if the information
32 released will assist unemployed persons to obtain employment or
33 will be generally useful in developing and diversifying the economic
34 interests of this State. Upon request by a state agency which is able
35 to demonstrate that its intended use of the information will benefit
36 the residents of this State, the Administrator may, in addition to the
37 information listed in this subsection, disclose the number of
38 employees employed by each employer and the total wages paid by
39 each employer. The Administrator may charge a fee to cover the
40 actual costs of any administrative expenses relating to the disclosure
41 of this information to a state agency. The Administrator may require
42 the state agency to certify in writing that the agency will take all
43 actions necessary to maintain the confidentiality of the information
44 and prevent its unauthorized disclosure.

6. Upon request therefor the Administrator shall furnish to any agency of the United States charged with the administration of public works or assistance through public employment, and may furnish to any state agency similarly charged, the name, address, ordinary occupation and employment status of each recipient of benefits and the recipient's rights to further benefits pursuant to this chapter.

7. To further a current criminal investigation, the chief executive officer of any law enforcement agency of this State may submit a written request to the Administrator that he furnish, from the records of the Division, the name, address and place of employment of any person listed in the records of employment of the Division. The request must set forth the social security number of the person about whom the request is made and contain a statement signed by the chief executive officer certifying that the request is made to further a criminal investigation currently being conducted by the agency. Upon receipt of such a request, the Administrator shall furnish the information requested. He may charge a fee to cover the actual costs of any related administrative expenses.

8. In addition to the provisions of subsection 5, the Administrator shall provide lists containing the names and addresses of employers, and information regarding the wages paid by each employer to the Department of Taxation, upon request, for use in verifying returns for the ~~{taxes}~~ tax imposed pursuant to ~~{chapters 363A and}~~ chapter 363B of NRS. The Administrator may charge a fee to cover the actual costs of any related administrative expenses.

9. A private carrier that provides industrial insurance in this State shall submit to the Administrator a list containing the name of each person who received benefits pursuant to chapters 616A to 616D, inclusive, or 617 of NRS during the preceding month and request that he compare the information so provided with the records of the Division regarding persons claiming benefits pursuant to chapter 612 of NRS for the same period. The information submitted by the private carrier must be in a form determined by the Administrator and must contain the social security number of each such person. Upon receipt of the request, the Administrator shall make such a comparison and, if it appears from the information submitted that a person is simultaneously claiming benefits under chapter 612 of NRS and under chapters 616A to 616D, inclusive, or 617 of NRS, the Administrator shall notify the Attorney General or any other appropriate law enforcement agency. The Administrator shall charge a fee to cover the actual costs of any related administrative expenses.



10. The Administrator may request the Comptroller of the Currency of the United States to cause an examination of the correctness of any return or report of any national banking association rendered pursuant to the provisions of this chapter, and may in connection with the request transmit any such report or return to the Comptroller of the Currency of the United States as provided in Section 3305(c) of the Internal Revenue Code of 1954.

11. If any employee or member of the Board of Review, the Administrator or any employee of the Administrator, in violation of the provisions of this section, discloses information obtained from any employing unit or person in the administration of this chapter, or if any person who has obtained a list of applicants for work, or of claimants or recipients of benefits pursuant to this chapter uses or permits the use of the list for any political purpose, he is guilty of a gross misdemeanor.

12. All letters, reports or communications of any kind, oral or written, from the employer or employee to each other or to the Division or any of its agents, representatives or employees are privileged and must not be the subject matter or basis for any lawsuit if the letter, report or communication is written, sent, delivered or prepared pursuant to the requirements of this chapter.

Sec. 11. NRS 616B.012 is hereby amended to read as follows:

616B.012 1. Except as otherwise provided in this section and in NRS 616B.015, 616B.021 and 616C.205, information obtained from any insurer, employer or employee is confidential and may not be disclosed or be open to public inspection in any manner which would reveal the person's identity.

2. Any claimant or his legal representative is entitled to information from the records of the insurer, to the extent necessary for the proper presentation of a claim in any proceeding under chapters 616A to 616D, inclusive, or chapter 617 of NRS.

3. The Division and Administrator are entitled to information from the records of the insurer which is necessary for the performance of their duties. The Administrator may, by regulation, prescribe the manner in which otherwise confidential information may be made available to:

(a) Any agency of this or any other state charged with the administration or enforcement of laws relating to industrial insurance, unemployment compensation, public assistance or labor law and industrial relations;

(b) Any state or local agency for the enforcement of child support;

11. Improperly using notes or other reference material to complete an examination for a license related to insurance.

12. Knowingly accepting business related to insurance from an unlicensed person.

13. Failing to comply with an administrative or judicial order imposing an obligation of child support.

14. Failing to pay a tax as required pursuant to the provisions of chapter ~~[363A]~~ 363B of NRS.

Sec. 23. NRS 687A.130 is hereby amended to read as follows:

687A.130 The Association is exempt from payment of all fees and all taxes levied by this State or any of its subdivisions, except taxes:

1. Levied on real or personal property; or

2. Imposed pursuant to the provisions of chapter ~~[363A or]~~ 363B of NRS.

Sec. 24. NRS 688C.210 is hereby amended to read as follows:

688C.210 After notice, and after a hearing if requested, the Commissioner may suspend, revoke, refuse to issue or refuse to renew a license under this chapter if he finds that:

1. There was material misrepresentation in the application for the license;

2. The licensee or an officer, partner, member or significant managerial employee has been convicted of fraudulent or dishonest practices, is subject to a final administrative action for disqualification, or is otherwise shown to be untrustworthy or incompetent;

3. A provider of viatical settlements has engaged in a pattern of unreasonable payments to viators;

4. The applicant or licensee has been found guilty of, or pleaded guilty or nolo contendere to, a felony or a misdemeanor involving fraud, forgery, embezzlement, obtaining money under false pretenses, larceny, extortion, conspiracy to defraud or any crime involving moral turpitude, whether or not a judgment of conviction has been entered by the court;

5. A provider of viatical settlements has entered into a viatical settlement in a form not approved pursuant to NRS 688C.220;

6. A provider of viatical settlements has failed to honor obligations of a viatical settlement;

7. The licensee no longer meets a requirement for initial licensure;



8. A provider of viatical settlements has assigned, transferred or pledged a viaticated policy to a person other than another provider licensed under this chapter, a purchaser of the viatical settlement, a special organization or a trust for a related provider;

9. The applicant or licensee has provided materially untrue information to an insurer that issued a policy that is the subject of a viatical settlement;

10. The applicant or licensee has failed to pay a tax as required pursuant to the provisions of chapter ~~363A~~ 363B of NRS; or

11. The applicant or licensee has violated a provision of this chapter.

Sec. 25. NRS 694C.450 is hereby amended to read as follows:

694C.450 1. Except as otherwise provided in this section, a captive insurer shall pay to the Division, not later than March 1 of each year, a tax at the rate of:

(a) Two-fifths of 1 percent on the first \$20,000,000 of its net direct premiums;

(b) One-fifth of 1 percent on the next \$20,000,000 of its net direct premiums; and

(c) Seventy-five thousandths of 1 percent on each additional dollar of its net direct premiums.

2. Except as otherwise provided in this section, a captive insurer shall pay to the Division, not later than March 1 of each year, a tax at ~~the~~ the rate of:

(a) Two hundred twenty-five thousandths of 1 percent on the first \$20,000,000 of revenue from assumed reinsurance premiums;

(b) One hundred fifty thousandths of 1 percent on the next \$20,000,000 of revenue from assumed reinsurance premiums; and

(c) Twenty-five thousandths of 1 percent on each additional dollar of revenue from assumed reinsurance premiums.

➤ The tax on reinsurance premiums pursuant to this subsection must not be levied on premiums for risks or portions of risks which are subject to taxation on a direct basis pursuant to subsection 1. A captive insurer is not required to pay any reinsurance premium tax pursuant to this subsection on revenue related to the receipt of assets by the captive insurer in exchange for the assumption of loss reserves and other liabilities of another insurer that is under common ownership and control with the captive insurer, if the transaction is part of a plan to discontinue the operation of the other insurer and the intent of the parties to the transaction is to renew or maintain such business with the captive insurer.

3. If the sum of the taxes to be paid by a captive insurer calculated pursuant to subsections 1 and 2 is less than \$5,000 in any given year, the captive insurer shall pay a tax of \$5,000 for that year. The maximum aggregate tax for any year must not exceed

1 \$175,000. The maximum aggregate tax to be paid by a sponsored
2 captive insurer applies only to each protected cell and does not
3 apply to the sponsored captive insurer as a whole.

4 4. Two or more captive insurers under common ownership and
5 control must be taxed as if they were a single captive insurer.

6 5. Notwithstanding any specific statute to the contrary and
7 except as otherwise provided in this subsection, the tax provided for
