

ASSEMBLY BILL NO. 426—ASSEMBLYMEN GOEDHART, BEERS,
GANSERT, MABEY, MARVEL AND SEGERBLOM

MARCH 19, 2007

Referred to Committee on Natural Resources,
Agriculture, and Mining

SUMMARY—Prohibits the Board of Wildlife Commissioners from establishing a policy or adopting a regulation to preserve, protect, manage or restore wildlife raised for human consumption. (BDR 45-1296)

EXPLANATION – Matter in ***bolded italics*** is new; matter between brackets **[omitted material]** is material to be omitted.

AN ACT relating to wildlife; prohibiting the Board of Wildlife Commissioners from establishing a policy or adopting a regulation to preserve, protect, manage or restore wildlife raised for human consumption; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law requires the Board of Wildlife Commissioners to establish policies
2 and adopt regulations to preserve, protect, manage and restore wildlife and its
3 habitat. Existing law further requires the Commission to adopt regulations
4 establishing seasons for hunting game mammals and game birds and for hunting or
5 trapping fur-bearing mammals. (NRS 501.181) The terms “big game mammal,”
6 “fur-bearing mammal,” “game fish,” “game mammal,” “migratory game birds” and
7 “upland game birds” are defined to mean any such mammal, fish or bird that is so
8 classified by a regulation adopted by the Commission. (NRS 501.005, 501.035,
9 501.045, 501.055, 501.095) The term “wildlife” is defined to mean any wild
10 mammal, wild bird, fish, reptile, amphibian, mollusk or crustacean that is found
11 naturally in a wild state, regardless of whether it is indigenous to this State or
12 whether it is raised in captivity. (NRS 501.097)

13 This bill revises the jurisdiction of the Commission and the Department of
14 Wildlife by excluding from that jurisdiction any species of alternative livestock and
15 any species of big game mammal, fur-bearing mammal, game fish, game mammal,
16 migratory game bird, upland game bird or other species of crustacean, fish or
17 mammal that is raised on private property for the purpose of selling the crustacean,
18 fish or mammal for human consumption.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 501 of NRS is hereby amended by adding
2 thereto a new section to read as follows:

3 *As used in this title, unless the context otherwise requires, the
4 words and terms defined in NRS 501.003 to 501.097, inclusive,
5 have the meanings ascribed to them in those sections.*

6 **Sec. 2.** NRS 501.003 is hereby amended to read as follows:

41 game ~~mammals, game birds or game~~ amphibians raised in
42 captivity is not prohibited if the importation is from a licensed
43 commercial breeder or commercial processor.

45 livestock and products made therefrom.
